

Assessment of Methods and forms of student's accomplishments in Internal Medicine course

Regulations for assessing the current and final control of the discipline (developed in accordance with the Regulation "On the procedure for assessing the knowledge of students during the current and final control of the discipline at NMU named after OO Bogomolets" from 05.09.2019)

When organizing training on the credit-transfer system of training, session-module control is used, which provides for the following types of control:

The system of assessment of students' knowledge includes **current and final** control of knowledge.

The initial control of knowledge involves determining the initial level of knowledge of students in related disciplines, which is necessary to master the discipline studied by the student. The results of the initial control of knowledge are not taken into account in the current learning of the student, because they are only introductory for the teacher.

Current control involves 100% survey of students in the group in a practical lesson with a mandatory assessment of all components of the lesson - test control, oral examination, solving situational problems, description of drugs, etc. Each lesson topic also involves monitoring practical skills.

For each stage of the lesson and the element of current control, the student receives the traditional grade "5-4-3-2", from which the teacher forms the arithmetic mean for the lesson, which is converted into points according to the scale (distribution) provided by the working curriculum. compiled and approved before the study of the discipline. If the student receives "2", this score is converted to 0 points.

The student has the right to improve their knowledge and skills on the topic for which he received a total score of "2" and 0 points, respectively, during the next lesson, during the current control, according to the rules of the department, without receiving points.

Students have the right to get acquainted with the written work verified by the teacher and in case of disagreement to appeal to the assistant to the head of educational work at the department, or to the head of the department.

The following are also subject to evaluation:

Written educational works, the writing of which is provided by the curriculum of the discipline, and educational topics, which are presented as independent work in extracurricular time.

After the lesson, the teacher announces to students their average grade. The amount of points that the student has accumulated as a result of current education is part of the overall grade in the discipline in accordance with the types of final knowledge control.

The maximum number of points for the current training is **80 points**.

The current control consists of all the points that the student has accumulated during all classes. The student processes the missed material on practical classes independently without accrual of points according to the Situation "About the order of an estimation of knowledge of students during current and final control on discipline in NMU of a name of Bogomolets". Accordingly, the minimum score of admission to the final control of the discipline is not set for the current control. Points on current control over the decision of the department are assigned to individual work.

The order of calculation of points in the discipline

During the assessment of mastering each topic of the module the student is graded on a 4-point (traditional) scale and on a multi-point scale using the accepted and approved assessment criteria for the discipline. This takes into account all types of work provided by the methodological development for the study of the topic. The student must receive a grade for each topic. Scores on the traditional scale are converted into points.

Grades on the traditional scale are converted into points depending on the number of topics in the module. The number of points corresponding to the grade "5" is calculated by dividing the maximum number of points for the current educational activity, namely 80 by the number of practical classes. To calculate the grade "3" is calculated the number of points, which is 60% of the maximum number of points for the current educational activity, ie 48-50 points, which is divided by the number of practical classes.

The weight of each topic within one module in points should be the same.

Forms of assessment of current educational activities should be standardized and include control of theoretical and practical training.

Points for individual student tasks

The number of points accrued for different types of individual tasks is 4 points, including: 2 points - writing a medical history (content module 3 or 4); 1 point - writing a medical history (content module 1); 1 point - a report on a practical lesson. They are added to the amount of points that the student received in the classroom during the current academic activity.

The final score for the current activity is defined as the arithmetic sum of the scores for each lesson.

Lecture material is checked during the final control (according to the rules of the department there may be additional points for attending lectures).

The head of the department constantly monitors the current education of students in the discipline, especially paying attention to students at risk (a significant number of "abs", unsatisfactory grades). At the methodical meetings of the department the results of the current education of students are discussed. Students at risk, if desired, are offered in time, in advance, before the final control or after the last, the opportunity to provide in-depth study, in accordance with the procedure for providing educational services at the University.

Final control

The final control involves determining the level of knowledge and skills. It is held upon completion of the study of the discipline. It includes control of theoretical and practical training. The final control is carried out in the form of final control.

Students are admitted to the final control of the discipline provided that they attend at least 75% of the classroom classes (lectures, practical classes) with the entire accumulated amount of points during the study of the discipline.

If a student has attended less than 75% (missed more than 25% of classes) of classroom classes, he is considered to have failed the curriculum and syllabus in the discipline, and therefore must re-study the discipline.

- Classes that were missed by the student for any reason, including illness, are mastered by him independently in extracurricular time according to the rules of the department (by writing a syllabus, medical history, distance learning, counseling,

demonstration of practical skills , etc.). The student shows the synopsis of the missed topic to the group teacher during the next lesson or after the beginning of class attendance, and the group teacher marks the letter "C" in the journal of attendance and student progress in the conspect of the missed topic, without grading. The presence of a syllabus of a missed lesson is a confirmation of the student's fulfillment of the curriculum as well as reworking information on LIKAR platform.

- The teacher returns the syllabus of the missed lesson to the student. The teacher of the department keeps a Register of credited abstracts for missed classes by form , which is an appendix to the academic journal and shows the dynamics of students' mastery of missed study topics. Such Register is subject to weekly control by the head of the department.
- The department does not set a separate schedule indicating the hours for taking notes of missed classes. Missed lectures are not completed by students, at the same time, missed lectures are included in the total number of missed classrooms in the discipline, if there are no data on LIKAR platform also.

Discipline assessment

The final control is carried out in the form of final control of the discipline. The volume of educational questions submitted for final control should contain the most important questions from the discipline, and should not cover all the educational material, the study of which is provided by the curriculum in the discipline.

The evaluation of the results of the final control is carried out according to the 200-point system of knowledge control adopted by the university and the national scale and are reflected in the relevant information.

Assessment of knowledge of the discipline is carried out on the appropriate scale:

The regulations for the final control with a list of issues are discussed and approved at the methodological meeting of the department, CMC on therapeutic disciplines, approved by the Vice-Rector for Research, Teaching and Educational Work and published before the start of the study (website, stand, first lecture or practical lesson).

Final control (FC) is a form of final control of identification of skills and knowledge formed in a student in a particular discipline for the entire period of study of the discipline, which is carried out after the study of the discipline in the last lesson. When grading the discipline, the number of points accumulated by the student for the current study (maximum number of points 80) and the result of the FC in points (maximum number of points **120**) are taken into account. The student makes a FC with the number of points he has accumulated during the current study. The form of the FC and the type of tasks are determined by the curriculum (working) program of the discipline and the regulations of the department. Credit for the studied discipline is subject to the accumulation of the total number of points received by the student, which must be not less than the minimum, which is determined by the working curriculum of the discipline and corresponds to the minimum value of E, and therefore is 111 points.

- Admission to the compilation of FC subject to 75% attendance of educational classes, including lectures. Tolerance in point expression is not established.
- The student's ability to take a FC in a discipline is not affected by the results of other courses.

The order of liquidation of academic debt

Upon receipt of an unsatisfactory grade in the discipline within 60-110 points (FX), the student has the right to re-make it 2 times: one - to the departmental commission with the participation of the head. department, and last time - the commission with the participation of the head of the department and the dean.

Re-compilation of disciplines with unsatisfactory grades is carried out according to the schedule drawn up by the department, agreed with the dean (the interval between attempts or disciplines is not less than 3 days). Disciplines studied in the relevant course must be completed before the beginning of the new academic year. The presence of academic debt before the beginning of the new academic year is the basis for expulsion of a student from the university for non-compliance with the requirements of the curriculum (or registration of academic leave and repeat the course of study for health reasons).

Upon receipt of an unsatisfactory grade in the discipline within 1-59 points (F), the student is obliged to re-study it in extracurricular time on a paid basis. Repeated receipt by a student of unsatisfactory grade as a result of its re-study, taking into account two changes in the discipline or unsatisfactory grades in 3 disciplines, as well as the presence of missed classroom classes without good reason, the amount of absences **of 120 hours** or more, causes his expulsion from the university non-fulfillment of the curriculum.
