COURSE DESCRIPTION

A study of the theories and principles of behavior management, cognitive theories and techniques. Emphasis will be on their applications including managing self-behavior. In-depth study will be in operant conditioning techniques.

• Credit Hours: 3

• Classroom Contact Hours per week: 3

Laboratory Contact Hours per week: 0

COURSE RATIONAL

This course will focus on the basic principles and procedures of behavior modification. It is designed to introduce the student to some of the theoretical aspects of the subject, but primarily to focus on "how-to" skills such as analyzing behavior, interpreting it in behavioral terms, writing behaviorally, and developing behavioral programs.

COURSE STRUCTURE

This course is taught online, via the Internet. Students must have basic computer skills and Internet access/skills. This is a synchronous class so there will be regular class meetings online using web conferencing software.

COURSE ACCESS

The course is accessed through the ACC distance learning web site at https://acconline.austincc.edu/. To access the course, you will need a user name and password. Lessons must be completed by the deadlines (see Course Outline for deadlines) to earn full points. **NOTE:** Assignments should be submitted through the Assignment button in Blackboard.

Completion of Quizzes

Each lesson has a quiz that is part of the lesson. There are 15 quizzes each worth 20 points. Total possible points for quizzes is 300 points. Quizzes must be completed by the deadline posted on the Course Outline. Late quizzes will be worth half the scored value (maximum of 10 points). It is essential that you accept responsibility for knowing which quizzes you completed late. The Blackboard system automatically grades quizzes and allows for full credit. If you submit a quiz past the deadline, it is your responsibility to know that the score is half the posted value. If you are ever concerned about your grades, it is incumbent upon you to contact me early in the semester. All quizzes should be completed by Friday at Midnight.

Discussion Boards

Students are required to participate in each lesson's discussion board during the semester. The topics for discussion boards vary depending on the lesson. Students are required to post their comments on the discussion topic, as well as to respond to comments posted by at least 2 other students. Discussion boards are designed like an online bulletin board or "chat room", although they are only accessible to students in this class and can be accessed at any time. Each Discussion Board counts for up to 10 points. While you are welcome to continue posting comments past the deadline (you may have an interesting discussion going), only postings made by the deadline will be read by the instructor and counted for points. Guidelines for posts include:

- You are expected to actively participate in the discussion with postings submitted in a timely fashion while that discussion is in progress. Posting solely on the deadline and not during the lesson period will result in lost points.
- You are expected to post a minimum of 3 times in each lesson. One posting should be a substantive response to the discussion question (minimum of 50 words) and include at least one academic citation to the readings or related articles using APA style of referencing (if you do not know how to do this, please visit the Library website or see a tutor in the Learning Lab), and two postings should be a substantive response to other classmates (minimum of 25 words). You then have until the lesson deadline (Friday, 12 pm, midnight) to respond to two other students' posts. Failing to use an academic citation will result in 1-3 lost points. Think of your initial post as a short essay use proper grammar and be sure to cite your readings to support your answers.
- Your comments are expected to be substantive in nature and your initial post should make at least one academic citation of the assigned readings or professional literature as appropriate. Not including an academic citation results in between 1-3 lost points (depending on the quality of your post). When responding to other classmates' comments, it may not be as relevant to support your comments with references from your readings, especially if you are offering a personal opinion. What is important is that comments are more than "me too" or "I agree" or "Sounds like a good idea" you must say something about what the person wrote and include your thoughts as it relates to the topic.
- Posts must be written with proper grammar, spelling and citations. Points are lost for poorly written posts. Do not use any color other than black font or background colors

- when writing your posts and be sure your posts are in a normal text size. Do not write your posts as attachments and expect others to open the attachments to read them.
- If you expect to be away from a computer for a week or more, you should contact me.

Discussion Board Etiquette

- Never post, transmit, promote, or distribute information that is known to be illegal.
- Never post harassing, threatening, or embarrassing comments. If you disagree with someone, respond to the subject, not the person.
- Never post content that is harmful, abusive; racially ethnically, or religiously offensive, vulgar; sexually explicit; or otherwise potentially offensive.
- Do not use curse words in your posts and do not use all capital letters or color fonts other than black/white.
- Spell and grammar check your postings.
- Never share anything that you are concerned about becoming public knowledge. The College does not guarantee the confidentiality of information shared by participants in the course.
- The instructor reserves the right to remove any postings that are deemed inappropriate.
- Postings that are removed are not given any grade points.

Assignments

Assignment #1: Find one scholarly journal article (I recommend using the ACC library system) that discusses the use of self-management systems with the population with whom you are preparing or would like to work. Write a brief synopsis (1 page) of the article and submit it through the Assignment button. Worth 50 points. **Paper due February 18, 12:00pm.**

Assignment #2: Using the contract in Figure 9.4 in your textbook as a sample, write a contract for either yourself or a family member/friend that will last for a 2, or 3-day period. If you are doing a self-contract, have a family member/friend witness it for you. Turn this in through the assignment button. Worth 50 points. **Paper due March 25, 12:00pm.**

Assignment #3: Self-Modification Program (final project) - Design a program to bring about change in one of your behaviors. Implement your program and take data for at least one week if possible. Submit a paper of your findings. (Two to three typed double-spaced pages, font size 10 or 12.). Worth 50 points. **Paper due by May 15, 12:00pm.** *However, for this project to be carried out successfully, you should start it no later than April 29.*

Any additional information will be discussed in class.

COURSE POLICIES

Withdrawal Policy

The College defines withdrawals as occurring after the official reporting date of the semester, typically the 12th class day. In addition, the Legislature has mandated the Rule of Six (see below). There may also be financial aid issues.

It is the responsibility of each student to ensure that his or her name is removed from the roll should they decide to withdraw from the class. The instructor does, however, reserve the right to drop a student should he or she feel it is necessary. If a student decides to withdraw, he or she should also verify that the withdrawal is recorded <u>before</u> the Final Withdrawal Date. **The Final Withdrawal Date for this semester is [insert date here]**. The student is also strongly encouraged to keep any paperwork in case a problem arises.

Students are responsible for understanding the impact that withdrawal from a course may have on their financial aid, veterans' benefits, and international student status. Per state law, students enrolling for the first time in Fall 2007 or later at any public Texas college or university may not withdraw (receive a "W") from more than six courses during their undergraduate college education. Some exemptions for good cause could allow a student to withdraw from a course without having it count toward this limit. Students are strongly encouraged to meet with an advisor when making decisions about course selection, course loads, and course withdrawals.

NOTE: It should be understood it is the student's responsibility and not the instructors to drop a course. A student that discontinues coming to class and fails to drop a course is subject to receiving a final, permanent grade of "F".

MISSED EXAM AND LATE WORK POLICIES

Quizzes, Discussion Boards, and Research/Writing assignment(s) submitted late will be worth half their value shown on Blackboard.

Incompletes

An incomplete (grade of "I") will only be given for extenuating circumstances. What constitutes "extenuating circumstances" is left to the instructor's discretion. If a grade of "I" is given, the remaining course work must be completed by a date set by the student and professor. This date may not be later than two weeks prior to the end of the following semester. A grade of "I" also requires completion and submission of the Incomplete Grade form, to be signed by the faculty member (and student if possible) and submitted to the department chair.

Students may request an Incomplete from their faculty member if they believe circumstances warrant. The faculty member will determine whether the Incomplete is appropriate to award or not. The following processes must be followed when awarding a student an "I" grade.

- 1. Prior to the end of the semester in which the "I" is to be awarded, the student must meet with the instructor to determine the assignments and exams that must be completed prior to the deadline date. This meeting can occur virtually or in person. The instructor should complete the Report of Incomplete Grade form.
- 2. The faculty member will complete the form, including all requirements to complete the course and the due date, sign (by typing in name) and then email it to the student. The student will then

complete his/her section, sign (by typing in name), and return the completed form to the faculty member to complete the agreement. A copy of the fully completed form can then be emailed by the faculty member to the student and the department chair for each grade of Incomplete that the faculty member submits at the end of the semester.

- 3. The student must complete all remaining work by the date specified on the form above. This date is determined by the instructor in collaboration with the student, but it may not be later than the final withdrawal deadline in the subsequent long semester.
- 4. Students will retain access to the course Blackboard page through the subsequent semester in order to submit work and complete the course. Students will be able to log on to Blackboard and have access to the course section materials, assignments, and grades from the course and semester in which the Incomplete was awarded.
- 5. When the student completes the required work by the Incomplete deadline, the instructor will submit an electronic Grade Change Form to change the student's performance grade from an "I" to the earned grade of A, B, C, D, or F.

If an Incomplete is not resolved by the deadline, the grade automatically converts to an "F." Approval to carry an Incomplete for longer than the following semester or session deadline is not frequently granted.

ACC Library Services offers both in-person and extensive online services, with research and assignment assistance available in-person during limited hours of service. Although all college services are subject to change, plans include ACC students signing up for study space and use of computers at open libraries, extensive online instruction in classes, online reference assistance 24/7 and reference with ACC faculty librarians. In addition, currently enrolled students, faculty and staff can access Library Services online (also 24/7) via the ACC Library website and by using their ACCeID to access all online materials (ebooks, articles from library databases, and streaming videos). ACC Libraries offer these services in numerous ways such as: "Get Help from a Faculty Librarian: the 24/7 Ask a Librarian chat service," an online form for in-depth research Q and A sessions, one-on-one video appointments, email, and phone (voicemail is monitored regularly).
