

PHOTOGRAPHY AND VIDEO RELEASE AGREEMENT

1. Grant of Rights

The Model hereby grants to the Photographer, and any licensees, assigns, or agents of the Photographer, the irrevocable, non-exclusive, and worldwide right to use, reproduce, display, publish, and distribute photographs, video footage, and other media (collectively, "Media") taken during the photoshoot or video session held on _____ (date of session).

2. Usage of Media

The Model agrees that the Media may be used for any lawful purpose, including but not limited to: advertising, marketing, promotional material, websites, social media, publications, or any other use by the Photographer, their clients, or agents. This use may be in any format, medium, or platform now known or later developed, including but not limited to print, digital, or electronic media.

3. Copyright Ownership

The Photographer shall retain the copyright of all Media created during the photoshoot or video session. The Photographer grants the Model permission to use the Media for personal or commercial purposes as agreed in separate agreements, subject to the terms of this Release.

4. Model's Likeness and Name

The Model grants the Photographer the right to use the Model's name, likeness, voice, and biographical information in connection with the Media, including but not limited to advertising, promotional, and commercial use.

5. Compensation

The Model acknowledges that the compensation for the photoshoot or video session (if any) has been agreed upon separately. The Model acknowledges that the Photographer is not obligated to provide any additional compensation or royalties for future use of the Media.

6. Waiver of Claims

The Model waives any and all claims against the Photographer arising from the use of the Media, including but not limited to claims for defamation, invasion of privacy, or infringement of any intellectual property rights.

7. No Further Approval Needed

The Model acknowledges that the Photographer is under no obligation to submit the Media to the Model for review or approval before use. The Model waives any right to inspect or approve the final version of the Media used by the Photographer.

8. Release of Liability

The Model agrees to release and hold harmless the Photographer and any associated parties from any and all claims, liabilities, or damages that may arise from the use of the

Media, including but not limited to claims of copyright infringement, defamation, or invasion of privacy.

9. Entire Agreement

This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements or understandings related to the Media. Any amendments to this Agreement must be made in writing and signed by both parties.

10. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the jurisdiction in which the photoshoot or video session took place.
