**51st OAKLAND FUKUOKA
HIGH SCHOOL STUDENT EXCHANGE PROGRAM**

Tentative Dates: Approx. Early to Mid July 2025

The annual Oakland Fukuoka High School Student Exchange Program is a **10-12 day Program in Fukuoka, Japan**, Oakland's Sister City. We are accepting applications for this Program and space will be **limited to 6 students**. The estimated **Program Cost is \$3,000.00** that includes airfare, room & board (home-stays), organized activities while in Fukuoka. Students will be responsible for any personal expenses not included in the estimate (purchases, gifts, snacks, etc.). Students attending high school during the 2024-2025 academic years are eligible.

The students will be under adult supervision. A representative or representatives from the Oakland Fukuoka Sister City Association will chaperon the students during the trip. The City of Fukuoka, through the Fukuoka International Association in partnership with the Fukuoka – Oakland Friendship Association, will organize the homestay for each student with a host family and daily activities for the group during their stay in Fukuoka, Japan. The homestay and cultural exchange are the highlights of the program. The parent/guardian and student will be required to sign a Release Form. The student or their family will be required to join the Oakland Fukuoka Sister City Association. We strongly encourage each family to homestay a student from Japan the preceding and/or following summer as this is an exchange program. If your family is unable to host a student from Japan in the year after the program participation, please sign up to recruit a family in your stead. This will ensure student exchange programs between our cities will thrive and be available for students in the future.
