## Issue

The Internal Regulations of Student Groups must be updated to reflect the current responsibilities of Services and ISGs (now named ASGs).

## Background and Rationale

The document includes the following changes:

- Services must present a report at least once per academic year to Legislative Council
  - To encourage accountability and transparency, and to foster a relationship between Services and the Legislative Council.
- Services must present an exit report to the Services Sub-Committee at the end of each academic year.
  - To encourage accountability, transparency, and to create institutional memory on the function and operation of Services year after year.
- The name 'Independent Student Groups' has now been changed to 'Associated Student Groups'.
  - To better reflect the relationship between such groups and SSMU.
- All Associated Student Groups must sign a Memorandum of Agreement with the Society in order to qualify for status.
