Endorsements for Students Receiving Special Education Services

A student receiving special education services may earn an endorsement if the student meets ALL the following criteria:

- The student completes the credit requirements for graduation under the Foundation High School Program with or without modified curriculum.
- The student completes the additional credit requirements in math, science, and elective courses required for the endorsement, with or without modified curriculum.
- The student completes all courses required for endorsement with or without modified curriculum.
- An Admission, Review, and Dismissal committee (ARDc) determines and documents in the Individualized Education Program (IEP) that the curriculum, as modified in the four courses required for the endorsement, is sufficiently rigorous.
- The student takes each of the required End-of-Course (EOC) assessments and performs satisfactorily on the EOCs OR the student's ARDc determines that satisfactory performance is not required.
