Why do writers write it?

 Very popular so creators can be successful producing it. Podcasts are easy to publish as they can upload the podcast straight to the internet, while books need to be published.

Why do readers consume?

- Commuter society so audiences want to engage + learn + be entertained
- The podcast format is more naturalistic and thus relatable (vocal inflections, etc.)

Resources and constraints of this genre and medium

- Constraint: has to be entertaining and easily digestible for listeners can't be as meaty with information
- Complexity limited, many readers won't have the patience to rewind the podcast if they want to hear something again
- Resource: more intimate, can convey emotion naturally through inflections in voice
- Can add music to evoke emotion
