2022 NCFA Forensics Camp

CSU Sacramento

We are pleased to extend an invitation to the 2022 NCFA Forensics Camp hosted by CSU Sacramento. The camp will take place on Saturday, September 10th, 2022 and focus on IPDA, NPDA and NFA-LD style debate as well as the full range of AFA / NFA individual events. This year we are continuing with a format that we hope will make the camp beneficial to both our rookie and more seasoned competitors alike. The debate side of the event will consist of lectures and labs in the morning with a 2 round mock tournament in the afternoon.The individual event side of the event will include a full day of lectures and workshops.

Like previous years it is our plan to offer advanced lectures in the morning for your more experienced debaters. It is our hope this will increase participation by seasoned debaters who will then participate on judging panels in the afternoon. The advanced sessions will be general to all forms of debate and will focus on topics requested by the debaters. The Individual Events side of the camp will hold sessions for returning students hoping to get feedback on current events.

All formats of debate will be governed by their respective national rules of debating. Ballots will also be available electronically immediately after the event. Disclosure and discussion is encouraged, but please stay aware of the schedule when giving novice debaters feedback and don't forget to return your ballots!

Judging

One judge covers two entries in any form of debate per day. A judge can be split between two different formats on the same day (Parli/LD/IPDA) but may only be assigned to one pool by the director. If judging commitment is a problem, please let us know beforehand.

Any coach, faculty member, or open level competitor with at least one year of experience may judge at the camp. Please bring enough judges to cover your entry. Entries may be restricted based on available judging; we are not planning on hiring judges. Remember our hope is that you will bring your open debaters to both learn and judge.

Fees

Our fee structure is designed to be very affordable and accessible. Please contact Ryan Guy if these fees constitute a financial hardship for your squad.

School fee: \$15.00 per school

We are not permitting uncovered entries, so there is no uncovered fee.

Guidelines for Maintaining a Professional and Respectful Educational Environment:

All tournament attendees are to be protected from an intimidating, hostile, or threatening work or educational environment. All attendees will be held to the standards established by <u>California Education Code 212.5</u> and/or <u>Title IX of the Education Amendments of 1972</u>. Failure to follow these guidelines may result in being removed from the tournament and/or being disqualified from the round in question. All incidences of such violations should be reported to the tournament host. Judges will be instructed that they may dismiss or award a loss to a student who violates California Education Code 212.5 and/or Title IX of the Education Amendments of 1972.

Entry

Entry for the Debate Camp will be done online at forensicstournament.net with a closing date of Thursday, September 8th at 8pm. Changes ARE permitted in person the morning of the event at registration; at that time rosters will be finalized for the practice debates later in the day. This should give us the opportunity to make hybrid teams if an odd number of debaters make the event from given squads. <u>https://forensicstournament.net/NCFACAMP/22</u>

Please do not send your debaters to the event without registering them in the tournament. Adding entire schools day-of adds unnecessary stress to the event. Also, please send a coach or other representative from your school to oversee and supervise the learning of your students even if you are not judging or lecturing.

When you arrive on campus, pay with cash (no coin) or credit at any permit machine located in all student parking lots/structures or the UTAPS office at the Welcome Center building
