Born as [REDACTED], "Pluto" initially joined the Foundation's ranks in the capacity of a security escort, quickly distinguishing himself through his exceptional combat abilities, tactical acumen, and unwavering loyalty to the mission. His progression through the ranks has been marked by numerous commendations, ultimately leading to his recruitment into the elite Omega-1 task force. Pluto is



known for his calm demeanour under pressure, strategic thinking, and the ability to make quick decisions in the field, often under extreme duress.

His father, [REDACTED] was also a military man with "Pluto" following in his steps, joining the USMC (United States Marine Corps) at age 21, quickly climbing the ranks before being noticed by the foundation recruitment agency as a possible candidate for security forces.

After being taken, and accepting the offer for the prestigious position, "Pluto" demonstrated his combative ability to his superiors and was recommended for a position in Omega-1, which he was given by Omega-1 Commander [REDACTED].



# Incident Report:

Description: On April 15, 2023, at approximately 23:47, a containment breach occurred in Sector D, Sub-Level 3 of Site-17 involving SCP-[REDACTED]. The breach was triggered by an unexpected power failure, causing the automated containment systems to shut down. SCP-[REDACTED] escaped containment and began moving toward the research laboratories. MTF Omega-1, under the command of Captain [REDACTED], was immediately deployed to contain the breach due to an Ethics Committee Member being located on the site. Operative "Pluto" was part of the response team tasked with securing Sector D and re-establishing containment protocols.

Upon arrival at Sector D, the team encountered SCP-[REDACTED], which had already incapacitated two security personnel. Operative Pluto took point and engaged SCP-[REDACTED] using non-lethal containment measures as per protocol. The entity unexpectedly showed resistance to standard containment tools, requiring the deployment of more aggressive tactics. Operative Pluto initiated a direct confrontation, utilising specialised containment gear designed for SCP-[REDACTED]. While engaging, SCP-[REDACTED] exhibited increased hostility and lethality, resulting in significant damage to the surrounding infrastructure. Despite sustaining injuries, Operative Pluto successfully incapacitated SCP-[REDACTED] using a prototype device (Device ID: [REDACTED]) recently developed by Site-17's R&D department.



#### Outcome:

SCP-[REDACTED] was successfully re-contained and transferred to a more secure holding facility pending further review of containment protocols. Damage to Site-17's infrastructure was extensive, however easily repairable. A full assessment of the damages has not been provided by the ETS department. Operative Pluto's actions were instrumental in preventing a full-scale breach. His bravery and quick thinking under pressure are commendable.

#### Post Incident Actions:

De-briefing occured after the incident. All personnel involved were debriefed by the Ethics Committee Member and Site-17's Security Director.

A taskforce has been assigned to review, update and continue working on containment procedures for SCP-[REDACTED] to prevent and mitigate any future breaches.
