Discussion Items (3:35-4:30)

- Lily Ann Villaraza explained why PHST, her department, is adopting seven PIL courses from WORL. This required CC approval before Banner changes are made on the school and department levels. **APPROVED**
- Clarifying Permanent <u>Membership</u>
 - o The website needs to be updated. Currently it reads Seven permanent positions: Articulation Officer, Distance Education Coordinator, Requisites Coordinator, SLO Coordinator/Liaison, CTE Curriculum Liaison, CurrIQunet Liaison, Curriculum Specialist
 - o **Change** Distance Ed Coordinator to Distance Ed Chair; change SLO Coordinator to SLO Liaison; replace CurrlQunet Administrator with Chief Instructional Officer or designee
- Under the hood: ESLA 3180 (code fix), HLTH 38 min qual, Construction Mgmnt AS, ARCH 134 impact
 - o The issues, often related to historicals, were explained in these examples to show the need for an improved updating process since CurrlQunet requires manual assistance for such things
- CC Squads: Handbook, Historicals (ENGL 30A impact report example), Supplemental Docs Manual
 - o Squads were explained, and open registration has begun!
- Sharing "homework" (drafting a pretend course or program)?
 - o Alissa spoke again about how much she loves the increase and decrease buttons in the content editor.
- Considering backward design and anti-racist teaching in the context of curriculum outlines
 - Discussion on the elements of backward design that are in our outline design, especially with the SLO and evaluation placement and relationship. CC members have been encouraged to watch the Vanderbilt U "Understanding by Design" workshop lecture to think about how the design of our outlines might be further improved. The Brown U piece on anti-racist teaching focused on sample outcomes designed to to enhance anti-racism, social contexts, and inclusion. The two pieces should be considered together, as they both bring attention to outcomes and improved teaching and learning.
