

# CCJ230 Suggested Module Template

Module Header: Week 1 Topic (Case 1: Crime, Criminal Justice, Criminology)

- Week 1 Overview (“Start Here”)
  - On this page, instructors can provide a short text introduction to the themes or concepts of the week. They can introduce an introductory question or image, or provide more context for the week’s goals.
  - Instructors can also share learning objectives for this week or unit: What will students be able to do or to know after they complete the module?
  - Ideally the Overview Page will also provide reminders of the weekly work and links to the following sections of the module.
- Week 1 Lecture
  - On this page, the instructor provides their own lecture on the weekly materials. This page might also include a list of textbook readings and any other materials to read or view.
- Week 1 Discussion/Assignment
  - After the Overview and Course Content pages, it’s a great idea to add any assignments or discussions required for the week. By adding assignments or discussions at the end of the module, they stand out as required tasks.
  - If an assignment is due in a few weeks, it’s a great idea to add it early so that students can review the purpose, tasks, and criteria for success before the assignment is due. In this course, the three major assignments are listed between the syllabus module and the first weekly module.
- Week 1 Summary
  - Although not a part of the sample template below, a summary page is an important tool for helping students bridge or transition between weeks or units. In this space, you help students prepare for the week ahead by summarizing what this week covered, offering a final reflection question, or synthesizing key points you don’t want them to miss.
  - Usually this page is pretty short and offers a statement of encouragement and support as students move on to the next module or unit.
