

EATON TOWNSHIP ZONING FEES

RESIDENTIAL NEW HOMES: \$.30/sq ft of living space excluding attached garage + \$300 Township Road & Bridge Fee (non-development)

+ \$600 Township Road & Bridge Fee (development)**

+ \$400 Substation fee (Development)**

+ \$300 Parks fee (Development)**

** these fees apply to housing developments for Construction that has started after April 2018

RESIDENTIAL ADDITIONS & ACCESSORY STRUCTURES: \$.20/sq ft \$25.00 minimum.

This includes unattached garage, pole barns, utility sheds, gazebos, decks, etc.

RAISING PITCH OF ROOF: \$25.00

NON RESIDENTIAL NEW CONSTRUCTION /ADDITIONS & ADDITIONAL STRUCTURES:

New commercial & recreational: \$.40 /sq ft \$300.00 minimum

Commercial additions/additional structures: \$.30/sq ft \$150.00 minimum

New Industrial: \$.45/sq ft \$500.00 minimum

Industrial additions & additional structures: \$.35/sq ft \$200.00 minimum

FENCING: Non Residential: \$150.00. Residential: \$30.00

SWIMMING POOLS: \$40.00

PONDS: with the approval from Lorain County Water Conservation District \$75.00.

SIGNS: \$2.25 per square foot/\$ 30.00 minimum fee, includes all sides. Replacement of original signs \$2.25 plus \$2.25 for each additional square foot that exceeds the original sign square footage.

SOLICITOR PERMIT FEE: \$25.00 Annual Fee.

ZONING VERIFICATION LETTER: \$25.00 per address/parcel (includes municipal assessment, zoning district & address file review)

Residential: \$75.00 All other districts: \$225.00

Final Site Plan Review Application: \$1500.00 (includes all preliminary informational meetings, 1-ZC work session if applicable, 1-ZC Public hearing, 1-Trustee Public Hearing). Each revision, post-approval amendment, applicant requested extra public hearings: \$1000.00 each. **Preliminary / Concept Site Plan Review Application**: \$250.00 (recommended for ALL housing developments & large non-residential)

Site Plan Review Applications expire 365 calendar days from filing date (if not approved).

COSD Application (min of 35 acres is required per zoning ordinance): \$1500.00 in conjunction with the Site Plan Review application

Non-COSD Housing Development Plan Review Application: \$1500.00 in conjunction with the Site Plan Review application

Big Box/Chain Store Plan Review Application: \$2000 (1-3 acre), \$3000 (3-10 acres), \$4000 (10-20 acres) \$5000 plus \$200 per acre for each acre or portion there of>20 acres.

Zoning permits shall expire and may be revoked if work has not begun within (6) months from the date of filing application.

FAILURE TO SECURE A ZONING PERMIT WILL RESULT IN DOUBLE THE COST OF THE PERMIT FEE.
