

Iowa State Trapshooting Association
Board of Directors Zoom Meeting Minutes
February 18, 2024

Present: President John Dvorak; Secretary/Treasurer Lindsey Kaufmann; Directors and Alternates: Dick Wonick, Jack Gangwish, Ray Dentlinger, Rod Goodrich, and Ryan Meier; and ATA Delegate(s): Steve Glasgow.

The meeting was called to order via Zoom at 5:11 pm.

The minutes from January 17, 2024 were read. Jack Gangwish moved to approve the minutes with two corrections, and Ray Dentlinger seconded it. Motion passed. The minutes from January 24, 2024 were read. Ray Dentlinger moved to approve the minutes with two corrections, and Dick Wonick seconded it. Motion passed.

The financial report was given with a detailed profit and loss statement for the year so far and balances of each account as follows. The operating account with \$29,295.48, savings account with \$45,059.71, and the money market account with \$138,717.67 for a grand total of \$213,072.86.

Old Business

Shower House/Bob Allen Building Update – Jack talked to Jason Paulsen, the flooring individual, and provided an estimate of \$10,000 to do the floors. It was suggested that the walls are painted before. John was going to call Bill Stueve about what temperature the block walls need to be before they can be painted. Ray was going to look into putting closers and or door handles on the shower house doors. Ryan was going to get square footage of both buildings for Jason to order product for. The steel and windows estimate is \$5,000 to \$5,200, and the lighting would be about \$100. The NW door on the Bob Allen building would also need to be replaced. Ray Dentlinger moved to proceed with the epoxy floors in the shower house and Bob Allen building (including Wendy's office) with Steve Glasgow taking care of the steel, Ryan Meier doing the lighting, and NW door being replaced in the Bob Allen building at \$17,000 to \$17,500. Ryan Meier seconded it, and the motion passed.

Bathroom Stocking – Jack provided an update that the contact he has been working with is Dave. He said it would be \$140 per day for SCTP and State Shoot for a total of \$1,820. Jack will work on getting a contract from him with pre and post clean. We will be responsible to keep product on hand and have a reserved parking spot for them. Ray Dentlinger moved to pay \$2,000 with a pre and post clean, and Ryan Meier seconded it. Motion passed.

Zone Shoots – Shamrock Leathers has discontinued the bag use typically use. Ryan had to finish the order and decided to go to the next level up to keep it most like the previous bag we use.

Water Leak – John called Raymond Spangenburg but is waiting for a response.

Work Bench/Parts Storage – These will be set up in March when the group is on site.

2023 Ads – Iowa Western has paid, and Kolar's check is in the mail.

SCTP Parking – John has set up a meeting with the Black Hawk County Sherrif and Engineers. It will be on Friday and John has asked Kevin DeSerano to join too.

HOF Application – An application for Denny Dozark was presented and has been approved by Denny Bigelow and Linda Sawvell. Jack Gangwish moved to approve the application for Denny Dozark on the contributory side of the HOF, and Ray Dentlinger seconded it. Motion passed 5-2 with votes as follows: Denny Bigelow – Yes, Linda Sawvell – Yes, Ray Dentlinger – Yes, Jack Gangwish – Yes, Dick Wonick – Yes, Ryan Meier – No, John Dvorack – No.

State Shoot Trophies – Char Bartholow will do this. She is going to charge \$2,500 to \$3,000 for the work and was given a budget of \$25,000.

New Business

Concrete – John is going to contact the concrete contractor to see how soon it will be to get our walkways done. The old stuff could be removed now and prepared for the new. Ray Dentlinger moved to purchase a walk behind edger the same product we borrowed from CFGC for about \$2,000 plus or minus 15%, and Ryan Meier seconded it. Motion passed.

SCTP Loading Traps – John has not heard anything from Jim Wilmont.

Parking Crews – It is too early to tell if we have enough help or not.

Trap Parts – Ryan ordered what we need.

Next Meeting Date – The next scheduled meeting is March 16th, 2024 in Cedar Falls.

Jack Gangwish moved to adjourn the meeting, Ryan Meier seconded. Motion passed. Meeting was adjourned at 6:28pm.
