Everyone needs a middleman, and that's what we did. When Feds are knocking on houses daily, and people are wearing wires, why send your guys to do anything that can put them at risk, whether transporting drugs to a fellow organization or getting a hit out. No one wants to get pinched by the feds or another criminal organization; there will be retaliation.

No one could pinch us because we were meant to get pinched. Our guys come out of jail daily, are killed daily, and get beat up daily. We take a beating no one else will. And because of this, we were violent back. No one wanted to deal with us, but it was frequently the only option. The main services that we provided were; Hits (even inside the jail), Kidnappings, Harassment of rival businesses/personnel, Blackmail/threats, Identity theft/forge documents, Smuggling, Money mule, Personal protection, Property protection, Slavery, Private investigation/intelligence, Stalking, Sending discrete/illegal messages, Fencing, Arson/vandalism, Property break-ins, Loan sharking, Body removal/crime scene clean up, and even Terrorism. And it was all untraceable back to the original contractor. That was unless one of our own decided to snitch, but we took care of our own if that was the case. We were business, and we did not want our honor stained.

Even when people did not hire us, we decided to take advantage of the business no one else would do because it put them in danger with other organizations or they were too lazy to do said business. We were often involved in organ trafficking/harvesting, Human Trafficking, Forced homelessness, bookkeeping, Numbers game, Robberies, Embezzlement, and Fraud.

Human Trafficking was our main staple for money. Not drugs, not guns, but the selling and buying of people. We would first consider if we can use humans ourselves, which could be for Organ harvesting, illegal fights for gambling, or forced homelessness. Often under threat of death if they did not comply. If we cannot find a use, we will ship them to a contractor who would want them either in New York or outside the country.

You may ask, where did we come from? Our group came in the 80s, with small influxes of immigrants until the 90s. When communism ended, it caused a more significant influx of immigrants. I joined in the 90s, so I cannot say where we came from other than one of the many Albanian Clans.
