Information We Collect

Information Sharing

Your information will only be shared with our business partners in the event that it helps us provide you with essential business functions. We do not sell, trade, or otherwise transfer your personal information to third parties. Mobile information will not be shared with third parties/affiliates for marketing/promotional purposes. All the above categories exclude text messaging originator opt-in data and consent; this information will not be shared with any third parties.

Your information will only be shared under the following circumstances:

- **Service Providers:**
We may share your information with third-party vendors who support our operations (e.g., email/SMS service providers). These parties are bound to confidentiality and security obligations.
- **Legal Compliance:**
We may disclose your information if required by law or to protect the rights, safety, and property of our company, our users, or others.

Important: We do not sell, trade, or rent your personal data. All categories above exclude SMS/text messaging originator opt-in data and consent, which will not be shared with any third parties.

- **Access & Update:**
You can request to access or update your personal data anytime by contacting us.
