- 4) What will happen in the event that Meiaquar wins, and vice versa. This includes any specific fates of captured/defeated characters, if beyond the norm.

Please understand the following;

- 1) While NPCs are a consideration, their impact in the conflict will be minimal; they are likely going to be a defensive factor, not offensive, etc.
- 2) Fairview was an abandoned village that seceded from Meiaquar. It can't really expect anything much in regards to NPC support.
- 3) Actual 'strategic' details can be withheld for suspense and such. Consult with a GM privately if you want to know what is fine and what isn't.
- 4) Be respectful of each other and consider some compromises to lessen OOC gripes. We're all just here to have fun.

For starters, we're adding a small number of people to this chat, but if requested, more of those who will be involved can be given access to the channel at a GM's discretion.

- 4- If we win, we're definitely going to be trying to execute both Ash and Yuri. No one else will be killed, they will be processed by Kro, our prisoner rehabilitation and management expert. Some will outright be let go afterwards.

We've only discussed this with Fairview. I think it's entirely fair for us to take our time and try to organize.

Anyway! We are still finding a schedule, but from the looks of it, it's looking like Wednesday the 26th anywhere between 12 PM and 8PM EST is our best bet. Not 100% still, but just trying to be transparent with you!

But either way, here's the response we came up with as everyone seems satisfied with it now. Mother wants to add some things to take into account alongside it, so please wait until she does that to properly discuss it.

1- Fairview has been wary of Meiaquar since the declaration of independence, splitting their time between training in preparation, working on building up Fairview properly again, and repairing relations between other nations. Geladyne and Telegrad mostly as it stands. Recently, after some talks with outsiders, Fairview may begin focusing on defenses, however.

## 2- Still being decided

- 3- Should Meiaquar make an attack on Fairview, it should be expected that Fairview would like to retaliate the very same. Our representative and their partner is being focused out solely, and as such we will likely do the same, focusing on the Donna and any close to her such as Loki, Coal or Chiba. Should they not be present, depending on the IC, Fairview may march directly into Meiaguar to come after the Donna directly.
- 4- Should Fairview be victorious we expect equal retaliation. Meiaquar is seeking to eliminate those they see as problems, and as such Fairview will do the same. Any outside of that will likely just be questioned about motives before being released once everything has been settled. Should anyone outside of the problem makers for Fairview prove to seem as though they may create problems for Fairview similarly to the Donna in the future, they may get harsher treatment. That'll be dictated by IC.

As for the part that Dev talked about. For Fairview this ... Isn't fun rp. This conflict isn't something we are interested in nor will enjoy but we understand if Meiaguar wants to have it.

Yet this is why we will always ask for a fair trade in return of what you ask from us. If you want to kill some of our character, then we will ask to kill some of yours. We understand why you want to force a lvl 4 conflict and again we won't refuse that you do that as it makes sense IC, but know that a defeat will expose you to the price you ask us to pay.

Conflict decided by mechanic fight isn't however the only solution and I personnally believe it is far from the most fun one. We could instead work together to turn this conflict in a serie of events that would be more enjoyable for people as a whole, at least on Fairview side. The option is here and free for you to take.

The players in charge of Fairview will then see which days their players will be able to make, and will propose parties and times. Meiaquar's players will respond by offering their own parties to fight them.

This will continue until at least everyone has fought once, and the wins and losses will be recorded. If one side does not have enough people to form a full party but close to, either 2/4 or 3/4, but still has fighters that haven't gone yet, players that won a previous fight may round out their party to make it full.

The fights will continue, at least, until everyone has fought once, then further discussion might be had if there is a want or need to continue.

During these initial fights, no one will be captured, or maimed horribly. It is expected that after a battle, win or lose, both parties retreat to their respective sides.

You need to make it a shared narration act. Not a competition.

otherwise you will always get this problem. Always. I tried to speak about it before, to Dev, to others, I'm serious. This happened with Wasgow, with Ash once, with Shivania, with every conflict IC before. You need to make the people cooperate and not compete.

We aren't on league of legend, we are in a narrative environement with characters and players behind. And in any rp led by characters the rules that maintain the players together is the rule of consent. Aka, if everyone consent, things go well, as soon as one is forced into play things turn sour and violent

One of the guards gave a description to a PC of one of the perpetrators having huge gauntlets; said PC suggested it might have been a Shaitan, and there was a well known one associated with Fairview. There were other things passed on about IC events.

The idea that there was no provable culpability is false, and even if it weren't, this is a fantasy setting with political intrigue baked in; if the leader of another nation says they think you did something, then even if you didn't do it, it's going to be played out.

The situation lead to relatively interesting RP with the tribunal. I'm not sure what you're complaining about beyond that you got caught, nor do I feel you have any ground to legitimately criticize the RP. You were given a ton of leeway to let it happen IC, so I really don't want to hear you complain about it after the fact.

You had every opportunity in this very channel to discuss that. If you wanted to pack your bags and leave Fairview to go to Telegrad or somewhere else, you could have. Instead, your side wanted to fight back, in full view of the intentions of Meiaguar to execute two of you.

Rather than keep your head down in Fairview, even in light of the exile, you decided to escalate the situation IC by trying to secede from the nation who owns it. ICly, Meiaquar's response is perfectly logical. Generally, insurrectionists are not treated kindly, least of all those who have been problems for the nation before, or are on bad terms with the leader of said nation IC.

No one has a problem with Fairview existing. I have no problem with Mother personally. But hostile IC actions have consequences.

Croakie didn't break the same rules as TCBlade. TCBlade repeatedly ghosted someone IC, pretending they weren't there, not responding to their posts, etc. The reason I allowed the meeting to continue as planned wasn't because I necessarily disagreed with the GMs on the matter. I allowed it because I wanted to see if Blade had improved after his ban.

To my expectations, he hadn't. He didn't even acknowledge the Donna once in that meeting. He continued to act more in LOOC than he did IC and had to leave because he was upset, and was convinced that the GMs were trying to ban him again for some reason.

As far as I understand, Wasgow's leaders decided to bail because of Hated's ban. Unless you're going to try and argue that wasn't justified, then I'd prefer you stop bringing them up as if they have anything to do with this situation.

But make no mistake, both Blade and Hated got banned for very legitimate reasons. It wasn't OOCly motivated or targeted to try and allow someone to run free IC because the GM team likes them. I was very much aware of the details of both and as time has gone on, I only feel more that it was the correct call. You're not doing yourself any favors trying to defend him in my eyes.

No, I didn't do it to give my own character an IC edge either, which should be obvious because I've done nothing related to Wasgow or Meiaquar ever since the bans happened. The OOC drama somewhat killed my motivation to continue it, and I imagine right now Meiaquar is feeling the same way.

I'm really tired of seeing this from you. Nations have armies. Meiaquar's has been very much reigned in despite it being entirely appropriate for them to be more heavy handed, and the only reason for that is out of consideration for Fairview, to try and make the situation more fun for them. It's like thrusting your character's head under the water and complaining that they drowned.

The armies are not there to enforce the status quo or deny people from doing things, however they are absolutely an IC consideration that must be accounted for. You can't just say 'I am so strong IC that I will beat them all', because you won't, not even mechanically. And sadly, to my disappointment, there have been far more cries of OOC unfairness and accusation throwing than any sort of mutual discussion. It doesn't matter how much you've studied game design if you don't understand that throwing around bile in a cooperative storytelling environment isn't going to lead to anything positive.

The problem with this situation isn't that it was done mechanically. The problem is that, from my point of view, you have been combative with the other party OOCly while also downplaying the seriousness of your IC actions and desperately trying to avoid the consequences of such, and constantly played the part of victim when people react in ways that do not benefit you.

You are forced to accept the ic consequences of your ic actions. Stop trying to say ic is forced when its IC. Everything that was done was deserved, and saying otherwise just because you do not like it doesn't help things.

Stop claiming ooc bias when none exists, and if it does exist, point it out, because rest assured I can gurantee everythign that was done had ic reasoning.

You can't just claim everyone's ganging up against you oocly when you do something nobody cares for, and everyone is against icly. Its not just me.
