

Section 1. Schedules

Section 2. Meetings

1. Please refer to the CTC General Sport By Laws regarding meetings with the following special notes:
 - a. The pre-season meeting will be held on the same day as the CIAC Volleyball Rules Interpretation Meeting for the purpose of discussing rule changes, addressing scheduling issues and sub-varsity games. Our CTC Meeting will immediately follow the CIAC Meeting.

Section 3. Match Requirements

1. Varsity Match Requirements
 - a. All CIAC and NFHS rules will apply.
 - b. Two officials unless a shortage of officials is identified by the Assigner.
 - c. Line judges – each team shall supply one (1) line judge
 - d. Scorekeeper (Adult whenever possible)
 - e. Scoreboard Operator (Adult whenever possible)
 - f. Libero Tracker (To be kept by the team using a libero. If both teams have liberos only one is necessary.)
 - g. Start time shall be 4:00 p.m. if it is a single varsity match or 25 minutes following the end of the JV Match.
2. Junior Varsity Match Requirements
 - a. Shall be played first with Varsity game to follow.
 - b. Start time for JV will be 4:00 p.m.
 - c. Match requirements above shall apply.

Section 4. Conference Tournament

1. CTC Tournament questions should be directed to the Sport Chairperson.
2. Tournament seeding shall follow the CTC Tournament By-Laws and Seeding Protocols (See Appendix)
3. Access to the bench area during the tournament is limited to team coaches, players, managers, Athletic Director and medical personnel.

A. Locations

- a. The qualifying, quarter-final and semi-final matches shall be at the higher seeded team

- b. The championship match will be located at a neutral site.
- B. Qualifying Match requirements
 - a. Higher seeded team shall be responsible for:
 - i. Securing two officials (Referee & Umpire) unless a shortage of officials is identified by the Assigner.
 - ii. Scorekeeper (Adult whenever possible)
 - iii. Scoreboard Operator (Adult whenever possible)
 - b. Both teams shall be responsible for:
 - i. Libero Tracker (To be kept by the team using a libero. If both teams use one than only one tracker is necessary.)
 - ii. Line judges – each team shall supply one (1) line judge
 - c. Qualifying match(s) shall start no earlier than 4:00 p.m.
- C. Championship Tournament Match requirements – the Tournament Director shall be responsible for:
 - a. Securing four officials (Referee, Umpire, & 2 line judges)
 - b. Scorekeeper (Adult)
 - c. Scoreboard Operator (Adult)
 - d. Libero Tracker (To be kept by the team using a libero. If both teams use one than only one tracker is necessary.)
 - e. Championship match start time shall be coordinated by the Tournament Director.
- D. Tournament Awards

The following awards shall be issued at the conclusion of the championship game.

 - a. The traveling trophy shall be awarded to the winning team by the Sport Chairperson/Designee for display at their school until the Conference Tournament the following year.
 - b. The first place team will also receive a permanent trophy to remain at their school once the traveling trophy leaves.
 - c. The runner-up will receive a plaque for display at their school.
 - a. The first place team will receive medals for all players.

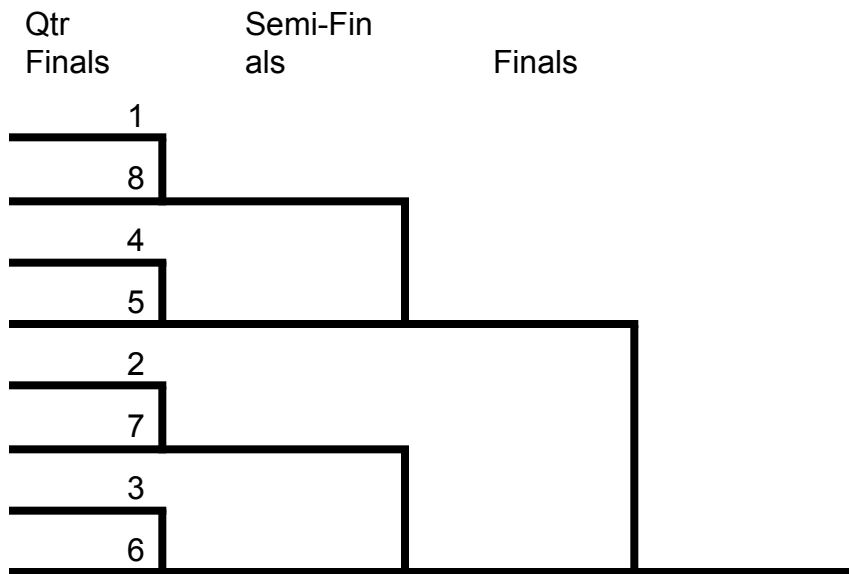
Section 5. All-Conference Selections

 - c. 17- Sportsmanship Certificate Recipients (one nomination at coach's discretion per school)

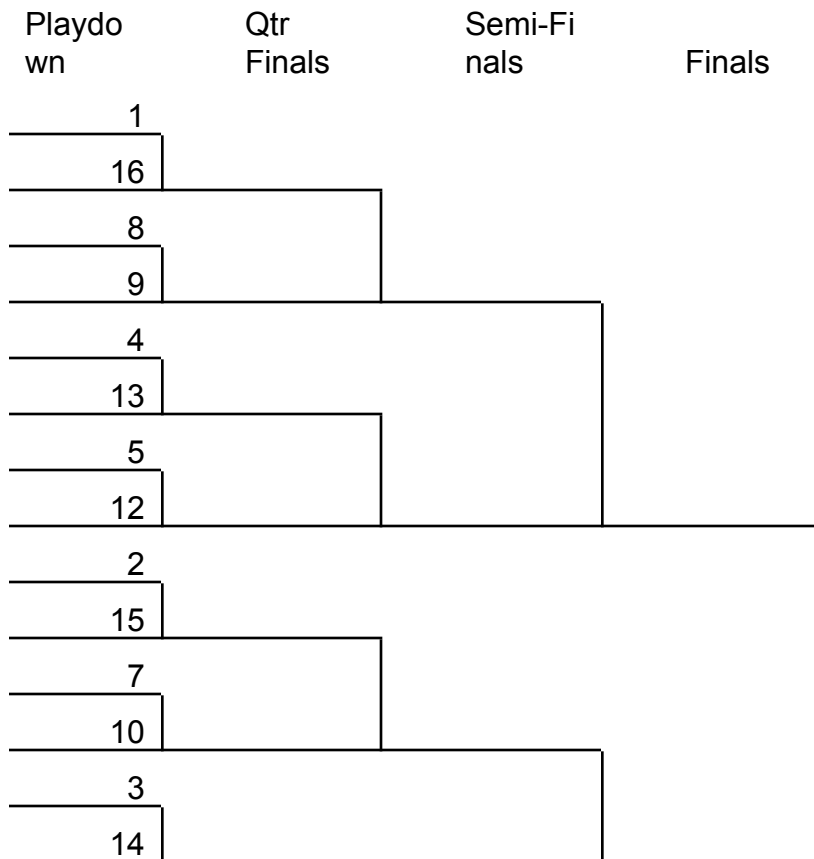
