RE: Frisco Canary Followup

Dear Dr. Bartlett (sp):

It was nice to meet you yesterday. Thanks for the time you spent with Frisco and me

- 1. I've received the radiology report and reviewed it. .
- 2. I've asked for a script for Hyperthyroidism in another email.
- 3. I've asked for confirmation and/or adjustment on the Radiology read charges when that final pricing is confirmed in another email.

At this point in time we are opting to pass on the surgery option. That may change. While you view this is a "critical situation", and the radiology report conveys the same, the irony of this is that he's seemingly been like this for almost 3 months with a currently "unbelievable" amount of positive healing having transpired since we got him back, in light of the information you have shared. He actually had 3 seizures after coming home and in this condition before we discovered the food we had been feeding him for years was likely responsible for all his seizure problems. He seems to be putting on a clinic for feline self care in a very remarkable way. Without the prior vet's proper heads up when he was seen/found in early December, we've been treating him as if he could heal. In fact, the reason for our recent appointments was to share his remarkable healing progress from chronic food poisoning and to establish baselines for a healing study. They were not to find out his insides had been 50% dislocated before he started recovery. That has only added a lot more mystery to all of this. We may pursue the surgery in the future. If we do, we will forgo the specialists. That is not within our budget. We appreciate the lower cost option you all discussed. This letter can stand as a waiver of liability or we will sign another as would be required to proceed.

At this point in time I would like to get a prescription for Hyperthyroid management. As I indicated on the phone, I have some concerns about using that at this time. Hyperthyroidism seems to provide "strikingly" powerful wound healing work, which we now know is needed. I would like to administer the medicine to see if that helps with his heart rate while not limiting or retarding his healing potential.

When I saw Frisco after the X-rays, his eyes were fully dilated. I have only seen him do that during a seizure. I assume that was from extreme environmental stress. We can pick him up and handle him with no issues. We can check his kidneys with no issues. We handle him a little softer than typical, but there are no positions that grossly stress him out. We are not however probing for internal damage and/or the foreign environment may have triggered that. When a cat goes into that state, would that affect blood draw results? Are any of the blood test values remotely a function of a chemical that might be a short term spike from stress? You all didn't draw blood, but if you had, could an animal in that stressed out state produce readings on blood tests that aren't representative of a typical state? This isn't a loaded question. I don't know the answer. It just made me wonder.

As I indicated, I am involved in a very large publishing related to small business startup and management of businesses with a focus on affordability, good client communication, and ethics. Your office seems to have a nice focus on a lower cost clinic setting that interests me greatly. I will follow up on that matter separately.

I've included some additional information in this document. Thanks for the care given yesterday.

Frisco is our last cat at this time. We lost both he and Kizmet last November and we are very glad to have him back for as long as he's able to stay.

We've had 6+ cats in the past 10 years and we had many more prior. The vet care costs have skyrocketed. We hope to get more and we hope your lower cost approach to care can set a new example in an industry where many of the Professionals seem to have totally lost focus on pricing and services.

These Appointments were for Recovery Baselines, not what was found...

When I setup the appointments with our primary vet last week, we weren't searching for problems. We were actually trying to get baseline health information so we could document his remarkable recovery progress since removing him from a fish diet that seems to have been grossly mis-prescribed by a nationa/international pet food provider with extremely poor industry oversight.

- Prolonged exposure to toxic food seems to have led to 12+ months of violent seizures (30+ seizures)
- The source of those seizures was not properly diagnosed or remedied due to the omission of a simple, low cost mineral analysis test
- When that information was presented to our prior vet it was extremely apparent she knew what the tests were, and she refused to discuss the findings at all. To compound matters it was clear both of her office staff had been coached not to discuss it at all as well, which is grossly problematic.
- For reference, Kaiser Permanente, a membership based health care system where costs are more relevant, uses hair mineral analysis to assess human patients. Global researchers involved in human health studies related to autism and seizures use it. Those studying aggressive abnormal human behavior use it. Holistic Vets are finally starting to use it. The modern version of it dates back to the 1950s. One man dedicated 40 years of research to the systems. It was originally used in a very similar form first in the 1840s to diagnose Arsenic poisoning.
- To find out such an important low cost diagnostic tool has been completely omitted from Modern Veterinary Medicine has been beyond shocking. There are several very simple commercial reasons for the omission and none are good.

When our Vet last week looked horrified while checking out Frisco it was very confusing.

- His condition last week was 10-20x better than it was when we got him back in December
- Given she was the vet who saw him and enabled his return to us in December, when all fo the same
 internal damage had to be present, you can imagine the confusion. Any problems he has now he most
 certainly had then in a far more obvious manner.
- Why on earth did we just find out about these internal problems last week with a confirmation from your office and radiologist yesterday?

Personally, given all the facts available to us now, I believe our prior Vet knew of all his problems when she reviewed him in December. Given his condition then and the trauma documented she had to have known.

- Instead of sharing that with the people who found him, which would have likely resulted in a request for Euthanasia, her suggestion was to "just feed him and water him" in a way that would allow him to die in his own time.
- In some ways, that kind of service might be appreciated. We would have likely choosing to try to provide Kitty Hospice, but not all people would have.
- In others, it makes all of us look incredibly inappropriate when he starts to heal himself to a degree far more than anyone might have thought possible.

He was definitely a little shaken up by the Vet visit yesterday. That type of eye dilation doesn't come naturally, but as of this AM he's back to his routine in which no pain nor discomfort is visible and he's following the protocols he's used for the past several weeks to manage or heal.

As a Kitty Shaman, I have assisted with the cross over process for several cats. Most of those that wished for a conscious passing we've been able to accommodate. We also have used Euthenasia when we've felt it

appropriate. We will continue to work with him as he seems to dictate. In the yogic world, they believe that each life is defined by a predetermined number of breaths. Everything that happens between the first and last is just a story that connects the two. He should have been dead 50x by now. He seems to be putting on a show.

Hyperthyroidism

It appears Hyperthyroidism is a symptom of extreme wound healing. Maybe the body can get stuck in that mode too. As of now, I'm guessing that has been a critical contributor to his remarkable healing since we've stopped with the toxic fish food. I'm a little concerned about intervening but it seems he's interested in trying the medicine.
