

IBikeLondon - Terms and Conditions

IBikeLondon CiC Event Terms and Conditions

The Terms and Conditions detailed below apply to all riders participating in any event organised and operated by IBikeLondon CiC. Completion of an Event Registration Form on Eventbrite or attendance at an event of the rider's own free will acknowledges acceptance of these Terms and Conditions.

EVENT TERMS AND CONDITIONS

Format

1. You accept that the event you are entering is not a race in any format.

Conduct

2. You are fully responsible for your actions whilst attending the event. IBikeLondon CiC do not accept responsibility for your actions nor their consequences.
3. Upon signing the Event Registration Form or attending an event, you agree that you understand the style of ride you are entering (slow/social). Furthermore, you confirm that you are physically fit and capable of undertaking this event.

Age Requirement

4. The completion of the Event Registration Form or attendance at an event must be by a person aged 18 years or over. Evidence of age must be provided on request.
5. Riders under the age of 18 will be allowed to participate in the event with the consent of their parent or legal guardian who must sign the Event Registration Form and attend the event in person. By signing the Event Registration Form and

attending the event in person, you accept responsibility for the actions and consequences of the underage rider.

6. Additionally, Under 16's need to be accompanied by an adult who is responsible for them at all times.

Equipment

7. You confirm that the cycle you are riding for the event and all of your equipment is of a suitable standard and state of roadworthiness, in particular, providing the ability to complete the distance, dependant on the event.

8. We reserve the right to refuse entry to the event to anyone with inappropriate equipment or clothing.

E-Bikes

9. If you wish to use an e-bike at one of our events, it must be fully compliant with UK law - e.g. no "chipped" or overpowered e-bikes. These are considered illegal in the UK and are not allowed at our events.

Routes

10. The Ride Leader will give a ride briefing at the start of the event, detailing the route, any potential obstacles, points of interest, identifying Ride Marshals & important points regarding how the ride is operated.

11. During the event, there will be verbal recommendations given by the Ride Leader & Ride Marshals at appropriate points on the route. The absence of these recommendations does not signal that there are no dangers approaching and it is your responsibility to make a decision regarding whether to ride a section or not. The choice of route does not necessarily indicate that the trail or road is rideable and you

are deemed to make your own decision about whether to proceed on bike, foot or not at all.

12. We reserve the right to shorten or alter the published route at any time.

Rules

13. You must adhere to and obey the Highway Code, local bylaws and the laws of England, in which the event is taking place, and extend all reasonable courtesy to other road and off-road users.

14. You must be considerate to other users of bridleways, tracks, byways and public ways when riding off-road. Upon seeing other users, such as horse riders, walkers, and other cyclists, it is advised to slow down and pass with care.

15. You must not drop or leave any litter on any part of the route but dispose of it responsibly at an appropriate place or bin.

16. You are expected to respect the roads and areas that the events travel through. It should be remembered that this is both a working landscape and home to many communities. If you stop for a comfort break you are asked to do so at public/ private toilets.

17. You will be fully responsible for any fees or costs incurred or arising from an accident either involving or caused by you. This includes, but is not exclusive to, fees from Police, Air Ambulance, Fire and Rescue and Ambulance service. If the situation arises that you are not capable of making the decision to call the emergency services, you agree that a member of our Team or a member of the public may call on your behalf. In this situation, you still accept the costs and consequences of such actions.

Insurance

18. Participation in the event is at your own risk. Riders who wish to, can organise their own personal insurance cover.

Recordings and Event Photography

19. By participating in the event, you confirm and agree that we and third parties authorised by us may record you via photographs, film, audio, audio-visual or other recordings, still or moving, during the event (“Recordings”). We shall own all rights in such recordings and you hereby (i) assign to us any and all present and future copyright, performance rights and any other right, title and interest in and to the Recordings and you hereby waive the benefit of any law known as “moral rights”; (ii) agree that we may use the Recordings for any purpose at our sole discretion including in any marketing and/or publicity materials, and on any website and social media; and (iii) agree that the Recordings may be altered, edited and/or modified (e.g. combined with other images, text, graphics and/or sound). You hereby release us from any and all liability from such use and promotion and specifically waive any right to any compensation you may have for appearing in any of the Recordings.

20. The ‘Recording’ (photographs, film, audio, audio-visual or other recordings still or moving taken during the event) rights remain the property of IBikeLondon CiC and the photographer. Whilst we allow riders to share recordings free of charge on social media, anyone looking to use the images for commercial purposes needs to contact IBikeLondon CiC to arrange special permissions.

Cancellations

21. Events are all free of charge. Donations can be made to charity via links on the event page.

22. We reserve the right to cancel any event due to extreme weather conditions. We always aim to do this with more than 24 hours notice where possible.

Your Personal Information

23. We will only use your personal information as set out in our [Privacy Policy](#).

Alcohol Consumption

24. At any point during the event, when riders may consume alcoholic beverages, it remains the full responsibility of riders to ensure that they are fit and safe to ride or drive home and remain fully responsible for their actions in such circumstances.
