PARENT(S):

1. Parents should support the efforts of the volunteer coaches and of the league.
2. The use of profanity, drugs, alcohol, or tobacco during any NCYFL event is prohibited.
3. Set the right example for your child by always showing good sportsmanship.
4. Never argue with a coach or official during practices or games.
5. Any complaint or concern can be directed to the NCYFL, where it will be promptly investigated.
6. Understand that your child will be given every opportunity to participate; however, the safety of our athletes is our #1 concern.
7. Any parent who enters the playing field during a game risks their child being disqualified from further participation (except for an injury to your child).
8. Any parent who incurs an unsportsmanlike behavior penalty risks their child being disqualified from further participation.
9. Remember to praise your child's efforts and always offer your support.
10. Please allow your child to play as a child and have fun.
11. Never voice any complaints or concerns towards coaches, referees, or league officials in front of the children.

SEDRO WOOLLEY YOUTH FOOTBALL AND CHEER CODE OF CONDUCT SUPPLEMENT

All Head Coaches, Assistant Coaches, Players, Parents or Legal Guardians of Registered Players, and SWYF&C Sponsors will be considered "Associate Members" in the SWYF&C Organization.

All Associate Members must abide by the NCYFL Handbook, NCYFL Code of Conduct, Head Coaches Job Descriptions, the SWYF&C Bylaws and SWYF&C Grievance Policy found on the SWYF&C website.

1. A signed NCYFL Code of Conduct must be on file for all Associate Members in order for any Football Player and/or Cheerleader/s to participate in any NCYFL or SWYF&C Event.
2. Associate Members are responsible for the conduct of any person brought to a SWYF&C or NCYFL event affiliated with their respective Player/s and/or Cheerleader/s. This includes all household members, relatives, and acquaintances regardless of whether they signed a NCYFL and SWYF&C Code of Conduct.
3. All Associate Members will follow the steps outlined in the SWYF&C Grievance Policy to address concerns or complaints within the SWYF&C that are a direct violation of the NCYFL Handbook, NCYFL Code of Conduct, or SWYF&C Bylaws.
4. Any associated members that speak negatively or slander other members are in direct violation of the SWYF&C Code of Conduct.
5. Associate Membership to the SWYF&C Organization may be suspended or terminated by majority vote of the Executive Board Members for violations of the NCYFL Handbook, NCYFL Code of Conduct, or SWYF&C Bylaws.
6. If any associated member is ejected or removed from any SWYF&C event they will automatically be suspended for a minimum of 1 week to any SWYF&C events. (This includes Practice, Games, Competitions, ect.)
7. Associated members will be held to the Code of Conduct effective on the signed date through the last game or competition of the season. Please note this Code of Conduct is in effect for Athletes while at school or other events not solely at SWYF&C / NCYFL Events.
8. Any and all complaints and concerns shall be emailed to SWYF&C Board to make it official, the SWYF&C Board will not accept anonymous complaints or concerns.
