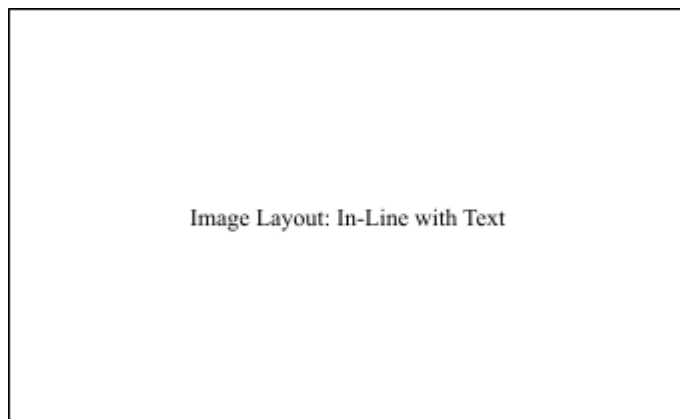


Figure 1. Title of Image - Bold

REFERENCES [Section 7: Capitalize each word, Times New Roman 9pt Bold, no spacing after subtitle]
