On Tuesday, September 19, 2023 the District 67 Policy Committee met in a joint session with the District 115 Policy Committee.

The Board's policies were undergoing suggested updates based on the recommendations issued in Press Issue 112. There were no questions submitted prior to the meeting.

Administration provided a brief update on only policies in which there were questions. Majority of the policies recommended by PRESS were in reference to a five year review. During a five year review, PRESS will review policies to determine if they are still valid according to new laws or regulations. Many of the policies did not change but the cross references and footnotes were updated.

Board members and administration held discussion on the recommendations from PRESS Issue 112.

Dr. McHugh discussed there is no need for milestones in Policy 6:10, there will be a discussion in a future meeting to update.

Policy 4:60 - Threshold

Whitney discussed the threshold change from \$25,000 to \$35,000 effective January 1, 2024 per law. Contracts less than the threshold will not need to be presented to the Board. Policy will be presented for the Board's approval in upcoming meetings.

Operating Procedure Manual Review Timeline

Discussion held on the best way to conduct an audit of the full policy manual. Will revisit in an upcoming meeting.

Open Discussion

Administration will be presenting an update to Policy 5:330 to align union contracts to other employee guidelines such as confidential employees. Discussion held on union vs. confidential employees.

The next policy meeting will be held once PRESS Issue 113 is released.

Mr. Remus motioned to adjourn the meeting and Mrs. Bernahl seconded. The meeting was adjourned at 5:49 p.m.
