Superintendent's Report: Enrollment K-8 136, 2 off campus, 20 in PreK. This is a total of 158 (up 5 from January report). The board was reminded of the Ashley High School All-Class Reunion to be held in November 2015. Discussion was held regarding the maintenance grant. It may be necessary to change the scope of the original work. The construction of an additional trophy case was discussed. Mr. Hodge will get an estimate or two. Ashley Post Office procedures were discussed. We are having trouble with the water heater pilot light going out. This has happened twice in the

last week. Classroom heating problems were discussed. The state budget was discussed. The governor is planning cuts in some areas of education. We have used five emergency days. This will push back the school end date to May 29. We had a recent ISBE breakfast/lunch review. More will be shared once we receive the official findings from ISBE. PARCC testing will begin March 3. These tests will replace the ISAT tests, and will be given to grades 3-8. Girls basketball has concluded their season. The boys will play this week in the Dodds 7th grade tournament. Their season will conclude once this tournament has finished. Upcoming scholar bowl meets are February 24 at Willow Grove, February 26 and March 3 at home, March 5 at North Wamac, March 9 at Willow Grove, March 10 at Nashville Middle School and March 26 at home. The scholar bowl will compete in the Marion County tournament held on March 20. Congratulations to Katelynn Rynski who received a medal for placing 2nd on the Mater Dei All-Tournament team. We lost three volleyball games and one tournament due to inclement weather. We will try to reschedule these games. The volleyball team plays tonight at North Wamac, tomorrow at Ina, and Thursday at home. The peewee basketball season is wrapping up. They play Friday at home and Saturday in the Woodlawn shootout. A home school extracurricular policy was discussed.
