Terms and Conditions for Ticket Sales

- **1. Acceptance of Terms.** By purchasing tickets to All-In Live: Miami (the "Event"), hosted by All In Podcast, LLC (the "Organizer"), you ("You" or the "Ticket Buyer") agree to be bound by these Terms and Conditions. - **5. Cancellation, Postponement, and Alterations.** The Organizer reserves the right to cancel, reschedule, or alter the Event at any time, including changing its format, speakers, participants, content, or other event-related components. If the Event is canceled in its entirety and not rescheduled, the Organizer may, at its sole discretion, refund the face value of the ticket. This does not include any handling, booking, or administrative fees. In the event of a postponement or significant alteration of the Event, you will not be entitled to a refund. Where possible, the Organizer will offer substitute tickets for a rescheduled Event or an alternative event, subject to availability.
- **6. Entry and Attendance.** Valid photo identification matching the name on the ticket and/or proof of purchase may be required for entry to the Event. The Organizer reserves the right to refuse entry or eject any person from the Event for reasons including, but not limited to, disorderly behavior, health and safety reasons, or non-compliance with these Terms and Conditions.
- **7. Media Consent.** By attending this event, You acknowledge and agree that the event will be filmed and/or photographed. You grant Organizer and its affiliates the right to use, reproduce, modify, and distribute any photographs, video, or audio recordings of You for any purpose, including promotional,

marketing, and distribution purposes, across any media channels or platforms, without any further authorization or compensation to you. Your attendance constitutes your consent to such filming and/or photography and to the use of your image and likeness.

- **8. Assumption of Risk** By attending this event, You acknowledge that participation in the event involves inherent risks, including but not limited to potential injury or death. You voluntarily assume all risks related to your participation and agree that the Organizer, its affiliates, employees, contractors, and agents are not responsible or liable for any personal injury, illness, damage, loss, or death that may occur as a result of your participation in the event.
- **9. General.** These Terms and Conditions are governed by the laws of the state where the Event is held, without regard to its conflict of law provisions. Any disputes related to these Terms and Conditions will be subject to the exclusive jurisdiction of the courts of the state where the Event is held.
- **10. Dispute Resolution.** In the event of any dispute, claim, or controversy arising out of or relating to this event or these Terms and Conditions, you agree to first attempt to resolve the dispute through good faith mediation. If the dispute is not resolved through mediation within 30 days of notice, it will be submitted to binding arbitration in accordance with the rules of the American Arbitration Association. The arbitration shall take place in Los Angeles, CA, and judgment on the arbitration award may be entered in any court having jurisdiction. You agree that any mediation or arbitration will be conducted on an individual basis, and you waive the right to participate in a class action or consolidated claims.
- **11. Changes to Terms and Conditions.** The Organizer reserves the right to change these Terms and Conditions at any time and such changes will be effective immediately upon posting the updated Terms and Conditions on the Event's official website. You are responsible for reviewing these Terms and Conditions regularly.
