There were 74 responses from stakeholders to the survey.

o Is the HCIS community willing to move from our current location if we have to? Make a plan.

Yes, the community is willing to move if we have to. 75% of respondents to survey said yes, if the school were not located in its current location, they would still be interested in enrolling. 25% said no. Very few respondents reported that the location of the building was an important factor in sending their students here.

That being said, most of the respondents reported that one of the benefits of the school is the location and proximity to YMCA, bus line, library, and other downtown locations.

- Is it possible and financially feasible to contract with bussing company to transport middle school students? How do we find out?
 - Would we have to provide bussing for high school students as well if we provide it for middle school students?

Only if they are in the same building. If the middle school kids are in a different building, then we would not be required to provide bussing for all students.

- How much would bussing cost?
- How would bussing change our daily schedule?

Depending on the schedule of the bussing company, our schedule may need to change. We don't know how that would change at this point. 41% of respondents to the survey said they would support changing the school day schedule if it had to change because of bussing.

One of the community support expansion?

Parents support expansion according to the survey. 61% said they would have liked to start their kids at Harbor City in 6th grade, 10% said they would have liked to start in 8th grade. 15% said no, they would not have considered enrolling their student in a middle school program.

Almost half of the respondents said they support grade expansion.
