Financial Impact

The state office is considering the Payroll Protection Program (\$40,000) loan. The recommendation is to use this to help alleviate projected deficits.

The state office has refunded personal checks and booster programs that had paid for festivals that were cancelled. The office has halted refunds of school issued checks until schools are staffed. This is to avoid uncashed checks, cancelling checks and incurring additional banking fees.
