

Green Happenings

Contra Costa Transportation Authority (CCTA) Smart Signals Project

The Countywide Smart Signals Project will interconnect major corridors with the ability to monitor and manage traffic operations and allow the sharing of information between agencies and the public. Implementation of this project will upgrade traffic signal systems at 7 of the 12 City intersections and is expected to result in safety and operational improvements for all modes of transportation on San Pablo Avenue and Richmond Street-Elm Street.

Rebecca was at the meeting where a bunch of us advocated for traffic calming in specific neighborhoods. We (Janet, Stuart, Gaia, Amelia Schmale, Mark whose last name I'm forgetting) met with Public Works director Yvetteh Ortiz last year and were told that some traffic calming things would be happening, and subsequently Jarrett told us that the city would be building three traffic circles. This circles back to the transparency issue; where will the traffic circles be and how is the city going to make that decision? How can we/she advocate for a comprehensive traffic calming program in El Cerrito?
