In-game Ban Rulebook

LAST UPDATE: 2025/11/23

You are expected to keep up to date with the changes made here as a community member.

Section 0 - Punishment Table

Each rule has a point value associated with it. Breaking a rule adds that point value to your total count.

Minor rule breaks result in few points or a warning, whereas major rule breaks result in an immediate permanent ban.

In the scenario where your current strike count is higher than the "Strike Cap" on a rule you have just violated you will receive a punishment equivalent to the point that rule break caps at. For example being at 5 strikes and being punished for bug abuse would result in a 30 day ban, not a 90 day ban.

You may appeal your most recent strike after 3 months (90 days) with a "clean" record in the given time. You may attempt to appeal any strike at any moment if you believe you have not violated the rule broken.

Some rules give a range of points depending on the severity of said rulebreak.

A "Warning" is a punishment only for select cases below, expiring in 3 days or as many as your current strike count; whichever is greater. It can be appealed anytime for a swift unban with an acknowledgment of whichever rule was broken, and how. Further infractions result in a strike(s). Strikes can possibly be issued instead of warnings for more drastic cases, and lies upon mod discretion.

Section 1 - Severe Offenses

As mentioned above, violating rules listed as "Severe Offenses" will result in a permanent ban that cannot be appealed unless the tag states otherwise.

1.1 Exploiting - (7 STRIKES)

- 1.1.1 Violation of Roblox's Terms of Service and Guidelines.
- 1.1.2 We will not tolerate and will ban for presence in *any* Discord Roblox exploiting servers unless given explicit permission by a Game Mod Lead beforehand, or attempts asking for scripts.
- 1.1.3 Vigilantism is not encouraged, you as a player should report it to the moderation team by using a player report instead of risking yourself for a ban.

1.2 Black Marketing - (7 STRIKES)

- 1.2.1 Violation of Roblox's Terms of Service and Guidelines.
- 1.2.2 We will not tolerate and will ban for presence in *any* Discord AO blackmarketing servers unless given explicit permission by a Game Mod Lead beforehand, or attempts asking to blackmarket.

1.2.3 Vigilantism is not encouraged, you as a player should report it to the moderation team by using a player report instead of risking yourself for a ban.

1.3 Harassment - (2-7 STRIKES)

- 1.3.1 This includes general harassment of individuals, playful trash-talk is fine but that's as far as it should go. Harassment in Discord or the Forum from an in-game experience may also be punished in severe circumstances.
- 1.3.2 *Including but not limited to any* following is not tolerated: death threats, discrimination, doxxing, and encouraging self-harm or harm towards others. Prolonged bedevilment, intimidation, or pressure over an amount of time is also not tolerated.

1.4 Impersonation - (2-7 STRIKES)

- 1.4.1 Impersonating any user against their will is forbidden.
- 1.4.2 The punishment will be aggravated if a staff member is impersonated; staff roles include:
 - Vetex and Techlevel80
 - Staff Leads
 - Game Moderators
 - Discord Moderators
 - Testers and the Friend role
- 1.4.3 Any impersonation for the sake of harassing a user through the use of their username, along with defamatory remarks, will be met with an instantaneous permanent ban.

1.5 Clan Infamy Sabotaging - (1-7 STRIKES + POTENTIAL CLAN DISBAND)

- 1.5.1 Joining a clan to purposefully lose Clan Infamy to sabotage the clan's progress.
- 1.5.2 Abusing bugs to assist in sabotaging will greatly increase the strike value for this rule break.
- 1.5.3 Depending on the severity of the issue it could lead to the offending clan being disbanded.

Section 2 - Moderate Offenses

Violating a "Moderate Offense" rule will generally result in a non-permanent punishment but repeat offenses will lead to a permanent ban.

2.1 Exploiter Association - (2-4 STRIKES - CAPS AT 6 STRIKES)

- 2.1.1 You associate yourself with an exploiter knowingly in-game: you accept items, help kill another player with someone blatantly exploiting, and so on.
- 2.1.2 Any moderation tools that need to be used to reset a slot prior to an association with an exploiter may be used.
- 2.1.3 With a similar punishment, aiding any chase-banned user with items, evading bans or anything that may benefit them is forbidden. Refer to <u>4.6</u> In the side notes.

2.2 Bug Abusing - (WARNING OR 1-2 STRIKES - CAPS AT 4 STRIKES)

- 2.2.1 Abusing any bugs to benefit from them or to disrupt the experience of other players.
 - Here you can find a list of some of the publicly known bugs.DD
- 2.2.2 Bugs that cannot be fixed due to being caused by Roblox, such as holding X on the window of the client.
- 2.2.3 Any bug you find can be reported in the <u>Discord</u> server with a bug report or the <u>Forum</u> with the Bug Reports tag.
- 2.2.4 Associating yourself with someone abusing bugs; accepting items earned through bugs, helping kill another player with someone who is abusing bugs in the process, and so on, will result in an equal punishment to the player that is bug abusing. Moderator tools may be used to roll back the data of any slot prior to the bug abuse.
- 2.2.5 Bugs used in Elysium are generally considered to be pointless or nugatory and therefore won't be punished for, please kick these individuals from your Elysium. Bugs that still affect main game progress such as item stealing bugs will still be heavily moderated within Elysium.
- 2.2.6 Unraidable bases will have the owner of the base striked if the base is personal, Clan Leader if it is a clan base. Clan members found using the base will receive a warning while those determined to be disposable/alt

accounts will receive a permanent ban. Moderator tools may be used to delete the data of offending personal/clan bases. For the specifics of what constitutes an unraidable base, refer to **Section 4.8 - Unraidable Base Specifications**.

2.3 Macroing - (2 STRIKES - CAPS AT 5 STRIKES)

- 2.3.1 Usage of programs that automate a process that would typically require a certain degree of attention in order to not fail the task. If you are present at your computer and are able to respond to stimuli within the game then this is permitted.
- 2.3.2 Alternate accounts blatantly used for macroing will be permanently banned.
- 2.3.3 Alternate accounts that are *not* exclusively used for macroing can be appealed with an inventory wipe after the main account ban duration.
- 2.3.4 You are permitted to AFK while macroing for the sake of staying in the server by eating or doing similar actions, provided you are in an accessible location.
- 2.3.5 Moderator tools may be used to roll back or completely wipe the inventories or fishing progress/journal statistics of any affected slot.

2.4 Bypassing - (WARNING OR 1-3 STRIKES - CAPS AT 6 STRIKES)

- 2.4.1 Bypassing the filter to use slurs, hate speech, or other flagrant language.
- 2.4.2 This includes Roblox usernames that are, or, related to: sexual, racist, homophobic, slurs, controversial groups or anything else that is in violation of Roblox's Terms of Services. This ban will be permanent unless the username is changed on the Roblox platform. It can then be appealed to the respective strike count.

2.5 Illegal Renown/Clan Infamy Gain - (1 STRIKE + POTENTIAL RENOWN RESET)

- 2.5.1 Using alternate accounts or others to help boost Renown or Clan Infamy; kill farming off each other in a way that boosts renown or clan infamy.
- 2.5.2 Purposely boosting off allowing the stealing of island claims is also prohibited, as well as using alternate accounts to assist in claiming multiple islands or "taking over servers" for the purpose of boosting infamy or renown.
- 2.6 Cross-trading (3-6 STRIKES CAPS AT 6 STRIKES)

- 2.6.1 This includes trading anything concerning other games for something in Arcane Odyssey.
- 2.6.2 Exempt from this are commissions like art in exchange for Galleons/in-game items and vice-versa.

Section 3 - Light Offenses

Violating a "Light Offense" rule can lead to harsher action, including being given a strike, if repeated. Some "Light Offense" violations can immediately result in a strike if they are denoted as such.

- 3.1 Impersonating In-Game Factions (0 STRIKES, CLAN DELETION)
 - 3.1.1 Impersonating the Grand Navy and Assassin Syndicate.
- 3.2 Impersonating Player Clans (0 STRIKES, CLAN DELETION)
 - 3.2.1 Impersonating other player clans by using their logo, description, and rank names.
- 3.3 Stealing Clan Logos (O STRIKES, CLAN DELETION)
 - 3.3.1 If a clan logo is not publicly accessible through the internet/custom made, it may not be used without explicit permission from its creator.
- 3.4 Showcasing Bugs/Exploits Online (WARNING + VIDEO DELETION)
 - 3.4.1 Involves showcasing and revealing how to replicate a bug/exploit in Arcane Odyssey.
 - 3.4.2 The warning and ban on your account will NOT naturally expire and will only be lifted once both the video has been removed and an appeal has been made.

Section 4 - Side Notes

4.1 Preventative Account Compromise Ban

4.1.1 Mods can temporarily ban your account if you request, with proof of ownership, if you believe that someone has broken into your account maliciously. We are not responsible for your account's security and all actions taken by your account are your responsibility.

4.2 Alt Account Ban

- 4.2.1 Any proven alternate accounts of the player at the time of their ban will also be banned.
- 4.2.2 This only applies to **permanent** bans.
- 4.2.3 Does not apply for an alt that...
 - ...was made after the ban and has no connections to the banned account.
 - ...was made after the ban and has made no bannable offense that has yet to be punished.

4.3 Ban Scope

- 4.3.1 Discord/Forum bans can transfer into a game ban if severe enough.
- 4.3.2 Vetex as well as the Mod Leads have the final say.
- 4.3.3 If the date of evidence provided in a ticket exceeds a reasonable timeframe, it can be disregarded on a case by case basis which lies upon mod discretion

4.4 ToS Violation via Clan

4.4.1 In the event that the clan is the source of the ToS Violation, the clan may be deleted and the Clan Leader could be punished with two to six points depending on the severity of the case.

4.5 Loopholes

- 4.5.1 Do not attempt to find loopholes to violate the rules.
- 4.5.2 Attempting to break the rules is also an offense that will result in the same punishment as the rule that the player was intending to break.
- 4.5.3 Forging any form of evidence to attempt to falsely incriminate the offender will result in a strike and removal of ticket perms.

4.6 Chase-banning

- 4.6.1 A user who is "chase-banned" is permanently banned from Arcane Odyssey and all of their current and future accounts will be banned.
- 4.6.2 A "chase-ban" is not something the vast majority of users will ever have to worry about in regards to their punishment. Chase-Bans are reserved for the most egregious cases.

4.7 Private Discord Servers & Clans

- 4.7.1 Actions that happen in your Clan's/Private Discord Server may be subject to moderation should extreme cases be presented to the moderation team.
- 4.7.2 If a clan leader were to be permanently banned, any request for transferring the ownership of the clan **WILL NOT** be entertained. The moderation team will not transfer clan ownership between players. Please refrain from opening support tickets asking to transfer clan ownership.

4.8 Unraidable Base Specifications

- 4.8.1 Unraidable bases are bases with the following descriptions but are not limited to:
 - Impossible to destroy barracks through bugs and/or being out of reach.
 - Unreachable Cannons and Mortars
- 4.8.2 General rule of thumb for determining Unraidable bases is if it is unable to be properly contested without using specific bugs or unintended mechanics, it will be considered unraidable. If a base were to be 99% unraidable and needs a very specific method to be raided, then it will be considered unraidable.
- 4.8.3 Specifications may be updated over time.

This rulebook is managed by the Staff Leads. If you have any questions regarding these sets

of rules, please make an appeal ticket in the Discord.

Section 5 - Ticket Rules

5.1 Moderators

- 5.1.1 The Arcane Odyssey Moderation Team reserves the right to deny your appeal or report for any reason we deem legitimate. We also reserve the right to close a ticket once the ticket's conclusion is explained.
- 5.1.2 You may request clarification but anything else will prompt the moderator to close the ticket. If you genuinely believe a mistake has been made by the moderator handling your ticket refer to 5.2.

5.2 Players

- 5.2.1 You have the right to get a second opinion from another moderator and can do so by making another ticket. You may make only one second opinion ticket and must specify that it's a second opinion ticket (1 regular ticket & then 1 second opinion ticket. 2 tickets in total of the same case and ticket type).
- 5.2.2 Staff Lead second opinions can be requested, but still adhere to the ticket limit of 2 in total for the same case. This means if you've already received a second opinion from someone else, Staff Leads can no longer be requested. If you wish to request a Staff Lead in your second opinion ticket please make that clear first upon ticket creation.

If you genuinely believe the Moderator(s) that reviewed your ticket are abusing their position, or breaking rules of any kind, you may report them instead. This will be counted separate from your original ticket(s) and may not change the conclusion of your original ticket(s). If you're reporting through a ticket instead of DMs, please clarify the ticket is a report so that the ticket can be made private to Staff Lead only.

- Troll submissions and simple disagreements of the interpretation of the rulebook will not be counted as valid reports. Depending on the severity this may lead to your ticket privileges being revoked.
- 5.2.3 Attempting to bypass the second opinion cap by continuously making second opinion tickets, or through any loophole is not allowed and will lead to your ticket privileges being revoked.

- 5.2.4 Players can only make appeal/restore tickets for accounts they own and cannot make tickets for others. If moderators suspect you do not own the account they may request you to verify account ownership. This can be done by opening Roblox on the account needing verification, and screenshotting it with the discord ticket visible all in the same screenshot. However, a single proxy is allowed if you reside in a country where Discord is not a possibility. Breaking this rule may lead to ticket privileges being revoked for everyone involved.
- 5.2.5 In cases where a ban were to be appealed, the player may be compensated based on days spent waiting to get their ticket appealed, capped out by the duration of their strike. Each day corresponds to 10 Dark Sealed Chests to be compensated.
