- During last call discussed ABA in PA's plan to address LBA licensure (stand alone license) this upcoming session.
- Jennie shared a link to the document

- Discussed MCE and County funding issues for IBHS benefit
  - Issues with Magellan (MBH) and CCBH- will not expand services to new physical brick and mortar centers
  - There was a rate increase proposed and the increase is on hold as well.
  - Aspire team shared their activities with Magellan thus far (since mid December)
  - Magellan continues to indicate this is not a network adequacy issue, and they are not obligated to expand services within the county.
    - Magellan also indicates that this is an over utilization issue and asked providers to reduce hour requests
    - Montgomery County is aware of the issue but is not communicating effectively
    - Aspire met with legislators yesterday to discuss these concerns.
      - HHS stated that IBHS is a Community Based Service and therefore whether or not center based services are available is not necessarily relevant.
      - SHO 24-0005 letter addresses EPSDT requirements

      - Will try to get language in writing about service exclusions and if it is a hard cap- can escalate to CMS
      - Submitted RTK request yesterday
      - Working to get communication from DHS and OMHSAS
    - Actuarial firm underestimated budget by about 6B
    - BHMCOs are trying to protect bottom line, instead of focus on legal requirements
  - Discussion about the review/ update in Q2
  - Try to get SCA- reference language from SHO 24-0005 letter "If an EPSDT-eligible child does not have timely access to a network provider for medically necessary care, the MCP must arrange for and cover medically necessary covered services out of network, including out of state if necessary, for as long as the MCP's provider network is unable to provide the medically necessary services."

- Recommended Grassroot advocacy efforts to communicate these concerns directly to State Reps.
  - Consider a Voter Voice Campaign & develop messaging
  - Try to align ask with RCPA as much as possible- Drew will connect
    - What contractual or regulatory language allows the BHMCOs to limit or deny expansion
    - Possible MHPAEA violation
