

RELEASE AND WAIVER OF LIABILITY

TevaLand Sanctuary Farm ("the Farm") provides a unique opportunity for education and fun all in one! We bring fun farm friends to you! Participants will be able to learn about and have direct contact with live farm animals. Unfortunately, the Farm cannot guarantee any particular animal will be visible or on exhibit during the traveling program.

I hereby waive and release, indemnify, hold harmless and forever discharge the Farm and its directors, officers, agents, employees, interns, sponsors, and volunteers, (individually and together, the "Released Parties"), of and from any and all claims, demands, debts, contracts, expenses, causes of action, lawsuits, damages and liabilities, of every kind and nature, whether known or unknown, in law or equity, that I ever had or may have arising from or in any way related to my participation in any events or activities conducted by, on the premises of, or for the benefit of, the Farm provided that this waiver of liability does not apply to any acts of gross negligence, or intentional, willful or wanton misconduct.

I understand that the activities that I will participate in are inherently dangerous and may cause serious or grievous injuries, including bodily injury, damage to personal property and/or death. I will be in direct contact with farm animals may include but are not limited to: Horses, ponies, donkeys, goats, chickens, ducks, bunnies, pigs, exotic animals such as ferrets, parrots, chinchillas, guinea pigs and wild animals such as rats and squirrels. I understand that, as with most animals, they may react in an unpredictable way to sounds, sudden movements, people, or other animals that could result in injuries to people or damage to property.

On behalf of myself, my heirs, assigns and next of kin, I waive all claims for damages, injuries and death sustained to me or property, that I may have against the aforementioned Released Parties to such activity. By this waiver, I assume any risk, and take full responsibility and waive any claims of personal injury or death or damage to personal property with the Farm including but not limited to visiting the traveling farm, observing or interacting with the animals, using the facility and its equipment in any manner, form

or fashion, and practicing and/or engaging in other related activities including the initiating of prohibited contact with the animals on and off the premises and disobeying any of the Farm's regulations. It is a condition of entry that participants observe all warning signs, do not venture over exhibit safety barriers and do not enter the Farm's off limit areas.

PHOTOGRAPHIC RELEASE

I grant and convey to the Farm all right, title, and interests in any and all photographs, images, video, or audio recordings of me or my likeness or voice made by the Released Parties in connection with my participation in Farm programs or activities. I hereby grant the Farm permission to use my likeness in photographs, images, video, or audio recordings and place such photographs, images, video, or audio recordings on its marketing and promotional materials, website, the internet, and/or social media platforms, without payment or any other consideration. I understand and agree that these materials will become the property of the Farm. I hereby irrevocably authorize the Farm to edit, alter, copy exhibit, publish, or distribute any photographs, images, video, or audio recordings of me or my likeness or voice for purposes of publicizing the Farm. In addition, I waive the right to inspect or approve the finished product, including written or electronic copy, wherein my likeness appears. Additionally, I waive any right to royalties or other compensation arising or related to the use of any and all photographs, images, video, or audio recordings of me or my likeness or voice.

OTHER

This agreement shall be construed in accordance with, and governed by, the laws of the State of New York. This waiver and release contains the entire agreement between parties, and supersedes any prior written or oral agreements between them concerning the subject matter of this waiver and release. The provisions of the waiver and release may be waived, altered, amended or repealed, in whole or in part, only upon the prior written consent of all parties. The provision of this waiver and release will continue in full force and effect even after the termination of the activities conducted by, on the premises of, or for the benefit of the Farm, whether by agreement, by operation of law, or otherwise.

I acknowledge that I have carefully read this release and waiver of liability and fully understand its contents. I voluntarily and knowingly agree to the stated terms and conditions. I am aware that by signing this release and waiver of liability, I am giving up substantial rights, including my right to sue and certain legal rights my heirs, next of kin, executors, administrators, and assigns may have against any Released Party.
