# Reporting Challenges to and Bans of Palestinian Books or Authors

Not all these organizations are responsive to or supportive of people reporting censorship or bans of books related to Palestine or interested in the silencing and cancelling of events that platform Palestinian content or people known to oppose violations of Palestinian human rights. Still, it is worth reporting challenges and attacks to create pressure for them to be inclusive. I suggest reporting to as many as possible. Keep track of what and when you reported. Keep track of the responses you get and the date, including names and screenshots. If you want to do more than report the censorship, see a list of existing toolkits for creating campaigns against censorship and book bans. Use them critically.
