**hasitha Raymond:** Thanks. What's up, Dick?

**Laura Mattiucci:** Yeah, correct. It's super long. So, we just need to I have a meeting tomorrow with Nate and with Jack.

**Terence McCutcheon:** we can still shorten this up ahead of the actual event. but the full slides would still be beneficial to go with the blog itself.

**Laura Mattiucci:** So yeah So literally just a couple of slides and go through those and then open up to discussion. So it's more of a working session I would say at the summit for the people there and then we pass over to the committee again and then we can start together the week after.

**Laura Mattiucci:** That would be my suggestion here.

**Laura Mattiucci:** Tax, may I ask you one thing on a different note and that's more the user journey for developers when you want to do new developer on boarding and I know the OSO committee was also into some of those topics if I'm not mistaken with Bora.

**Terence McCutcheon:** Yeah, I would need to get a meeting with you,...

**Terence McCutcheon:** Bora, and all affiliate developer advocates that are currently on contract.

**Laura Mattiucci:** Okay, Because what I see is today and maybe I know you're doing also the hackathon soon. So once we're done with the hackathon, I think we have a bit of a gap into what's happening after for retention which are the channels we should be using to pull them in and...

**Laura Mattiucci:** all of those things.

**Laura Mattiucci:** So the user flow for a new developer is not that clear towards the entire ecosystem. If there is anything which you have already text and you've been working on would be nice to see instead of me trying to pull new things out and...

**Terence McCutcheon:** And when is the hackathon you're referring to? Okay. Mhm.

**Laura Mattiucci:** So we start yesterday with the education piece and then the last day will be the summit and then would be nice to pull them in somewhere and not lose them but I'm not sure if IOG channel should be intersect channel so whatever you have in place otherwise I start from scratch which is not what I should be

**Terence McCutcheon:** At the very least,...

**Terence McCutcheon:** we can run things through the developer advocate program. There shouldn't be any issues doing that. I know that earmarks the intersect channel,...

**Laura Mattiucci:** Super heat.

**Terence McCutcheon:** but it's designed to work out. I was just actually explaining with the developer advocates yesterday, the developer portal is a great resource, right? One of the things I don't want to get

too deep here but is for us to understand what the use of that is or how useful is that to the developer community and they've actually created a new site if you haven't seen it as of yet. Let me drop it here.

**Laura Mattiucci:** Thank you.

**Terence McCutcheon:** This is not a direct mirror to the developer portal. but the design is to explain things a little bit more in detail as far as that onboarding journey or...

**Terence McCutcheon:** developer roadmap as we call it. So where the developer portal may have the resources then the developer experience actually focuses on that unique experience piece. So ideally I want these two to work synonymously is the goal.

**Laura Mattiucci:** Yep. No.

**Laura Mattiucci:** And then the developer advocate program Is it a ch Do you have a channel for that one? Where should I drive them? It's like a Discord channel. yeah,...

**Terence McCutcheon:** Was that a question back to me?

**Laura Mattiucci:** So for if I go into the site you have linked there the developer advocate program.

**Laura Mattiucci:** Is there a link to something? Is a Discord channel that they can join.

**Terence McCutcheon:** Right now there's not because people have to join Intersect first and...

**Terence McCutcheon:** get into the Discord. But that process is laid out specifically of join the discord and then find the developer experience channel. obviously I can understand this a little bit clunky...

**Laura Mattiucci:** Okay. Yeah.

**Terence McCutcheon:** but again happy to work together on that. again, there's another round that's going out where the state of state of the developer ecosystem is the survey that's currently run by CF. The state of developer experience again the difference there being what does the ecosystem look like? Where is everybody working? Our survey is focused on...

**Terence McCutcheon:** what is the experience that developers have. So, it's helpful for us to know where everyone's going. That leaves the CF survey with its purpose,...

**Laura Mattiucci:** And that one is done.

**Terence McCutcheon:** but the developer experience no,...

**Laura Mattiucci:** Text. That one is finished. Yours. ...

**Terence McCutcheon:** but it'll go out likely in January.

**Laura Mattiucci:** Got it. Okay. Okay.

**Terence McCutcheon:** They're still working on it.

**Laura Mattiucci:** Yeah. at this stage, where is what is the best channel to pull those new people in? because we've done so much efforts in Same thing in Africa is going to have thousand people in the hackathon.

**Laura Mattiucci:** Thousand people already registered. Where do we send them?

**Anuj Chaudhary:** Yeah, two ways. one is like mostly we'll be onboarding them on intersect as well. Meanwhile, they'll be hacking that is one funnel and the second we'll be capturing all the details and data. So that could be utilized accordingly. For example, Cardano forum newsletter subscription. we can ask them to subscribe to a few ecosystem newsletter for example intersect. So these are the few funnels where we can retain them and maybe we can have something better for example having one particular group for developers going forward as we having this multiple hackathons.

**Terence McCutcheon:** it probably to the working group.

**Anuj Chaudhary:** So where we can share opportunities or for example advocate developer role at intersect or any opportunities in cardano native projects. So there could be multiple avenues for them but I think I'm not sure ...

**Anuj Chaudhary:** how we going to have them at one place. This is my understanding intersect only one channel where we can have all of them making them at least so these are the few options that we can explore text...

**Laura Mattiucci:** Which of the tons of channels in the Discord?

**Laura Mattiucci:** It's so many channels. Where would you I just don't want them to go lost.

**Laura Mattiucci:** Thank you.

**Anuj Chaudhary:**

**Anuj Chaudhary:** where we should have them. according to you if we onboard them on intersect

**Terence McCutcheon:** should be here.

**Terence McCutcheon:** So the idea behind this here what the developer advocates are working on is this developer experience obviously they're deploying off of main for their website. the idea essentially is to get usability on the different branches and essentially allow this to be a developer playground. This may expand into other repositories and projects but different things like are done in the hackathon can be rebuilt and repurposed over here. We can work the developer advocates directly essentially. the goal is to shift them from right now they are contributors here in their first quarter just so that we see that their work and then transition them into maintainers of this repository alongside myself so that they're actually facilitating things for the community.

**Laura Mattiucci:** Can we talk together with Bora and...

**Laura Mattiucci:** Tommy because I feel we're doing two times the same things and we don't need to do so. And if we could spare resources would be nice streamline all together it's easier I think Monday.

**Terence McCutcheon:** Okay.

**Terence McCutcheon:** How late is Mondays at 5 UTC? That's pretty late for you. every Monday at 5 etc.

**Laura Mattiucci:** Say it again. Wait. this is next Monday doesn't work.

**Terence McCutcheon:** Right. Okay.

**Laura Mattiucci:** The week after is fine.

**Laura Mattiucci:** Thank you.
