Border carbon adjustments, a mechanism to shield businesses in nations with robust climate ambition, have been a hot topic recently. The European Union has announced it will impose such taxes starting in 2023, and Senate Democrats in the U.S. have included it in the budget reconciliation resolution. To learn more, we turn to Aaron Cosbey with the International Institute for Sustainable Development. Aaron is an economist with 30 years of experience in the areas of trade, investment and sustainable development. He has served on the Deputy Minister for International Trade's Academic Advisory Council on Canadian Trade Policy and recently wrote a report on the need for Canada to adopt a border carbon adjustment..

# Action 1: Congratulate you new or returning MP

On September 21, 2021, congratulate you new or returning MP. Indicate that once the dust settles on the election and COP 26, you look forward to connecting with her/him/them in late 2021 and at least twice in 2022. Identify yourself as a Citizens' Climate Lobbyist. We have over 6500 members in Canada in 42 chapters covering about 120 ridings. We have been lobbying for evidence-based carbon pricing policies on Parliament Hill since September 2010.

#### Laser Talk: How did the parties voted on key environmental policies

In the past 2.5 years, parliamentarians voted on Bill C230 – National Strategy to Redress Environmental Racism Act, Act C12 – the Net-Zero Emissions Accountability Act, C15 – Enshrining the United Nations Declaration of the Rights of Indigenous People under National Law, C38 – The Oil Tanker Moratorium Act, and the National Climate Emergency Declaration. The Liberals, NDP and Greens voted "Yea" for all of them. The Bloc voted Yea for all of them except the National Strategy to Redress Environmental Racism, and the Conservatives voted "Nay" for all of them.
