### **Minutes of last Meeting**

## **Matters arising**

The last meeting was cancelled as a result of the Covid–19 outbreak and the resultant lockdown. The lockdown also made most of the actions from the last meeting redundant. However the recruitment process has continued by Zoom meetings, this is on the main agenda. Liz Rae has left the choir and this will require finding a replacement Publicity lead. .

#### **Recruitment process**

This has been continuing throughout the lock down. All the committed candidates were interviewed, (11 see Attached report). of these it is the intention to audition 6 candidates in the future when it is possible to have rehearsals. It was suggested that those to be invited for audition should have this confirmed by letter but that no firm date given except that they would be contacted as soon as it became possible for the choir to restart.

There would be an initial rehearsal and welcome back to the choir and then three weeks of auditions, with 2 candidates taking 40 minutes each with the choir. We would hope that the successful candidate would be able to start ASAP.

#### **Autumn term**

It is hoped that we shall be able to restart the choir rehearsals in September, but this is still uncertain with the government guidelines at present. We shall be able to use the sanctuary at High Cross for rehearsals which would help with social distancing. The first few weeks would include auditions for the new Musical Director and Karen Phillips has agreed to fill in during the interregnum before the start of the new MD.

It is hoped that if we start in September the will be no problem asking for the full annual subscription but this may have to be amended if we are not allowed to start until after Christmas.

There was a discussion about the musical programme for September until December. It was decided to retain the Rossini and Puccini Copies if possible from Surrey performing arts. They would give the choir something to continue working on and give the people being auditioned pieces to choose from to work on with the choir at audition. If the new MD cannot start until after Christmas then the committee will have to make some decisions about the November and Christmas concerts with Karen.

Matthew was concerned about our previous commitment to Krystal .Hewitson to take part in sung evensong at St Peters church, which has been postponed until later in the autumn. It was thought that this could be offered to the members of the choir as an opportunity for individual members to take part in if they so wished during the autumn term.
