#### Introduction

These Terms explain how my commissions work. They balance legal protection with plain language so you can know what to expect. Please read them before commissioning.

My goal is to make the process smooth and enjoyable for you, while keeping expectations clear for both of us.

## What you are paying me for

I will create a digital illustration as described in the quote or invoice. The exact scope — number of characters, background complexity, full-body vs headshot, etc. — is defined in your order.

## **Payment**

- Currency: EUR, USD or RUB (BTC, TON, ETH and other cryptocurrency by discussion). Accepting money through Lava top, boosty, cryptocurrency, FPS / СБП (для русских).
- Deposit: 50% up front to start work (100% for cryptocurrency).
- Remaining balance: due on delivery and approval.
- You pay for any payment processing fees and applicable taxes.

# Workflow (what happens step-by-step)

- 1) You submit a form with references and briefs.
- 2) I send a quote and estimated delivery time.
- 3) You confirm and pay the 50% deposit.
- 4) I provide a sketch for review (N revision rounds included).
- 5) After sketch approval, I move to color and refinement.
- 6) Final render is sent for approval. You pay the remaining balance.
- 7) I send final files in agreed formats. Source files only if purchased.

### What I draw / What I don't draw

I reserve the right to refuse any commission request at my sole discretion.

### **Rights and Use**

- I keep the copyright to all artwork I create.
- After full payment you receive a Personal Use License (non-commercial, non-transferable, perpetual). You can use the image as an avatar, share on social media (please keep my watermark visible or credit me as 'art by @psihihichka') and print for personal use.
- Commercial uses (selling prints, merchandise, game assets, Vtuber, etc.) require a paid commercial license. Prices start from +150% and are set case-by-case. Commercial rights must always be agreed in writing.
- You cannot: mint or use the work as an NFT, use my artwork to train AI, remove my signature, or claim the work as your own without permission.
- If you want the work kept private (not shown in my portfolio) or an attribution exemption, request this in writing.

### **Revisions and changes**

- The number of included revisions is set in the quote. Extra revisions will be charged (recommended: 2 sketch revisions included for headshots; thereafter 5–20% additional fee per extra revision).
- Big composition changes after approval may be considered a new commission.

# **Delivery**

- I deliver PNG/JPEG files at 300 DPI by default.
- I keep files for 3 months to resend on request. After that, a fee may apply.

#### Cancellations and refunds

- If you cancel before significant work is done, a partial refund of the deposit may be issued.
- The deposit is generally non-refundable once significant work has begun.
- If I cannot finish the commission, you will receive a full refund.
