The Latina Giving Circle of San Diego, founded in 2013, unites Latinas in a powerful act of collective giving to address the most pressing needs within the San Diego Latine community. We believe that by pooling our resources and talents, we can create transformative change and uplift the voices and leadership of Latinas as catalysts for change.

For the 2025 giving cycle, we will direct our support to San Diego County organizations serving immigrant populations. This collaborative approach allows us to make a greater impact than we could individually, fostering a stronger, more resilient, and empowered community, ensuring organizations that support immigrants have our collective support.

We count on the support of over 200 members and allies. The Latina Giving Circle is fiscally sponsored by the International Community Foundation.

From this <u>request for proposals</u>, Latina Giving Circle will award at least \$30,000 to organizations bridging the challenges in accessing systems and services for immigrant communities to thrive. Past grant sizes have ranged from \$5,000 - \$10,000. We invite groups of any size and experience to apply, however, preference will be given to organizations with Latinas in leadership positions (staff, volunteers, or board).

ELIGIBILITY CRITERIA

- This RFP is open solely to established 501(C)(3) organizations, or nonprofits that are fiscally sponsored by a 501(C)(3) organization
- Applications that are not complete will be deemed ineligible.
- Groups of all demographic composition are invited to apply, however, priority will be given to applications from organizations that have Latinas present in their board and leadership.
- We honor the privacy and safety concerns of our grant partners. Funded organizations will not be required to be publicly recognized.

WHAT WE DO NOT FUND

- Capital or endowment campaigns
- Political campaigns or religious campaigns. Religious organizations are welcome to apply for non-religious programs or campaigns.
- 501(c)(4)
- Fundraising events
- Individuals
- Scholarships for tuition
- Programs outside of San Diego County. Applicants may be located anywhere in California but programs must take place in San Diego County.

IMPORTANT DATES

- Grant application deadline is Sunday, June 15th. Applications submitted after the deadline will not be accepted.
- All applicants will be notified of the status of their application by early July.

HOW TO APPLY

Our goal is to make this application as accessible as possible.

- Complete the questions in the following form to the best of your ability. Bullet points are welcome. Language that has been developed for other applications and funders is also welcome; there is no need to remove any reference to other funders.
- The submission platform is through <u>our website</u> and saving of work is not possible. Please draft your application on a separate document and copy/paste your responses.
- Applications can be submitted <u>online</u> or in hard copy format. However, email applications are preferred. If you prefer a hardcopy application, please email <u>preguntas@latinagiving.org</u>. The application will need to be received at our fiscal sponsor's office, International Community Foundation at 2505 N Ave, National City, CA 91950, by the deadline.
