THIS AGREEMENT is effective as of {START_DATE} and will be automatically and will be continued silently after 15th of November of each year for one more year (the "**Support End Date**").

I. **BETWEEN** anDREa BV a company incorporated in The Netherlands with registered number 83360263 whose registered office is at Reinier Postlaan 4, 6525EX Nijmegen, The Netherlands (hereinafter referred to as "anDREa"):

II. Company_Name a company with registered number Company_Number } whose registered office is at Company_Address (hereinafter referred to as " Company_Reference");

Hereinafter collectively referred to as the "Parties" and individually to as the "Party".

A. WHEREAS

anDREa is a company that, among other things, provides 'software as a service'. anDREa enables customers to create and manage secure environments for the storage and processing of (privacy-sensitive) data that can be processed in collaboration with their own tooling;

B. the Parties agree to **RS_Name** to be a Local Research Support to **Company_Reference** for its use of anDREa's myDRE (hereinafter referred to as "**Scope**").

The following definitions are used in this Agreement:

"Research Support"

The person or people that support the usage of myDRE and meets <u>Appendix A: Research</u> Support as a Service Procedures

"Controller"

The natural or legal person, public authority, agency or other body which, alone or jointly with others, determines the purposes and means of the processing of personal data. GDPR Art 4.7.

"Processor"

A natural or legal person, public authority, agency or other body which processes personal data on behalf of the controller. GDPR Art 7.8

"Ticket System"

NOW IT IS HEREBY AGREED as follows:

1. Purpose of this Agreement

- 1.1. The purpose of this Agreement is to formalise that anDREa Research Support can act to be Local Research Support for **Company_Reference**.
- 1.2. The Agreement is an addendum to the agreement entered by Company_Reference and anDREa. Insofar as these documents contradict each other, the agreement entered shall prevail over the latter mentioned:
 - 1. The agreement including its sub agreements between **RS_Name** and anDREa on the use of myDRE;
 - 2. This Agreement;

3. Obligations of the Parties

- 3.1. In order to complete the tasks assigned to either Party, either Party undertakes to provide suitable professional resources and replace them if the other Party deems their performance to be unsatisfactory.
- 3.2. The expected obligations/activities are:
 - anDREa
 - Train and provide support to Company_Reference Research Support
 - Provide and include Company_Reference Research Support in Research Support setup (agent in the ticket system, access to the knowledge base, participate in Research Support meetings)
 - Company_Name
 - Mandates RS_Name to act on behalf of Company_Reference for Research Support responsibilities with respect to myDRE
 - Informs anDREa directly when RS_Name no longer can act as Research Support for Company_Reference
 - RS_Name
 - Will complete after training the <u>Research Support</u> <u>Training/Quiz</u> with the minimum required score
 - Will read, agree, and work in accordance with <u>Research</u> <u>Support Agreement</u>

5. Financial agreements

- 5.1. Company_Reference pays an DREa at cost the yearly ZoHo desk license fee for Enterprise
 - 2 full agents and one light agent is included in the myDRE licence
- 5.2. anDREa shall invoice the agreed on yearly basis the Research Support fee mentioned in 4.1
- 5.3. Company_Name pays within 30 calendar days after receipt of the invoice
- 5.4. Upon signing Company_Reference provides the purchasing order and other relevant payment details to finadmin@mydre.org. If changes occur in the purchasing order or payment details, {COMPANY} ensures that this will be communicated to **finadmin@andrea-cloud.com before the next invoicing moment**.



6. Termination

- 6.1. Except as is elsewhere expressly provided for, this Agreement shall terminate only on:
 - 6.1.1. termination of the agreement **Company_Reference** and anDREa have for the use of myDRE
 - 6.1.2. written instruction of **Company_Reference before 15th of November** per calendar year
 - 6.1.3. mutual and written approval of the Parties
 - 6.1.4. failure to agree on the essential terms of the Agreement;
 - 6.1.5. either Party committing a breach of this Agreement and not remedying that breach within 30 working days of receipt of written notice from the other thereof
