An Ulster County Judge was sent to Rensselaer County to further engage in judicial abuse by ordering jail time for a displaced mother in favor of a convicted sex offender.

May 25th, 2023, Rensselaer County, New York-On May 23rd, 2023, Ulster County ([problematic](#)) Judge Anthony McGinty, sentenced a displaced mother, outspoken critic and advocate for court reform, Alisha Clark Walker, to [jail](#) time in a divorce case, Walker v. Walker. This in favor of [Registered Sex Offender](#) father [Luke Walker](#) [who previously served jail time for drugging and sexually assaulting minors], and his paramour [Sara Miller-Hornick](#), a professional sex worker also in Rensselaer County, [AKA [Mistress Couple](#)]. The mother, with no criminal history, lost full custody of her children with limited and sparse supervision visitation in 2019 to the sex offender father because of her religious beliefs, [Walker v. Cholakis, 2019](#).

During the divorce trial, the Attorney for the Child, Douglas Broda, became physical towards the mother on the stand. Bias AFC Broda objected over 360 times in a multi day trial against the mother but not once objected to the father's testimony[[link](#)]. Judge McGinty did nothing to stop the abuse of process towards the mother but in fact encouraged the abusive sexual behavior by the father. Judge McGinty discredited the testimony of a court ordered supervisor (in the case) who testified that she was also sexually assaulted by Mr. Walker [[link](#)].

Additionally, Judge McGinty allowed the plaintiff husband in a theft and takeover scheme involving the family wedding business known as [Clark Walker Studio Inc.](#), secretly rebranded as [Walker Wedding Group LLC](#). Defendant mother [a stay at home mom to a 3 year old boy], is currently impoverished and unemployed, while the plaintiff father, a convicted sexual predator, living with a BDSM practitioner, is earning well over \$120,000 per year from the stolen family business. Judge Anthony McGinty did not cite one piece of evidence of the mothers in his final divorce decision and judgment, ultimately resulting in an incarnation order. Alisha is currently financially bankrupt due to the theft of the family business and is unable to pay over \$132,000 in court ordered costs by Judge Anthony McGinty. **Judge McGinty was not even voted into office of Rensselaer County yet ordered an abused mother to jail in retaliation for speaking out against sexual predators in the county without trial, representation or even proper service of the order.**

Ms. Leslie Silva, of [Tully Rinckey PLLC](#), represents Mr. Walker, and has waged a relentless 'scorched earth campaign' against the mother who had been the primary caretaker for the children, to be imprisoned. NYS Commission on Judicial Conduct ignores all complaints.
