#### JMA Dress Code

Scholars are required to dress appropriately for the school day and must adhere to the

#### guidelines outlined below:

## Offensive/suggestive writing:

o Per CMS Code of Conduct offensive or suggestive writing on clothing or jewelry is prohibited, which includes the advertising of alcohol, controlled substances, tobacco products, or promotion of violence.

## • Exposed undergarments:

- o Clothing should be worn with appropriate undergarments.
- o Undergarments may not be visible.

#### Shoes:

- o All scholars must wear appropriate shoes to school.
- o Slippers and bed shoes are not allowed.

#### Headgear

- o No headgear is to be worn inside the school building unless approved by the administration.
- o Headgear includes, but is not limited to **bonnets**, **bandanas**, **stocking caps**, **hats**, **towels**, **doo-rags**, **visors**, **hoodies**, and **combs**.

# • Clothing (shirts / pants / dresses):

- o Shorts, Spandex shorts, dresses, and skirts should be relaxed fingertip length (4-inch inseam minimum).
- o Pants that **expose skin** above the knee, cannot be worn unless leggings or shorts are worn underneath.
- Shirts / tops / dresses may not include low necklines, strapless, see-through, midriff, tied up, tube tops, racerback, muscle shirts, and tank tops.
- Students may not remove or unzip jackets to reveal any of the above types of garments.
