## RECORDED BIOGRAPHY:

CORR VYND, BORN IN THE COLD WINTERS OF MURMANSK HAS BEEN RAISED AS A "PRODIGY SOLDIER" WITHIN THE POST USSR LANDSCAPE, AS IS CUSTOM IN RUSSIA, HE TOOK CLASSES IN SCHOOL RELATED TO WEAPON ASSEMBLY, DISASSEMBLY, OPERATION, ETC. IN 6TH GRADE. HIS FATHER SERVED AS A CORPORAL WITHIN THE ARMY, LEADING TO CORR'S EVENTUAL INFATUATION WITH MILITARISM, AFTER MIDDLE SCHOOL HE ENROLLED IN A MILITARY SCHOOL, STARTING HIS CAREER. 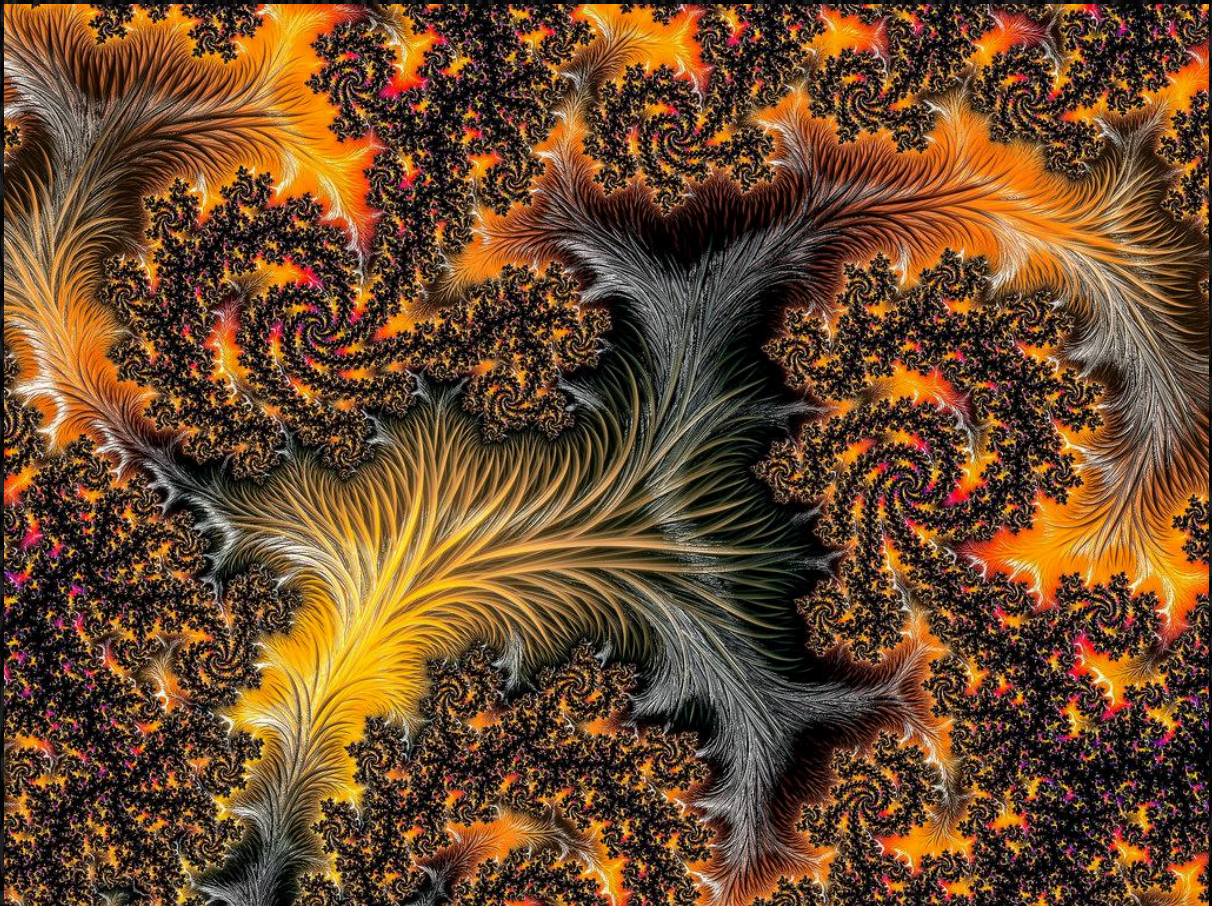

## UNREDACTED BIOGRAPHY:
