## NOTICE OF RACE

### 1. RULES:

- 1.1 The regatta will be governed by the Racing Rules of Sailing, the prescriptions of US SAILING, the ISSA Procedural Rules, this Notice of Race, and the Sailing Instructions.
- 1.2 In accordance with RRS 70.5(a), decisions of the protest committee are final. US SAILING's permission has been granted.
- 1.3 The Organizing Authority (OA) is Sharon High School in conjunction with the Massachusetts Bay League (MBL)

### 2. ELIGIBILITY:

- 2.1. The regatta is open to both NESSA and non-NESSA teams.
- 2.2. Article K, section 3 Qualification is in effect, as this is a qualifier for the ACC Regatta in November. Schools shall be eligible for NESSA Invitational Regattas in the following way.
  - 2.2.1. All NESSA teams must have paid NESSA dues.
  - 2.2.2. Each NESSA member school is entitled to one entry on a first come, first served basis until the regatta is filled.
  - 2.2.3. Non-NESSA teams (conglomerate teams or out of district school teams) are entitled to sign up when the registration opens for a NESSA Invitational Regatta. Entry in the said regatta will be granted to a Non-NESSA team after 10 days from when registration opens, only if space is available, at a first come first serve basis.

### 3. ENTRY AND COMMUNICATIONS:

- 3.1. Eligible schools wishing to register for this event may register by completing the Google docs form [LINKED HERE](#)
- 3.2. Sixteen berths are available.
- 3.3. Registration begins on Sept 5 at 1200 and ends on September 27 at 2359 or until the regatta is filled, whichever comes first.
- 3.4. Teams registering after all berths are filled will be added to a wait list.
- 3.5. Teams that have registered and are unable to compete must notify the regatta chairperson as soon as possible. Any withdrawal later than Thursday October 3 at 0900 hours will result in that team losing the right to register for any events hosted by Sharon High School for 1 year.

4. **ENTRY FEE:** The entry is **\$30 per team**, payable by check to "Friends of Sharon Sailing."

5. **BOATS:** Z420s
6. **SCHEDULE:**
  - 0900 Check in
  - 0915 Coaches' meeting
  - 0930 Competitors' meeting. First warning signal will be shortly thereafter.
  - 1600 No A Division race will be started after 1600Changes to the schedule will be posted on the official notice board.
7. **FORMAT:** A and B fleet racing.
8. **RACING AREA:** All races will be sailed in Lake Massapoag, off Memorial Beach.
9. **COURSES:** The Race Committee will determine the courses as prescribed in ISSA PR7.8.
10. **SCORING:** The regatta will be scored in accordance with ISSA Procedural Rules.
11. **COACHING:**
  - 11.1. Team leaders, chaperones, coaches, parents, advisors and other support personnel shall not go afloat in the sailing area unless they are part of the Race Committee team.
  - 11.2. A coach who is acting as a part of the Race Committee may coach their team between sets but not between races within a set.
  - 11.3. ISSA PR 8 defines other coaching limitations and obligations.
12. **PRIZES:** Prizes will be awarded to the schools finishing first through third. This regatta is a qualifier for the ACC regatta, as outlined on the NESSA website.
13. **RIGHTS TO USE NAME AND LIKENESS:** By participating in this event, competitors automatically grant to the Organizing Authority the right, in perpetuity, to make, use and show, at their discretion, any photography, audio and video recordings, and other reproductions of them made at the venue or on the water from the time of their arrival at the venue, until their final departure, without compensation.
14. **WAIVER OF LIABILITY:** Sailing is an activity that has an inherent risk of damage and injury. Competitors in this event are participating entirely at their own risk. See RRS 4, Decision to Race. The race organizers (organizing authority, race committee, protest committee, host club, sponsors, or any other organization or official) will not be responsible for damage to any boat or other property or the injury to any competitor, including death, sustained as a result of participation in this event. By participating in this event, each competitor agrees to release the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.
