Jody also shared the revenue sources and the revenue received by tuition. Jody explained the programs that are open to the public for use such as automotive, culinary catering etc.

PE Staff Presentation – Tom Costello, Bret Halverson, Pam Quinn, Sarah Gallagher Presentation on the PE classes at Twinfield School. Went over the National Standards, the challenges in PE (class times, different abilities etc.). High School PE focuses on individual activities that they can do throughout life such as golf, tennis, biking etc. Went over the activities that students participate in. Nordic Rocks – brings supplies to schools. Lenny's Program – local donor has created a fund at Lenny's for students that need shoes. Went over the family nights that happen throughout the year. Discussed the importance of the trail and bike systems that the students utilize.

FY26 Budget – Michael Concessi was present to highlight some items.

Only one change from the previous budget provided. Added summer program for \$104k. Michael went over the drivers again. Michael went over the LTW ADM per pupil amount and the importance of being under the penalty if possible. Twinfield LTW ADM is under the penalty trigger. Michael showed the residential tax rates for FY26 – within line from last year. Michael answered any questions that the board

had regarding certain figures in the budget. Question on where transportation is at. Currently going to use the electric bus for the season to see how it goes. The board will work to get out information to the community to get any feedback and answer questions.
