

Prayerfully, these mentoring sessions and meetings will be as beneficial and as smooth as possible. To make it easier for all parties to do this, **this packet has been created**.

You and your Spouse's role is to *follow the steps* laid out in this packet, *watch the videos* that are assigned, and *SOAK IN* as much as you can from your mentors.

Logistics:

The structure of Marital Mentoring is:

• 6 sessions, each one being 60 to 90 mins. Those sessions are 1) Getting to Know Each Other, 2) Foundations, 3) Communications, 4) Finances, 5) Decision Making, and 6) Intimacy.

The basic rhythm of Marital Mentoring is that **before** each meeting you will have steps, ie. "homework", to do. Those steps are laid out in this packet, which consist of: completing evaluations, sending evaluations, watching videos assigned, filling out corresponding sheets in this packet, and bringing prepared questions when you meet together on your decided days and times.

What to Expect

This first meeting will be all about getting to know each other. This time ought to be laid back, full of questions, sharing, and intentional.

As the goal is to become acquainted with your mentoring couple, try and think through some things you want to know about them. Things like:

- How did they come to know the Lord?
- When did they meet? How has marriage been for them?
- Where do they work and why?

Don't be anxious though, your mentor will be mentoring you after all so they will have things to ask you and be leading the conversations. Remember that any mentoring relationships are **two-way relationships**.

Pressing In

Allow time and vulnerability to share the reasons why you and your spouse are seeking Marital Mentoring.

As your mentors ask you questions concerning the issues, remember that they are compassionately trying to help you. Throughout this process, seek to assume the best of everyone involved.

Steps Before Next Meeting

Complete **instruction steps** on the previous page. And above all pray.

Final Exhortation

What you will get out of this *will be* what you put into it. You have the amazing opportunity to be in an extended relationship with a married couple that has been pursuing each other and Christ through many seasons. There is much wisdom found in those years that you can glean from for "Where there is no guidance, a people falls, but in an abundance of counselors there is safety" (Proverbs 11:14).

Be intentional with your times together. This couple, God willing, will be a part of your life for much longer than these 6 meetings.
