- Leave your colleague as the first author on the proposal since he wrote up the ideas
- Remove your colleague from the proposal team, and offer the competition the position if they allow for their idea to be used
- 4. Ask the competitor to join the grant team, placing them as the third author on the proposal if they allow for their idea to be used

- 5. Acknowledge the competitor in the grant proposal because the ideas were there originally
- 6. Apologise to the competitor and indicate that the proposal must go out as is to meet the deadline
- 7. Remove competitor's ideas from the proposal and try to rework it before the deadline

The immediate action is to stop the unethical feature immediately and disclose the issue to both the client and relevant stakeholders, ensuring that user privacy is protected and that the platform complies with legal and ethical standards.

You enter their office to turn it off and find that they are still connected to his email. You scan the messages briefly, noticing whom they are from and what the topics are. The failure of this project could destroy your company if the corruption were to ever surface. You are part of the project steering committee. What do you do next?

I do not continue reading or use the information I accessed inappropriately.

To avoid harm and damage the company will receive I will then report the issue anonymously through the company's whistleblower forum, if available, focusing on the project award concern without disclosing how I learned of it.

Alternatively, raise concerns about the project manager's lack of experience through proper, formal channels available to the steering committee without

referencing the private email.
