# TRIGGER WARNING: SUICIDE ATTEMPT, PSYCHOLOGICAL ABUSE, DOXING, GASLIGHTING

Over the past two months Twitch Streamer, and VTuber **Adora\_Bunny** has engaged in what appears to be a campaign of active slander and harassment against her former friend, fellow Twitch Streamer, and VTuber **RADIAACTIVE**, for reasons that are known only to Adora and change with each telling.

This campaign has been largely kept from public view and has relied almost entirely on the spread of malicious and fictitious rumours, veiled threats, and whispers in people's ears; specifically larger, more influential members of the Twitch & VTubing community in what appears to be an attempt to end the streaming career of RADIAACTIVE.

The end result of this has been immense damage to Radia's mental health, personal relationships, career, financial situation, and the near loss of her life.

Radia is not the only person who has suffered at the hands of this kind of attack by Adora, but in the interest of not speaking for others, this document will focus primarily on Radia.

This document has been compiled in an attempt to bring Adora's behavior into the public light. For the sake of privacy it will only cover events relating to Radia, and contains testimonies, screenshots, and receipts of not only Adora's behavior, but of the consequences her actions have had on others in specifics to the two months of hell that she has put Radia through, which almost ended in the most tragic of circumstances.

This has been an exceedingly difficult time for all of us and, if anything, we hope that Adora will finally realize the kind of person she has become and take steps to improve herself.

#### **Foreword - Color Key Notes**

Before continuing, I would like to explicitly note and openly state that this document was written with the aid and support of both DigitalVagrant and LazerPig, whom, without their aid, I would never have been able to, on my lonesome, do everything required to create a comprehensive document of just MY situation. Statements written with only my voice are colored in deep blue, while anything solely from LazerPig is in light green; the rest of the document is in black and is a collaborative work. I extend my deepest apologies for possibly an unconventional approach to a 'Google Doc,' but I have delayed or cancelled multiple appointments the past two and a half months due to the burdens this situation has placed upon me, and this negligence has deteriorated my health further in addition to the undue stress placed upon me. My day job comes first, even before my health, as it is what ultimately provides me access to my required healthcare. I cannot risk ANY decline in performance during a critical time of year in the industry, this along with my own attempt on my life rendered me unable to pursue the creation of this document in isolation.

I thank you for your understanding as I offer full transparency this document was not made solely on my own nor was even conceived until after the events of my attempted suicide.

# **Initial Summary**

### **Accusations**

As this document is extensive and many may not have the time to digest it in its entirety, below will provide a brief summarization of Adora's actions and the effects they had on Radia:

#### Adora's Actions:

- Casually doxxing Radia's name, background, and personal information to multiple uninvolved third parties in pursuit of her slander campaign.
- Authored the creation of a list of grievances, what could be referred to as a 'cancel doc',
  which was both overexaggerated and completely imagined/falsified, which she
  forwarded to outside parties as "truth" after doctoring them to remove anything related to
  herself.
- Arranged for an "intervention" under false pretenses, which was a poorly-disguised cover to ambush Radia in a format she could not escape from and designed to maximize humiliation and mental anguish
- <u>Demanding Radia take a forced break from streaming for an intentionally vague</u> amount of time under threat of being thrown out of Project STIM
- Used incredibly flimsy justifications to "prove" Radia wasn't sorry as justification to force Radia out of Project STIM
- Engaged in deceptive and manipulative language to place all of the blame for the invented wrongdoings solely on Radia, while engaging in deliberate deception that she was doing this out of concern for Radia's well-being

- Engaged in a sustained campaign of slander across the content sphere to countless content creators, both mutual friends and an unknown number of uninvolved parties, attempting to paint Radia as manipulative, greedy, "content-rotted", and a compulsive liar that had falsified her entire history for malicious ends
- Attempted and succeeded in isolating Radia from her entire social sphere and support network for the sake of making her "learn her lesson" for perceived slights and imaginary wrongdoings
- Accused Radia of falsifying her medical history for personal gain
- Accused Radia of falsifying her education and career for personal gain
- Accused Radia of "money hoarding"
- Digging into Radia's personal background through all available public resources and using it to build a false narrative of Radia's "dishonesty"
- Attempted sabotage of Radia's romantic relationship as part of the slander campaign, attempting to provide her partner with a heavily editorialized and abusive account of events when Radia was unable to speak up for her own defense
- Twisting her version of what transpired based on who she was speaking to based on what she believed would be most sympathetically received, ensuring no person ever received the same story as another
- Active denial of these actions and attempting to play the victim when third parties began to investigate outside of her ability to control them or threaten them

### Radia's Injuries:

- Suffered immense psychological anguish and agony as her social network was forcibly ripped away from her
- Was reduced to tears and begging apologies for things she did not do in an attempt to keep friendships she valued and placate someone she believed was her best friend
- Needed to be hospitalized 4 days after the initial onset due to heart palpitations
- Extreme stress due to attempts to be private and "professional" about the matter due to not wanting to "bother" others
- Had personal identifying information leaked to outside, uninvolved parties by someone she previously trusted/espoused as a "sister"
- Suffered isolation from her friends and loved ones due to slander and rumormongering
- Considered on multiple occasions leaving content entirely to appease Adora and defuse the situation
- Delay in her ability to re-enter education plans due to the situation, resulting in an irreversible loss of significant amounts of financial aid
- Loss of her roommate, who Radia considers to be family; the sudden drop in her mental health and sharp drop in income left her unable to support their college plans
- Severe decline in income due to a combination of the slander campaign and the sharp decline in her mental health inhibiting her ability to stream

- Ongoing fear and trauma from believing nobody would believe her if she told her side of the story
- Harassment of people who even spoke to her at a convention, leading to further isolation
- Nearly-successful suicide attempt due to extreme isolation and a genuine belief that there was no other way out

# **Reasons for Putting Out a Document**

Prior to the creation of this document, Adora was granted every courtesy possible. She has been made fully aware of the damage she has caused and of the potential repercussions this would create. She was spoken to by a number of different individuals, attempting to discourage her from her actions, including Radia herself.

She has been granted every opportunity to speak, to explain herself, to reverse her decisions and to go on with her life unharmed with no consequences, and nothing made public.

This culminated in a final call last week, with a neutral third party observer, between Radia and Adora to attempt to find some way to right the wrongs done with as minimal public damage to careers as possible.

She made the decision, each time this was offered, to double down on her behaviour towards Radia. She has further now begun to deny any of her actions.

This document is a last resort, as she refuses to take any kind of accountability, nor is she willing to admit to any sort of fault.

Furthermore, the act of compiling this document has made it evident that this is not a one-off vendetta, it is a pattern of abusive behavior that has continued for years, across multiple people.

Many of the people spoken to during this process indicated a genuine *fear* of Adora, and a desire to remain anonymous or be left out due to fear of becoming her next target.

It was concluded it would therefore be irresponsible not to make this information public, regardless of the personal stress, as to remain silent would ensure that this continued to happen.

### **Documentation Notes:**

While significant time and effort has been made to document what has occurred and produce as much corroborating evidence as possible, there are specific limitations where information is not able to be listed:

- VODs that have expired due to the length of time it took this situation to progress to this
  point, as a document of this nature was not considered until nearly two months had
  passed
- Names/Statements that have been left out due to fear of retaliation from Adora
- Names/Statements that have been left out due to fear of retaliation from Social Media
- Names that have been left out due to unrelated professional obligations and concerns
- Testimonies that could not be included due to time constraints on the part of those giving them

It must be noted that significant amounts of Adora's actions were done over VCs and without warning, likely deliberately. During the compilation of this document, there was a noticeable shift in the amount of DMs sent versus things spoken over VCs, likely as Adora sensed that she was leaving an incriminating paper trail.

This document is solely aimed at addressing Adora's actions; all other mentioned parties should be assumed to be innocent or misinformed.

## **Discussion Notes:**

While it would be irresponsible to speculate on the reasoning and psychology behind Adora's actions, this document will at times include discussion and analysis of the language used in particular pieces of evidence, to highlight **the specific language and tactics of abuse**. This is necessary to give readers who may not be familiar with them context, as these actions are using subtle and corrosive rather than overt, used to wear down someone's self esteem over time until they can be isolated and controlled. For readability (and due to them all coming from the same author), these sections will be marked in GREEN.

# **Additional Victims:**

During the course of assembling this document, we have been able to identify at least one other victim of Adora's abuse. There are likely more we have been unable to identify.

As this document only has the authority to address the actions taken against Radia, we will not be discussing the abuse visited upon other individuals; however, at minimum there are credible allegations of:

- Additional Doxing
- Financial Abuse
- False Accusations
- Slander
- Social Ostracization
- Emotional Abuse

# **Ousting From Project STIM**

# **Synopsis**

For those with limited time, below are listed bullet points of what occurred during this phase of Adora's campaign:


- Luring Radia into a poorly-planned 3v1 "intervention"/interrogation where she was accused of being ungrateful, a compulsive liar, a content thief, and having falsified her medical conditions for "monetary gain"
- Radia was sent into a days-long emotional breakdown, during which Adora dictated a dishonest version of events to both her friends and family
- Adora doctored a document that purported to represent the facts of the event to remove most references to herself
- Adora extensively attempted to drive a wedge in Radia's relationship with her partner through extensive disinformation provided when he was in an emotionally compromised state
- Radia was forced to leave Project STIM after an unrelated comment on her own stream (which was being monitored) was used as proof of her "lack of regret"

## **Initial Confrontation**

Adora's actions began after Anime North; Radia was completely unaware that anything was wrong, and believed the trip had been a huge success and was immensely happy at getting to spend time with her friends.

Without her knowledge, Adora had involved FenariMori and PomatoMaster, the other two members of Project Stim, to begin compiling a list of specific incidents where Radia said things they considered insensitive or hurtful, or had not been fully honest with her about her personal details. While all three members were involved in this, it is unlikely the other two members were aware of the extent of Adora's intentions regarding this.

Rather than address these things one on one or calmly, Radia was then lured into a voice call in the Project Stim server under the guise of an "emergency meeting" on May 27th, 2025. Upon entering this call, what transpired was an incredibly poorly-conceived "intervention" that operated more as an interrogation, as perceived lies were fired off at Radia and receipts demanded as they went down the list, infraction by infraction.



While no recording of this call exists, third party sources have confirmed that they had involved parties outside of Project STIM from the beginning of this, and had already begun slandering Radia's reputation to others. They were also advised that such a format was a poor idea, and went forward with it regardless.

The end result was Radia being forced to stand, humiliated, and in near tears, outside in her gym's parking lot as she was raked over the coals for things she had no idea were bothering others. These accusations included compulsive lying, a lack of gratitude, actions that were "bad optics" for the group, and an emotional appeal for Radia to "take a break".

By the time this conversation had ended Radia was so hysterical she could say nothing in her own defense and had fully capitulated to the narrative as it was presented to her. It took several days before she was calm enough to explain her side of the story; up until this time, Radia's partner, friends, and family received no information regarding what had occurred outside of the narrative being communicated by Adora.

A third party has confirmed that by this point, all three members of Project STIM had privately recognized that the intervention had been a poor choice. No admission of this was ever made.


## **Post-Confrontation**


There isn't a way to prove anything is improving if I'm not supposed to exist in any capacity around the space. It's not as if you all exist around me physically.



# No apology or even check-in was ever received from any of the other members regarding this, though they were made aware of it.

### Screenshots Analysis

It should be observed Adora uses a type of language called "coercive control", something common in abusive relationships; those who have come from abusive households, be that an ex-partner or your own parents, may find the language used familiar.

Coercive control tactics can be extremely subtle, and may not be apparent to the people around the victim or indeed the victim themselves.

#### Examples of Coercive control include:

- Strict and restricting routines
- Extreme and often unfounded jealousy
- Accusations and threats
- A cycle of physical, sexual, or financial abuse, or a combination of all these.
- Gaslighting
- Isolation from loved ones and work colleagues by creating rifts

#### Examples of the things an abuser might say include:

- "You make me feel bad."
- "No-one can trust you now."
- "You are hurting us with your actions."
- "You make me have to be mean."
- "Everyone hates you for this."
- "I am doing this for your own good."
- "I truly love you, but you need to change."

In short, the abuser will attempt to control a narrative around the victim presented to both the abused and to the audience, that the abuse they receive is somehow entirely their fault, and that the abuser is being forced to act because of it. In many cases when this abuse is challenged or acknowledged as abuse, the abuser will often be quick to play the victim, assured that everyone is "ganging up on them" when they were just trying to do what was right.

Their goal will be to create confusion, isolation, and diminish the victim's sense of self. By subjecting their target to verbal abuse, perpetrators begin to hold control over their victim's life, instilling a sense of hopelessness and sometimes fear into them while also taking away their independence.


It is important to note the significant focus Adora placed on Radia stepping away from streaming and the internet entirely for a time. She returns to that point again and again, reminding Radia on a daily basis of her ostracization.

## **Post-Intervention Escalation**

Up until this point, this appeared to be something that, although handled incredibly poorly, there was room for this to be resolved. Adora outwardly appeared willing to reconcile, Radia was actively attempting to apologize for whatever hurt feelings her actions had caused.

It is during the time period of May 30th - 31st that a noticeable shift began. During this time, Radia was finally able to open up regarding what had taken place during the initial confrontation. It is at this point the narrative that had been fed to outside parties began unraveling.

The primary source for the discovery of these discrepancies, outside of Radia's own words, was a document that had been forwarded to DigitalVagrant, Radia's partner, on May 29th, two days after the initial confrontation. It was represented as "bullet points" of what had been gone over during the call, as well as a summary of what Radia had done to justify the call in the first place.



This document had been altered. Adora had edited it significantly to remove almost every point which mentioned herself before sending it, without the knowledge of anyone else involved.

The full version of this list, minus redactions of personal information, can be found <u>below</u>. To summarize, this list turned out to be full of extremely minor slights, or highly inaccurate/outright false assumptions regarding Radia's personal details. Below is a list of their main points, along with an analysis of the framing that was used in this document.

#### Main Issue #1

#### Main Issue 1:

Saturday Night Stream

This section revolved around the alleged "hiding" of a late-night Saturday night stream done by Radia's partner, DigitalVagrant, while she was away. Radia was also accused of "faking food poisoning" and "playing up her illness for money", with a variety of poorly-constructed "evidence" and a complete lack of understanding of medical issues.

### **Screenshot Analysis**

The problems in this opening should be obvious as you read it below. Accusations are made without context and supported with no evidence, even anecdotal; several of them contradict each other, and others are provided with so little context it is hard to understand exactly what they mean.

It is simply assumed Radia is lying about her health, and the fact she was able to run a stream in which a lot of gift subs were given out is offered as a connection in spite of the fact Radia will frequently run streams which generate gifted subscriptions and hype trains, i.e money. In the same manner one could make the accusation that Radia uses her cat to garner money from her supporters.

The type of "Health problem" also changes three times; at first it is unspecified, then it jumps to food poisoning, and then to mental health.

It also accuses Radia of "massively over-emphasising" a health problem for money, but also keeping it a secret. This is a complete contradiction.

Radia is entitled to her privacy and has made it clear on numerous occasions she does not like discussing her health issues and will often refer to her health issues as "Hot Girl Tummy Troubles". Other members of project STIM also do this, including Adora and other VTubers within that same sphere of influence.

The other highlighted issues seem to focus on Radia's consumption of dairy products with the presumed assumption that Radia is lying about being lactose intolerant.

Lactose intolerance is not an uncommon issue; there are pills which contain enzymes which, if taken daily, allow someone with a lactose intolerance to consume dairy products. Radia had

these pills on her person along with her other necessary mealtime meds and has been vocal about taking these pills. Adora would know she was taking them.

All of these are small, nitpicky items that could have been resolved in a 15 minute conversation with Radia over coffee. None of this is grounds for an intervention.

The final conclusion is a good example of the kind of abusive language highlighted earlier: punishment is framed as not only a result of Radia's actions, but also a favour to prevent the situation getting worse. It is a classic "I'm doing this for your own good" argument and leans heavily on isolating Radia from outside sources: "If this got out it would look incredibly poorly on you", with the burden of proof placed heavily on Radia to prove she is not lying in spite of the utter lack of evidence to even suggest she is.

This is a tactic used to force a mind into a submissive position; the feeling one gets when faced with this sort of language is a sense of hopelessness, and if you lack defenses against this sort of thing then the mind cannot help but do everything it can to prove innocence. The victim will seek to please the abuser; while glossing over the technical details such as the criticisms of eating, drinking, and monetary habits, the abused might feel the subconscious need to complain less, eat less, and either be less extravagant with funds or be more willing to share funds to prove there are no issues.

#### Main Issue #2

#### Main Issue 2:

General lack of gratitude

This section features a number of alleged comments made by Radia that were either interpreted as malicious or actively misconstrued as Radia displaying a "lack of gratitude", painting her as unappreciative for the support received and for her friends in general. It also featured accusations that Radia, as she made more money than others, had no right to complain or express anxiety about monetary issues around others who had less.

There is a lot to unpack in this section, but the one factor you should be primarily aware of is that Adora has been to Radia's house where her monthly budget is stapled to the fridge. Adora is fully aware of Radia's living expenses including mortgage and medical bills. Prior to this incident Radia looked upon Adora as a sister and confided in her a serious amount of personal information which included her monthly incomes and outgoings.

Again you'll note the constant use of "this is good for you" followed by "You didn't say thank you enough"; this is again the language of the abuser, in particular one with narcissistic tendencies.

It is a very common tactic to use this sort of language after the abused has had a good day, in order to pull them back down in what is called the rollercoaster effect, large highs followed by immediate downs. This keeps the mind in a permanent submissive state and the feeling that the high was undeserved or wasted because of their attitude, that others were constantly – or are constantly – judging their actions and behaviors.

All of these accusations are, again, minor nitpicks; You see a repeat of the \$50 hotel suite argument and I will not insult the intelligence of the reader by explaining why someone may have concerns over spending thousands of dollars for flights, hotels, convention materials, and restaurants but might find a \$50 hotel room upgrade good value and potentially worth it. These are simply methods of degrading Radia's mental state and making her feel guilty for receiving and spending money.

You'll note, back in the first issue, Adora tells Radia to "take a break" which is combined with a vague threat. This at this point has become a theme; the themes of money, revenue generated from Twitch viewers, and the need for Radia to "take a break from Streaming or else..." have been very common and allude to the greater purpose behind this document.

#### Main Issue #3

Main Issue #3: Copying of content

# This section, while incredibly short, alleges that Radia copied the content of those around her.

This final issue is short and lacks substance. Again these are fictitious claims with no real evidence as they attempt to allude to a greater problem without having to mention it nor provide evidence it is happening.

The few things mentioned, such as the elevator skit, is something Adora worked with Radia to replicate on her own channel. Aforementioned Youtuber LazerPig (me) claimed Adora even offered to show him how it worked if he wanted to replicate it for his own streams.

The TL;DR at the end is of more interest, again the repetition that Radia is at fault and the need to "take a break or else" is repeated. Accusations are sandwiched after compliments, again a repetition of the "rollercoaster" tactic.

The document cuts off abruptly mid-sentence here, likely due to Adora's altering of the document.

Confronted with the disparity between Radia's account of events and the list's allegations, combined with the stark contrast between how the initial confrontation had been portrayed and how it actually occurred, it is at this point Adora began to receive pushback from DigitalVagrant.

His account of events follows.

### DigitalVagrant's Account

I want to preface this statement by pointing out that at first, I had no reason to disbelieve Adora's sincerity or honesty. She had proclaimed constantly that she saw Radia as a "sister" and genuinely believed that she was approaching me from an honest place.


Further, though I do not wish to indulge in the details, I am a former abuse victim of extremely similar tactics to what was used in this situation; I am extremely susceptible to tactics like this, and have spent significant amounts of time in therapy, including during the time of this document, attempting to improve this.

I was messaged by FenariMori as I came out of a therapy session in the early morning of Tuesday, May 27th. Fen's statements were mostly benign warnings that Radia's mental state would likely be fragile, but made specific mention of many of the accusations mentioned in the list while providing no evidence. It was at this point that Fen dropped out of contact due to falling ill; this was the last information I would receive for two days. I had received no warning that any of this would occur, and had suddenly had a nuclear warhead dropped directly into my lap.

The next 48 hours were abject hell. I was effectively paralyzed; unable to do my day job effectively, barely sleeping, head feeling like it was full of static as it appeared my life was disintegrating before my eyes. My partner was in a state of near-complete hysteria; it took all of my energy to keep her from making incredibly rash decisions (including abruptly departing from the content space with no plan for making up the financial gap) while also attempting to get her to speak to me about what had happened. From what I could tell, her shame and humiliation was so overwhelming she couldn't speak to me about it; she just continued to blame herself

while trying to figure out how to properly "atone", incredibly focused on attempting to save her friendships.

It was on May 29th that Adora chose to reach out to me; she appeared sympathetic, and I was so emotionally exhausted from the events of the prior days (my car had also been rear-ended during this), that I did not question at first what she was saying, even when she provided me the aforementioned list of accusations.



What later initially struck me as odd once I came out of my emotional shell-shock was that Adora had slipped in accusations that made no sense in hindsight, and had not been listed on the document. Some seemed utterly misinformed, and even abjectly cruel.

(Note: Adora has been long aware that Radia has chronic medical issues of a severe nature, even if she has not been privy to the full details. There was no basis to make the below

It was not until Radia began speaking, with the assistance of her roommate, that I began to get suspicious and actually start to think critically again. Once I was informed of the nature of the "meeting" and inconsistencies began to show, I was incredibly unhappy with what I was hearing, and decided to follow through on recent therapy efforts to cease being conflict avoidant and express when I am upset rather than bottling it up.

I requested a phone call with Adora and Pom in order to hopefully express my displeasure with the way in which Radia had been spoken to and the destruction of both her week, my week, and the week of her roommate with no warning. Screenshot excerpts of my request for this are listed below.





An important point to note: it was only after considerable time had passed that I discovered even that last point was a lie. Adora had already begun to involve third parties by this point, and there was even a non-Project STIM third party individual in the calls where they planned their "intervention". But at this point I still had hope that Adora was operating in good faith, albeit

horribly misguided in how they communicated and perhaps reluctant to admit it. I did not expect what came next.

This call was unproductive; I was met with defensive hostility immediately from the get-go to the point that I nearly retreated from the call entirely. Adora refused any request to apologize and only repeated justifications and excuses for the actions taken. I left the call frustrated and dissatisfied, both with the logic presented to me and the way in which I was spoken to, which was full of straw men arguments and attempts to dodge any kind of accountability. I was not spoken to like a third party they felt guilty about involving, but a nosy trespasser they wanted to force to back down. I later found out from a mutual friend that Adora flippantly referred to me as "doing a misogyny" because I objected to the aggressive tone right out of the gate, as well as dismissing me as "biased" when the only points I raised were that a lot of their actions seemed extreme, as well as expressing a displeasure for this being sprung on me with zero warning. I explained multiple times this was an attempt on my part to enforce my boundaries, which I have been in therapy for months about due to my tendency towards conflict avoidance. This apparently had no effect on their opinions.



It was at this point I ceased all communication with Adora, Pom, and Fenari. The level of defensive irritation and attempted minimizing of my concerns was upsetting, and only intensified my feelings that something was not right. While my direct involvement with any dialogue ended at this point, switching solely to assisting Radia, I did bear witness to the extent of that cruelty that came next.

While I understand that my account of things will inherently be considered biased due to my status as her partner, I want to emphasize anyways that Radia, up until she realized what was being done to her, fully attempted to appease Adora and any aggrieved parties as much as possible, and heavily heaped blame on herself even in cases where the accusations were not

true or were heavily misrepresented in hopes of saving her friendships. This went as far as Radia heavily considering just leaving content entirely multiple times, with zero financial preparation of any kind, in hopes that it would assuage the anger and cause the least amount of problems for everyone involved. This remained her main priority up until it became obvious that was no longer possible, and even after that she attempted to separate quietly and professionally because she did not want to "cause trouble". I will not be posting any screenshots of the conversations we had during these moments; they are both deeply personal and gut-wrenching in the despair on display.

Radia is incredibly conflict-avoidant, even more so than I am; it is a particular sticking point in our relationship that we have sought counseling on, as neither of us wish to "bother" or "take advantage" of the other, even when our problems are near-overwhelming and deserving of help. To say that she was attempting to cause trouble on purpose defies sanity.

It was at this point that another party's involvement began: Lazerpig, a mutual friend of all three parties who had received spillover awareness of the ongoing issues when DigitalVagrant had reached out for understanding and support in the wake of the initial confrontation. Lazerpig decided to act as a neutral third party, not attempting to get directly involved (he did not directly contact Adora or Radia until after this portion). However, it is important to document that he had been tangentially involved at this point.

# **Project STIM Ejection**

It is at this point that almost all productive conversation broke down between Adora and Radia. The flashpoint for this took place on June 4th, during a stream in which Radia was speaking to a fellow content creator and offhandedly mentioned that many relationships in the VTuber space are extremely transactional and how off-putting it could be. This extremely general, non-specific comment was taken as being directed at her Project STIM compatriots, who were apparently monitoring her VODs. This was used as "proof" that Radia was not actually sorry.

The knock-on effects of this perceived slight were as follows:

Attempts by Radia to arrange a follow-up meeting to continue to hash things out were
delayed and put off for an additional week. Radia was not immediately told of their new
point of anger, which was later revealed to Radia on June 11th to be from a stream held
earlier in June in which Radia said, "Some people view friendships as transactional"
while speaking with another uninvolved content creator on content creation in general.
None of the Project STIM members were mentioned at any point, including Adora.

Note: This VOD was able to be preserved as it still was able to be downloaded after the attempt to end Radia's life on July 12th. This VOD has been uploaded to a Google Drive to preserve it.

- When this second conversation finally occurred on June 11th, Radia, now entirely broken and feeling completely alone, desperately tried to appeal to Adora and offer an apology for whatever Adora dictated was the problem in the hopes of continuing to salvage the situation. At the same time, she attempted to hold her ground on the point that the way she had been spoken to was unacceptable and caused her and those close to her grievous harm.
- These apologies were refused and focus remained on how Radia had "hurt them"; something that continued to be more and more ill-defined the longer the situation continued. Radia then agreed to leave Project STIM on Adora's instruction, though she would refuse Adora's demands to claim it was "due to mental health issues" out of fear that it would publicly mark her as an unstable individual and further isolate her.

It was at this point that Radia hoped that, in the absence of being able to salvage her friendships, at least the situation was over and she could return to streaming without much incident.

# **Ongoing Slander/Harassment Campaign**

# **Synopsis**

For those with limited time, below are listed bullet points of what occurred during this phase of Adora's campaign:

- Combing through Radia's personal information and professional social media presence searching for "evidence" that she could use to accuse Radia of falsifying her career and education backgrounds
- <u>Casually doxing Radia's real name</u> and <u>personal information</u> that Adora discovered to completely unrelated third parties
- Actively spread a disinformation narrative to a still-unknown number of uninvolved parties in an attempt to freeze Radia out of as much of her social and support networks as possible
- Publicly disparaged Radia, both personally and through an additional content creator, upon Radia attempting to privately announce to her community about her cessation of content with Adora

- Worked to continue Radia's isolation at the Offkai convention and other various social events
- Inspired implied threats against uninvolved third-parties seen speaking to Radia during the Offkai convention
- Due to extreme isolation and an overwhelming sense of hopelessness regarding the situation, Radia attempted suicide, an act that was only narrowly averted

### **Doxing of Personal Information**

It would later become increasingly apparent that the situation had never been either private nor in good faith. Over the next month, more and more information came to light regarding Adora's subterfuge nearly from the beginning of the situation, which only intensified as time went on.

Despite Radia's attempts to resolve this issue quietly and privately, Adora has continuously and consistently attempted to discredit Radia's name to everyone she could contact. This was not limited to people directly involved with Project STIM or close friends; but was spread to a still-unknown number of people, several of whom were contacted before the initial confrontation had even happened; These are the "whispers in people's ears" mentioned in the introduction to this document.

These 'whispers' ranged from vague warnings about something "potentially coming" that Adora would "try to keep them out of", to full blown tales about Radia's purported bad behavior and untrustworthiness. This also included her roommate, anyone she had recently collabed with, and an unknown number of others.

The clear goal at play was isolation; This unfortunately, to a point, worked. Radia began to isolate herself both emotionally and physically in fear of the whispers that now arrived thick and fast at her door, including from those she loved or believed she trusted.

It had the secondary, and likely intended, effect that this would also break Radia's confidence. She began to stream less and felt she was not 'worthy' of the attention and good will she received from her community, she described herself as "running on 5%" and did not believe her streams were up to par.

She would grow fearful of spending money on herself and would often forgo eating. She became more drawn into herself, quiet, difficult to talk to, and would even attempt to end things with her partner because "she wasn't worth it."

At this point, the lion's share of evidence comes from testimonials from other parties who came forward over time to provide evidence of Adora's lies. As communications between Adora and Radia had halted, and Adora (presumably due to becoming aware that she was leaving an

extensive paper trail) moved most of her communication into VCs, our picture of the extent of this slander is likely incomplete. We have no way of determining how many people this reached, but we have confirmation from independent, uninvolved third parties that this reached at least one content creator with a multi-thousand viewer count, as well as a representative of a corporate entity.

Below is a compendium of relevant testimonials during this time period, which lasted from mid-June until present day.

#### Lazerpig's Statement

So I never really wanted to be part of this, Radia and Adora were two very close friends of mine so I kinda had my "head out the window" so to speak. I wasn't paying attention, didn't care, better stuff to attend to than hot girl VTuber drama. Yeah ok I heard things on the grapevine, Digi reached out to me a few times and I was a little suspicious of things and said I'd maybe talk to Adora or Radia but I was half way into the video editing hole and basically had my head up my ass, what I said one day I'd forgotten the next.

Then Radia goes into the hospital and suddenly I have my best friend crying over a voice call worried that he is going to lose his girlfriend over this and *that*'s when I started paying closer attention to what was going on.

Adora is someone I had always trusted, she was a friend, she helped me out with my OBS problems, showed me how to run streams and I helped her get a leg up on Youtube, we were always there for each other. I was on her streams a lot and I was always happy to promote her to my audience because I genuinely felt she had talent and her streams were excellent. She was a person I once described as "if I were straight" *that* is how close we were, so none of this makes any fucking sense.

So I talk to her and obviously she's confused and upset and she cries a little but she assures me nothing is going on.

So I ask her for the truth, I wanna hear her side of the story and that's where things start getting a little odd. Suddenly the tears stop, suddenly her voice goes a little flat and she starts rambling about something off topic, she starts blaming Radia's declining mental health and how this is all a delusion fantasy cooked up by her and Digi etc

So I ask again, "whats going on truely, what's Radia done to cause you both to split like this?" She can't answer me, and now she's no longer upset, now she's getting frustrated and on the *third* attempt to coax an answer out of her she alludes to some long ago stream where Radia said something about fake friends.

So I watch it and it's got nothing to do with Adora.

Now I'm just confused. And that's kind of where something snaps in the back of my mind, some little red light I've been ignoring.

So I did my due diligence and started digging.

I've been down the Ukraine rabbit hole for the better part of the past four years, I get attacked by Z-bots almost every day, I'm up to my asshole in russian propaganda, Bad OSI bro's, Scammers, Vatniks, conspiracy goons who think cultural marxism is real because they saw a homeless guy on the subway, and people who just wanna troll or get a rise out of me. A huge part of my job has become to separate fact from fiction and I've become really, really good at telling when people are lying to me, and Adora is lying to me.

In fact I don't think you'd need to be someone with any skill to know Adora was lying, the crocodile tears were hints enough but the sudden frustration and being unable to answer a basic "show me on the doll what she did wrong" question?

But it's when I start talking to others in the Vtubing sphere that it just becomes more than obvious.

Everyone I talked to trying to work out what the hell was going on were all giving me different stories about what Adora had said, it's more than obvious she's just making shit up on the fly to hurt Radia for reasons that I don't fucking know.

And that's what shook me. Adora is my friend and she lied to me, she continued to lie and cannot fathom why.

And then I see the document and it all starts to fall into place.

I've been hurt in my past. I make no secret of that. I was in a highly toxic relationship for 10 years, the details of which I'll spare you because this isn't about me. But because of that and consequently the therapy I've had regarding it I have come to recognise the language of the abuser, they way they talk, they way they act, the subtle things they do to keep you down. And that document sent to Digi is *textbook*.

The way Adora talks to Radia, the way she acts, the things she says, I recognised it immediately, I lived with that for ten years it stood out like a fucking firework display and at that point I knew exactly what was going on.

An abusers motivations can be complicated and never clear, sometimes they have none its just how they live, but one thing they like to do is involve as many people as physically possible, so that the whole drama becomes exhausting for everyone and you are put under pressure to let them get away with it "for the sake of everybody else".

There are a number of Vtubers who knew *exactly* what was going on and had the power to stop it but choose not to for their own sake, I know who those people are and you wanna bet your ass they are on thin *fucking* ice with me.

But, for their sake we tried one last time with Adora. I sat in a call between her and Radia attempting to establish a dialogue. My motivations were if I could just get the two to hash it out, clear the air, maybe we could learn to live with each other and move on. That is not what happened.

If you only know Adora through her streams it would be difficult to describe what she was like in this call. Her usual bubbliness and offensive charm was gone, she spoke in a bizarre, utterly monotone, emotionless way and simply repeated the same three things over and over and over. "We both hurt each other, it was a private matter, I'm ready to bury the hatchet".

I asked her a grand total of seven times to explain what Radia had done to hurt her and she avoided the question each time refusing to answer. When I asked Adora if she thought Radia deserved an apology all she could muster was a "I'm sorry you feel it's come to this". When Radia finally blurted out she had tried to take her own life, Adora's response was an utterly hollow, almost eerie "ok, I hope you get help".

The call finally ended when we simply grew exhausted of trying to get her to say literally anything else.

Maybe Adora was ready to finally bury the hatchet, but would you trust someone who had driven you to suicide? Who couldn't even apologize, tell you what you had done so wrong to offend them, or even offer any hint or remorse or guilt?

And so I choose to help make this document, adding in sections where I think it should be made obvious to the reader the kind of person Adora is, though I am not qualified to offer a diagnosis I can assure you this is behaviour I recognise and know well.

I lived with it every day for a decade.

These are the actions of an abuser, one who delights in the feelings of power and control they hold over others.

I truly hope I am wrong, but I don't think I am.

(Note: While LazerPig is seen as a close friend by many within the Vtuber sphere, he still remains something of an outsider, his is a different world. However, LazerPig has been the subject of abuse previously, having been in several abusive relationships under both his family and from someone he loved for over 10 years. He recognised the language and tactics of the abuser almost instantly and has provided several resources helpful in highlighting the more subtle nature of Coercive control and the tactics of those with narcissistic tendencies.)

#### Anonymous Account of Doxing

Note: It is necessary to note that this individual was willing to provide a statement and DM evidence of Adora's doxing of Radia, but asked for their name to be removed due to concerns regarding their professional obligations and their own mental health.



Note: As the above statement is too wide to resize, below is the statement in plaintext:

"On June 5th, 2025, I was having a conversation with Adora Bunny. During this conversation, she informed me that she was distancing herself due to several reasons, including the fact that Radia had allegedly lied about her master's degree. Adora brought up Radia's LinkedIn, and I stated that I didn't know Radia's IRL name to even be able to look it up. She then gave me Radia's IRL name. Since June 5, Adora has removed the name, but I still have the search history from that day. I was sent Radia's name even though I did not know it previously, nor should I have ever known it unless Radia herself told me."

## Animarchy's Statement

I want to make it clear that from the outset of this situation a few months ago, I made it abundantly clear to all parties concerned that I wanted no part of this entire fiasco in any capacity. In fact, I was completely oblivious to any wrongdoing on the part of everyone involved

prior to me being notified and quite frankly it should have remained that way. I had no idea what was going on and I had no desire TO know, however, the fact that I am now publicly involved and openly partisan is a testament to both the severity of the situation and a vindication of Radia's position.

My involvement in this drama began immediately after Adora submitted her demands seemingly on behalf of Project Stim to Radia as outlined in the associated documents. I received a discord call at something like 04:00 AM Australian time from Adora, who informed me about the developing situation and the escalating conflict between Radia and the rest of Project Stim. Now, I want to make it clear here, I am on friendly terms with every member of this V-Tuber group (at least I hope so), so this came as something of a shock given I had no warning or inclination this was happening. All of a sudden at 04:00 I am being told that a dear friend of mine and the romantic partner of one of my best mates (Digital Vagrant) is apparently engaged in defrauding her audience by begging for money due to her various medical conditions while simultaneously undermining the lives and personal relationships of the other members of Project Stim.

Now, to be fair to Adora, which given the circumstances seems ridiculous, yet context is vital. I've known Radia for a while now and have heard more about her personal life than most people have with the exception of the aforementioned individuals involved in this scandal. For the sake of her privacy I will not divulge specifics, but suffice to say her medical issues and personal traumas are very real. Experiences which have resulted in serious issues regarding her neurological ability to socialise. There aren't enough letters in the alphabet to provide an acronym for the amount of HD's and Tism's she possesses, layered upon a physical wreck of a frail constitution. The upshot of this being that when Radia is finally comfortable with someone and able to open up, her scientific and analytical mind gives her a tendency to be hyper self-conscious while simultaneously being EXCEEDINGLY direct. She has said publicly on stream that the reason she got into streaming as a V-Tuber was to have an anonymous identity where she could meet people and improve her social skills without having to worry about the constraints of her real life.

So, when Adora said that Radia had been insensitive, spoken out of turn or shared information and opinions that hurt both her and the people around her. I had no reason to not believe her, I considered Adora a very close personal friend and wanted to believe that if such a thing were happening she wouldn't lie or exaggerate. However, I also suspected that while these concerns of Adora's were legitimate, I got the feeling that Radia had simply not been told about any of these issues prior to the point of it blowing up in her face and that Radia was simply being open and honest about her thoughts and feelings which had been misinterpreted as hostility or outright malicious social maneuvering. I mentioned this to Adora, and she told me that it had been a constant ongoing issue that was coming to a head with the support of the other members of Project Stim. As such I spoke to my friend Pomatomaster who corroborated Adora's story, but at the same time she admitted that she was not exactly happy about the way Adora

was going about it, expressing concerns that there was "mean girl bullshit" going on. And I started to have a sneaking suspicion that all was not as it seemed, but at the time I said to everyone I was going to embrace the skills of my Swiss German ancestors and embrace neutrality on top of my own little mountain and avoid it all.

So, I sat on my own and waited it out, watching things unfold while making a pointed effort NOT to get involved. Regardless of what happened I was resolved to stay friends with everyone because as far as I was concerned, THIS WAS "mean girl bullshit" and everyone was acting like immature children who just needed to sit down and hammer out their differences. I personally must admit I didn't believe Adora's accusation against Radia regards using her medical conditions to raise money, she has been open with her audience about her physical health and I WAS ON THE STREAM WHERE SHE SUPPOSEDLY DID IT... and it didn't come off that way at all. However, like with all neutral nations in times of conflict, eventually circumstances are going to bring the war to you whether you like it or not. And in my case, it was the attempt by Adora to undermine Radia's relationship with Digital Vagrant. Now forgive me but I have a confession of my own to make. I am perhaps the most stereotypical "Man" there is, if there is an entry for "toxic masculine stereotype" you'll find my picture there. At this point I was happy to remain neutral because I wanted nothing to do with the drama, even involving my friends, I figured they were adults and could sort things out themselves. The words I used at the time were "they're big girls, they can handle it on their own". However, an attack on "one of the boys" is another thing entirely, so I started talking to Digi to find out the extent of what was going on, ONLY TO BE MET WITH A COMPLETELY DIFFERENT STORY FROM WHAT ADORA TOLD ME.

This naturally led to alarm bells going off, so I finally decided to sit down and speak to Radia, WHO AGAIN GAVE A COMPLETELY DIFFERENT STORY. Alright... So now I knew something was wrong, I went around everyone I knew who was at least aware of the situation and sure enough their version of events did not match up to the version of the story I got from Adora. Then I decided to feel my way around some of the people who weren't aware of what was going on, only to discover THAT HALF THE V-TUBER COMMUNITY apparently knew. I had been told by Adora in a Voice-Chat that Project STIM was going to keep the dispute in house to protect the careers of everyone involved, they stressed they didn't want to hurt Radia and wanted her to improve herself and come back like a concerned friend staging an intervention. Only for me to find out that Adora had essentially spread the information about the ongoing drama to half of her friends and several very large creators. While I can't name names, there were at least two creators who are considered globally famous in the VTuber space who actively began asking questions about Radia to senior figures in the community (including sponsors), to find out what was going on because they'd heard the rumours. So, I began asking around my friends and chasing up the rumours only to once again, GET A COMPLETELY DIFFERENT STORY FROM EACH ONE. I even found out she had been doing similar things to a number of other creators who she supposedly considered "friends". And that several of MY FRIENDS had essentially

been bullied out of our communal spaces by Adora for various reasons that I knew to be complete and utter nonsense. However, for their privacy I shall not elaborate.

It now became obvious what was happening. Adora was very intentionally spreading rumours and slandering Radia, making all kinds of accusations, and then customising the story to achieve the maximum effect depending on the person she was speaking to. She had framed her story as an ethical concern to me, because she knows my Left-Wing Political views would make me sympathetic to issues regarding the principles of ethics and justice. She changed the story to one about betrayal when talking to her girlfriends, she changed it to one of business concerns when talking to her professional acquaintances. And in every single case she edited the information to remove ANY wrongdoing or mishandling of the situation on her part. The severity with which she pursued it, the threats and aggressive moves she made while doing it, the attempt to spread slanderous rumours to every corner of the community could only mean one thing. Adora was intentionally attempting to destroy Radia's career, and the more she said and did, the more obvious it became she had no interest in reaching an amicable or acceptable conclusion to the situation.

Thus, I was asked to act as a go-between. To do some reconnaissance and find out what was going on because Adora and I were still on good terms at this stage, so I decided to go incognito and very carefully ask her what was going on. Saying that I had heard a bunch of conflicting stuff and I was worried that it could hurt all my friends, which was definitely me being very polite, I gave her every single courtesy and handled it delicately. I desperately wanted the entire affair to be resolved peacefully and efficiently to everyone's satisfaction without risking the livelihoods of the people involved. This is where the screenshots of my conversation came from, she spun the entire thing as though she was a master politician, accused Digi of being a misogynist for pointing out that the members of Project STIM were being rather aggressive towards Radia with the wording of the document and the manner in which it was delivered. Only to tell me "I actually realised afterwards you didn't need to be involved and I'm sorry for mentioning it", perhaps realizing she'd made a mistake involving me. Which she had.





Thats all good, I just wanted to check in on the whole situation going on. Because I'm starting to get dragged in by virtue of the fact that there seems to be factions forming. I don't want to get involved but Digi is one of my close friends and he is ROYALLY pissed off RN. He has kept it between the people who know at present and I'm wondering WTAF is going on really.

Because to be honest this is getting out of hand fast. And Im wondering what going on



After this interaction we decided we needed help, so Digi and I coordinated with Lazerpig to act as another neutral party to confirm our suspicions. As evidenced by his earlier statement, he did confirm our suspicions. The rest of the story you can find in the other parts of this document, as from that point onwards I very intentionally avoided speaking to Adora or hanging out in her server, choosing to instead help Radia recover from the immense emotional trauma inflicted on her, trauma which very nearly cost her life. An outcome that, should it have come to pass, would have been a devastating loss to the world and a shameful indictment on behaviour which has become distressingly common in the V-Tuber community, behaviour perpetuated by vindictive, spiteful individuals.

But what hurts me the most, is that Adora was a close friend and a member of my international trade union. To me it always appeared that she used her platform to elevate and collaborate with other creators, we are stronger together, not apart. We do not have to tear each other down to advance, we can march forward as one, inspiring our colleagues to greater achievements with our own success. Helping the smaller talents among us shine through and come to the fore, we can achieve so much if we work together. Yet Adora and others like her, most famously a certain infernal canine, do nothing except tear others down, projecting their insecurities and inferiority complexes on people who trusted them to have their back. Adora's actions are not just immoral, they are a betrayal of both the personal and professional trust of everyone around her, and in doing so has brought shame not only on her. But on myself as well, she was a friend and fellow comrade who I supported without questioning the situation until it was almost too late. And I will not absolve myself of that responsibility or my failure to hold her directly to account until now.

Suffice to say, solidarity is stronger than division, supporting each other is the only way to triumph over both AI and the Algorithm, not tearing each other down. And with that in mind I issue this statement as both one of support for Radia. And a warning against the evils of abusive relationships in content creation.

I'm going back to History YouTube now... it's safer there, at least there people just question my intellect and yell slurs at me. That I can deal with.


She still decided to tell me the vague version of things anyway, despite my previously stated desire to not know. I expressed that I believed that they'd be able to work this out as they're both adults. This resulted in Adora giving me more vague information that painted Rae in a bad light.

This didn't sit right in my mind. As they'd just had Anime North not that long ago, and everything seemed fine. In fact everyone sounded like they had a good time. I was confused about it and decided to not dig too deeply into it. It wasn't the first time I'd had friends butt heads over something and make up. I left it as I'd just entered my own IRL problems and had become quite distracted from the entire thing.

Rae didn't want to drag anyone into this, but was being forced to at this point. I did NOT know how deep this went until I was told about Rae's attempted suicide. I was filled in that this had been going on for a good while now. I was shown screenshots of Adora's behavior. I do not condone actions that endager my friends in general. In this moment I did not almost lose a friend, but I almost lost someone who I consider to be one of my own family. I would not have lost a friend that night. I would have lost a sister.

Further, PartyDemoness provided DMs evidence of Adora's ever-shifting narrative, and DIRECT evidence of her duplicity.

In brief, Adora was lying directly to Radia's face regarding her intentions as early as June 3rd-4th. The below screenshots are from less than 24 hours apart.

Adora states she wanted "polite distance"; she never even made that possible via actions solely of her own accord and ensured her time was dedicated to brutally and systematically destroying my life. concerns, as stated before. It is incredibly evident that Adora was and always has been lying about how "she could move on."

### **Discord Harassment**

During the course of Radia's attempts to move on, she discovered that any attempt to speak about what had happened in anything resembling a public fashion would be met with retaliation.

Adora announced a hiatus during June, apparently due to poor mental health and needing to be "a better person to those around me".



#### **Hiatus Announcement**

Hi everyone! I wanted to let you all know that at least for the next few weeks of July and potentially longer, streams will be on pause. My mental health is in a very poor spot meaning it is time to step back and work on the deeper problems I have been putting off so I can be a better person to those around me online and offline.

I will also not be posting on social media during this time until I'm in a better place mentally to announce a return. However YouTube videos will continue to be posted at least for the next couple of weeks due to a four week backlog, so please enjoy them in the meantime as my editor and thumbnail artist worked hard to make them for you to enjoy.

Radia assumed, quite reasonably, this may have included her poor treatment, and saw this as an opportune time to quell questions of why she was no longer streaming with Adora as quietly and non-commitally as possible. 



Note: It is unknown if Alicia is aware of the extent of Adora's campaign or the depth of her deception; it is entirely possible that she has been given an alternative version of events like many others, and was attempting to defend a friend, albeit in an irresponsible manner.



# Rat Queen Alicia RATS 4:04 PM

@everyone Hey folks!! So I was made aware of a bullshit statement by Radia about Adora. I want to say it is bullshit. Adora is taking a break because her and I had an amazing heart to heart about life and growth. This didn't involve Radia. Don't know why she is making it about herself LOL.

You all know I don't fuck with Radia after she pressured you guys to donate to her and got mad that someone mentioned supporting me. Now this is just getting weird af. Here is her random ass statement she made in her community.

Adora is completely fine. This was a decision she made after a heart to heart with ME. Don't know why other mofos acting like weird.

Anyways Adora will be returning of course!

Just gonna be recording Logan solo while she's on break much love rats. (edited)

Alicia is a well-known and sizable Vtuber with an extremely large community; directing the ire of her community at Radia was both grossly irresponsible considering the dangers of online fans and a clear retaliation at Radia for speaking up to try to address anyone about what had

happened.



At the time of her Discord announcement, it was unknown to me how large her Discord community was. I am a busy woman and not in the habit of occupying numerous Discords, so I


never took it upon myself to look, let alone join. This public tweet was put out on July 31st, with her Discord statement being in early July; suffice to say, her Discord at the time was 17,000+ members strong. Putting forth such a statement was not only incredibly reckless but also willfully engaging in behavior that could endanger my safety. With such a large and dedicated audience who trust you as a creator, engaging in this behavior is irresponsible to the highest degree.

Alicia's statement is an incredibly false representation of a situation that did occur on the day of the Project STIM debut and a full-on lie about "pressuring her community to donate" to me. I will fully admit that I did eventually become short with one of her community members that had decided to pop into my chat (who was only identifiable as a supposed community member by them referencing a "rat queen") after they had repeated the same message 5 to 6 times after being told politely the first time it was not a problem they couldn't sub as the content is inherently free. But this individual took it upon themselves to keep proclaiming over and over, despite assurance that it did not matter, that they were sorry they "couldn't sub, as they gave all their money to their rat queen (Alicia)."

In the past, Alicia was kind enough to pay for two video edits for both me and Adora from my now former editor, Gobtsun, for which I was immensely grateful for that gesture and expressed my appreciation. To reiterate a certain earlier accusation of "pressuring her community to donate" to me, I had not had Alicia on my stream more than a handful of times, and I made it a point to not overly involve myself in becoming a mainstay on hers. At no point did I request her community do anything for me; at no point did I request anything other than the thumbnail tips she did graciously offer (as well as provide an edit for one of my videos in which she is credited as the thumbnail creator in the description) and for which I appreciated and still do despite this attack on my person.

I made it a purpose to not overly involve myself in a deep friendship with Alicia after seeing how heavily it was something Adora was pursuing and desperately heralded as a fantastic new addition to her life. I historically know better than to get in the way of what Adora wants, be it people or anything else.


As stated above in Radia's statement Alicia had previously abruptly cut contact mere minutes after the conclusion of the conversation where Radia was ejected from Project STIM, citing an "incident" where Radia had "disrespected one of her community members".



The incident in question was confirmed by multiple third parties to be benign; Radia had snapped at the chatter for attention seeking after they repeated multiple times through the streams that they could not donate to them because they had given it all to their "rat queen"; this is a known faux pas heavily frowned upon in many streaming circles, with some banning on sight for similar comments. Regardless, Radia did not attempt to fight the cutoff, knowing it was likely futile as Alicia had not asked for her story at any point, and the timing was clearly no accident. It was later confirmed that Adora had asked Alicia to hold off sending the message until Radia had been booted.

Note: It is unknown if Alicia is aware of the extent of Adora's campaign or the depth of her deception; it is entirely possible that she has been given an alternative version of events like many others, and was attempting to defend a friend, albeit in an irresponsible manner.

Furthermore, Adora used this situation as an opportunity to resume smearing Radia to other individuals, casting herself as the victim and the one being "reasonable."



The message received by Radia was extremely clear at this point: any sign of perceived defiance, or attempt to speak publicly on what had happened, would be met with immediate and disproportionate punishment. Whatever guilt Adora had publicly stated, Radia was apparently not part of it.

#### Addendum - Anonymous Account



The main thing I can say is this.

That conversation was a week after I was on her stream and only weeks after she had recently referred to me as a "close" friend. Yet when a Bigger streamer went to attack my character and credibility by telling a lie that Adora KNOWS FOR A FACT is a lie, she chose to leave me to the wolves of her bigger, more successful friend. Despite constant claims of telling me she was actively trying to "be a better person," she dropped me the moment her bigger friend went after me. Friends don't do that or let their friends do that to others. I've learned that at the end of the day, whatever kind words or promises she will make you, at the end of the day Adora looks out for one person and that's Adora.

Note: The above account was offered, with redactions of name due to fear of additional retaliation, to clarify the previous screenshot. The individual in question wanted to highlight the insincerity at the core of Adora's words and actions, even to people completely outside Radia's situation.

#### **Offkai Harassment**

During the course of this campaign, Radia decided to attend Offkai, as she had made travel arrangements before the initiation of hostilities and did not want to see them go to waste. It was her intention to avoid straying into the same spaces as any of her former friends, and focus on reconnecting with other friends that she had been forced to distance herself from due to the ongoing stress of the situation.

Adora continued her campaign of harassment here. Radia was left feeling completely locked out of social spaces due to Adora's heavy presence and rumormongering. This culminated in a completely unrelated third party individual being approached by a known friend of Adora who had spotted them speaking to Radia, and launched abruptly into cryptically threatening statements about people "getting what they deserve", statements that profoundly disturbed them, once Radia had walked away.

### **Corroborating Statement**

Note: The below DM image has been destructively chopped up to avoid speculation on names based on character length or other methods, as names were mentioned that are not the focus of this document. The individual who provided this has also asked that their name be redacted, due to fear of retaliation.

I was talking to Radia on the last day of the con and we inadvertently wound in the meeting up in the same area Adora was around. Radia excused herself to the bathroom for a sec and left me alone and while she was gone

### approached me,


We had talked before at other cons, so this was not unusual to casually approach me, but the conversation went from cordial to weirdly intense as me she seemed to threaten me in so many words of "People will get what's coming to them and reap what they sow," or something to that effect. I feigned ignorance and didn't rise to the veiled threat and simply wrapped up the conversation and wished them well. But, the conversation stuck in my mind as distinctly strange.

It is after this event that Radia was unexpectedly contacted by FenariMori. Over the course of a multiple-hour call, she apologized profusely for her role in the initial intervention: she confirmed that neither her nor Pom had been aware of what had been sent to DigitalVagrant, nor that it had been doctored prior to sending in a way that placed the majority of the comments focused on the two of them. She was further instrumental in confirming privately the extent of Adora's duplicity and doxing, providing key info on who to reach out to in an attempt to determine how far things had spread and what lies had been told.

FenariMori was able to corroborate that Radia was not imagining things: Adora had embarked on an unhinged campaign to undermine Radia's life of her own volition. This so disturbed the other two members of Project STIM that they proceeded to distance themselves from Adora after failing to convince her to stop.

It is also interesting to note that near-simultaneously, Radia received the only thing resembling an apology from Adora's side. We have confirmed that this apology was likely spurred on by disruption of Adora's own friendships due to the discovery of her duplicity; Radia was not the only one to receive incredibly belated apology messages at the same time, leaving this a likely case of "lovebombing", i.e. damage control commonly used by abusers. As far as we are aware, only Adora's victims received messages such as these; she did not contact anyone she had spun lies to, or make any attempt to undo the damage she had caused.

The "apology" in question is below:

This message is extremely disingenuous; Radia had not attempted to interfere or speak ill of Pom or Fen at all during this, or even spoken to them at all beyond the last conversation deciding her ousting from Project STIM. It claims all of Adora's actions to be a "misunderstanding", couched the message in more subtle accusations and with **zero offer to correct the lies she'd told, either privately or publicly.** It also directly lied; Radia was by this point now well-aware at this point that Adora did not consider her a "best friend", and hadn't for the better part of a year, as confirmed by a third party.

Rather than assuage Radia's concerns, this put the nail in the coffin of any hope Radia had that Adora had any intention of even trying to correct the damage she had done.

This apology, if you can even call it one, was couched with accusations in and of itself. My "ire," as you so call it, was never directed at anyone but myself as I tore myself apart mentally for weeks as false accusations were lobbed at me and I lamented over the possibility of unintentionally hurting friends feelings over unknown and previously uncommunicated situations.


You did not send down a "poorly edited version"; you **DELIBERATELY** worked to remove mentions of yourself and complaints so that the onus of aggression was wrongfully placed upon both Pom and Fen while you played the part of a concerned "sister," even if falsely so, with fabricated accusations with no evidence. This was not a miscommunication in any way, shape, or form...one does not simply doxx someone in a miscommunication. You, Adora, elected to slander me to multiple parties, fully knowing what you spread was false. This is behavior you have engaged in for years, taking advantage of my limited ability to be online and creating false narratives that you laid down as truth, coating many of my interactions, unknowingly to me, in a negative light from the onset.

### SUICIDE ATTEMPT

Cut off from her friends, isolated from her support network, and with the fear of permanent ostracization from one of the few things in her life that brought her joy, Radia's mental health went into a sharp dive.

On July the 12th, Radia attempted to take her own life.

It is only through the actions of her roommate and her partner, driving through the night, and of the crisis hotline that Radia called, that she did not succeed.



### **Current State of Affairs**

This section will attempt to provide a look at what the current state of affairs is, additional relevant information, analysis, and corroborating evidence, as well as a conclusion to draw the document to a close.

## **Ongoing Effects**

Radia has in no way managed to recover from her ordeal; she remains in a continued state of mental decline. Even as this document is being written Radia frequently tries to isolate herself from the collective which has sought to aid her and will often lament it would be easier to leave the streaming world behind or to "just disappear".

She continues to suffer from a variety of effects both lingering and recent, including but not limited to:

- Returning bouts of suicidal ideation due to the ongoing inability to clear her name or even speak her side of the story.
- Ongoing physical symptoms (shortness of breath, recurring fevers, fainting spells, etc.)
  as the result of the extreme stress aggravating her chronic and serious medical
  conditions. There is a reasonable chance some of the damage done will be
  permanent.
- Radia continues to struggle with reaching out to her friends and those in her seriously-damaged support network; with no idea of how far Adora's slander was spread, she fears what others will think ill of her, and that they will no longer wish to speak with her. She has been terrified that people will accuse her of forcing others to "pick sides"; it is this pressure that has made it so difficult to speak out publicly.
- Radia was forced to stop most streams for two weeks in an attempt to placate Adora's demands for contrition. Not only did this make no difference, but massively slashed her revenue at a time when she had numerous medical bills coming due and had been forced to take an effective pay cut at her day job.
- Radia's expenses, due to the family she needs to support and her own medical issues, are extremely high. This series of events directly endangered her ability to meet those obligations, and her ability to stream has been compromised to this day from sheer stress.
- Radia's roommate, whom she was helping to afford attending college, was forced to move out and make alternate arrangements due to the severe hits that Radia's income took during this.
- Radia was forced to delay re-entry into college classes to further her education; this resulted in the irreversible loss of nearly \$10k in educational assist funds from her employer.

• Radia continues to live in fear of Adora restarting her campaign. Adora does not have a job outside streaming, and spends the majority of her time online as of this document's last knowledge. Conversely, Radia has a full-time job, her content career, a relationship, a household to manage, pet ownership, and a myriad of other obligations. She quite literally does not, nor ever, have the time to win an internet fight with someone who has considerably more time to devote to it than her.

# **Early Signs of Abuse**

During the compilation of this document, Radia found the courage to begin examining her past interactions with Adora, and realized that she had been enduring poor treatment for far longer than she understood; treatment she brushed off as normal, or her concerns being "selfish".

In the interest of properly portraying these, Radia will be speaking on this treatment in her own words:

#### **Requesting Separation from Artists**

In the weeks before departing for Anime North, I was asked by Adora to jump into a call with her to discuss a "nagging matter." To preface this, the call was not recorded, and these are the only screenshots I can provide to A) prove this call occurred on the date of May the 5th, mere weeks before Anime North, and B) show that I attempted to provide her additional resources to aid her with obtaining other art pieces, from thumbnails to videos, in her price range, as that was part of


her central issue.




During the course of this call I was asked if I could "step back" from commissioning a thumbnail artist we shared, and still do, who goes by QB. Adora asked that due to QB's workload delaying thumbnail delivery if I would "step back from QB, as she cannot handle both thumbnail workloads, and you (Radia) can afford an artist that is higher in price range." At the time I agreed without fighting because I had zero interest in making this a point of contention, and due to QB's workload I was looking into other options; however, the continual assumption that because I have whatever amount of "more money" than Adora that I must step back shows a pattern of behavior.

Understand I am grateful for the artists Adora has shown me and shared with me, such as Kico or Mikami Michael; without Kico, I would not have my model. However, asking me to step back from an artist under the reasoning that I could afford the extra hit and that this was a small thing she was asking in return for showing me various artists is not behavior I believe most friends would engage in.

In an effort to reciprocate that generosity, I provided artists for various purposes that were within reasonable price ranges and hoped she could utilize them in the future. Through the conversation she told me, "I was afraid you were going to take this poorly" and "I'm happy you understand." I try my best to understand and exhibit compassion, but leveraging my "higher earnings" as an argument did not sit well with me. However, I complied as I always do.






#### **Medical Issues**

I will state that I am incredibly uncomfortable about diving into the severity of my physical issues; it is both incredibly embarrassing and shameful, as the reality cannot be played off as mere aches, pains, bad days, or *tummy troubles*.

My gastrointestinal system does not function without the assistance of various medications and enzymes; my ability to eat solid food is, in fact...entirely dependent on access to these medications. The motility in my intestines has degraded year by year with the onset of issues first noticed in about 2018. Initially these issues caused me to suffer from minor bouts of constipation, which I thought little of when the issues first began. By 2019 my condition had devolved into consistent vomiting, nausea, waste buildup, and repeated bowel obstructions, which required numerous hospital visits to clear the obstruction from my intestines. The process for attempting to clear a lower bowel obstruction (the most common of my obstructions, upper obstructions are another game) is a SMOG...it is an embarrassing procedure and one I do not personally wish to describe beyond comparisons. I will only offer that you imagine the shame you would feel if multiple people circled around you as you were awake during a colonoscopy... except you needed to void yourself immediately in the center of a room...not even a bathroom because you'd never make it there. You have no control over your body at that moment; it is utterly humiliating.

In the present day I have the ingredients for SMOGs kept at my home to help reduce the burden and embarrassment that an ER visit for this specific issue brings. Due to the high cost of going to the ER or being hospitalized, this is my first line of home defense against bowel impactions and resolving them myself. To describe what an SMOG is, it is an enema that is equal parts sorbitol solution, magnesium hydroxide suspension, mineral oil, and glycerin solution. Below are *most* of the items needed to make a SMOG, what is not pictured is magnesium hydroxide (I used my last bottle recently), sorbitol (I used my last bottle recently), the bag this all gets mixed into, and the tubes required for this treatment.

Before I continue, please understand that revealing this much of my intimate daily routine, specifically my gastrointestinal routine, along with other aspects of my care, particularly at-home support methods, is incredibly embarrassing. I would detail my entire medical history *if it was truly what would have ever satisfied* Adora, but we would be here for hundreds of pages, and an unsatisfied Adora would remain so that is a pointless endeavor for all parties. But to resume the detailing of this specific suite of issues, I continue on:

2019 was the last year I was able to utilize my intestines without the assistance of a massive medication regime; as the years progressed, my condition has degraded considerably. I now require a cocktail of medication to artificially recreate gut motility so that I can move solid food through my system. This comes with immense risk, such as, but not limited to:

- Critically low electrolyte levels each day, such as dangerously low potassium, as my body voids itself of large amounts of water on the daily.
- Dehydration
- Fatigue
- Bloody stools due to irritation and strain on the intestines
- Nausea and vomiting

Multiple bowel movements totaling on average over a dozen daily (this is a great burden
on a social level as well, not just medical, as it requires constant restroom visits when my
medication begins to work)

**NOTE:** I fully accepted these risks and was judiciously informed by my team of physicians about these risks and what I could do to help ease the burden of them upon my life. For me these risks and struggles are FAR more appealing and less detrimental to my life than having to undergo a colostomy, which would create an opening on my stomach known as a stoma, which waste would empty from. To reiterate, there is no shame in having undergone a colostomy especially if it is the **RIGHT CHOICE FOR YOU AS A PATIENT**. The choices are different for each individual, and for where I am at in life, the thought of having a bag attached to my body would be incredibly difficult to deal with mentally. Keeping up the illusion of being a healthy individual at least on a physical level is something I will admit is important to me and the pain I suffer in my medication regime is worth it for a small bit of normalcy in my human experience.

For my **gastrointestinal function ALONE** I must currently take the following medications **EACH and EVERY DAY**:

- Purcalopride 2mg
- **Linzess** (all available doses, I take one base 290mcg a day and depending on severity of my symptoms that day I take an additional 72mcg or 145mcg pill)
- **Biscodyl 15mg** (increase to 20mg or 25mg if no bowel movement is produced within 4-6 hours of taking the listed medications)
- **IBSRELA (TENAPANOR)**: taken during each solid food meal in conjunction with enzyme pills such as lactase and alpha-galactosidase to help aid digestion. Depending on current struggles PERT is employed to help break down carbs, fats, and protein.
- 2 cap full of milk of magnesium (the heinous liquids that I jokingly refer to as my "goop"): it aids in the motility process and pills alone are not sufficient 70% of the time to induce a bowel movement without the addition of magnesium citrate or milk of magnesium at this point in the progression of my illness.
- Enzyme replacement (for meal time and not directly part of recreating intestinal function but is part of the continuous motility and digestion process): As mentioned above, the following enzymes are taken during meal times, especially when dining out, and I wish to experience life and often am unsure of ALL the ingredients in a dish.
  - Lactase
  - Alpha-galactosidase
  - **PERT** (amylase, protease, and lipase mix) for breaking down carbs, fats, and proteins. The use of this is dependent upon lab results and symptoms such as issues with nutrient absorption/rapid weight loss.



In addition, I take numerous other medications, including but not limited to:

- Immunosuppressant medications (methotrexate is just one commonly used in treatment cycles)
- Antibiotics (primarily a daily regimen of penicillin to keep bacterial infections at bay)
- Hormones (hormone replacement and supplementation included but not limited to liothyronine, levothyroxine, and testosterone replacement for incredibly low T levels)
- Pain medication (tramadol and gabapentin). These are rarely taken if I can avoid it but are begrudgingly available as options for pain management.
- Plaquenil (aka hydroxychloroquine): It is a disease-modifying anti-rheumatic drug that
  has been a daily player in the treatment of my SLE (systemic lupus erythematosus). This
  medication also has degraded my sight as I have been using it for NEARLY 10 years
  and my care team is currently exploring other options.


I would like to preface this section here on my lupus: neurological issues stemming from lupus that heavily affect my CNS, along with other medical issues, will be much shorter, as this was added with what I can only describe as the last of my energy on August the 6th at 1:45AM PST. I apologize for a more scant section on this, but I highly doubt another dozen-plus pages of medical information will provide anything beyond bringing this document to a triple-digit page count. Furthermore, beyond my desire to not have this the length of a thesis I am currently fighting another bout of pancreatitis and am wracked with pain due to critically low sleep for over two months now and lack of food, as I cannot consume much without worsening the pain, and am constantly battling the immense stress put upon me, which has further exacerbated my issues.

Please note this is not a full and complete diagnosis list, medical history, nor a full list of current symptoms that I must combat. You would force me to redact hundreds of pages of documentation, some of which is imperative in continuing to pursue ongoing as well as future legal action regarding medical malpractice and workplace negligence at a former employer. At this time I am not comfortable, nor have I been advised to legally do so for the purpose of this document going public, and therefore will offer what I can comfortably and without risk to ongoing and future legal processes. I offer my deepest thanks in understanding that both the general public and Adora are not entitled to that level of intimate knowledge and insight into the full condition of my body; that is only for my care team, lawyers, and highly trusted confidants who exist in person incredibly close to me in real life.


While I will not detail the extensive history of medical issues, as we will be here for another 100+ pages, I will however offer *part* of my diagnosis list in an easy to read and understand format along with blood tests in the latter half.




Radiation damage to digestive system

As stated previously, I also suffer from bouts of acute pancreatitis, which cause me immense pain; oftentimes I am left doubled over, nearly crying from the organ pain. During these periods I deal with nausea, fever, fatigue, vomiting, and ridiculously high lipase levels, as shown below:




This is a normal, even what is considered a good, blood cell count for me; it is commonly much worse.



AUTO WBC (WHITE BLOOD CELL) COUNT: For those who lack knowledge or require a refresher on cells, white blood cells fight off infections and are a crucial part of the immune

system.



**NEUTROPHILS:** These little guys are who respond to infection and injury. In a healthy individual, these are the most abundant type of white blood cell.

**LYMPHOCYTES:** Another white blood cell and is divided into two types: T lymphocytes (these kill tumor cells, and they also play a major part in controlling immune responses) and B lymphocytes (they make antibodies!!).

**MONOCYTES:** Originating from the bone marrow monocytes become dendritic cells or macrophages. Macrophages are like industrial vacuum cleaners for the body; they remove dead cells, clear out debris, and bolster immune responses. Dendritic cells boost immune responses as well.

**EOSINOPHILS:** Like a stress ball that you squeeze, eosinophils release little granules coated with enzymes during allergic reactions or infections.

\*A light hearted break: Please note I have worked to make any immunology information easy to understand for the general public and so that there is a baseline of understanding of what these tests are even showing without having to do a vast amount of additional research outside of this document (you have read quite a bit if you're looking at these words). You should totally look more at these little guys though! Your immune system is super nifty, and it's fascinating to learn how it works, or doesn't in my case!\*


The inclusion of further blood tests (ANA, Anti-dsDNA antibodies, Anti-RNP antibodies, Anti-Smith antibodies, complement levels, tumor markers, etc.) or any other medical tests such as imaging has been kept incredibly limited, as they would not be helpful to the general populace unless the individual in particular reading this was a medical professional. Again, I offer my sincere appreciation in the understanding of those who read this document that providing the entire history of my medical information would not only be effectively useless on a greater scale but also incredibly violating and putting mass amounts of personal identifying information into the public sphere that does not need to be present especially after a doxing event.

I do not enjoy having to have a mounting list of medications as the years pass, but this is the nature of not only degenerative chronic diseases but also part of the harsh effects of chemical exposure and exposure to radioactive materials in samples through prior employment. This is a long and arduous road to travel; my most comprehensive care has only even started to be served to me within the last 16 months as I moved to the West Coast for improved medical care and support, which I lacked in the South of the United States. Every aspect of this is deeply embarrassing for me, to reveal how *degraded* my body truly is. What is required to live life in a way I find comfortable is, to put it simply...a lot. I would not wish this on anyone; juggling a complicated medical situation is another job in its own right from treatment to seeking legal pathways for justice and compensation, from advocating for oneself and dealing with mounting

costs of care as conditions progress along with missed opportunities to simply navigating the hellscape that is the American medical system.

In an effort to be transparent about the gravity of just some of the costs I deal with on a consistent basis, please note this is not a comprehensive overview of my medical costs this year but a snippet of them.







#### **Additional Notes**

It is vital to note that Radia has, at no point, attempted to spread this beyond an extremely small selection of very close friends that she was using for mental support and even then it has been a difficult and exhausting experience in getting Radia to fully open up about what has been going on.

We still do not understand what actions Radia had done to deserve this, and what was expected of her to fix this and to retain her friendships, her streaming, and all of the achievements she has worked so hard for. Her alleged wrongdoing, as far as can be determined, extends mainly to her difficulty managing her anxiety and her unwillingness to fully divulge her personal details or medical history to Adora, out of concern that her details would be shared without her permission. Given Adora's immediate actions to do just that upon being angered, this fear now seems well-founded.

Adora's version of events change with each re-telling, and each person who has asked her. Her justifications have steadily degraded over the course of the past two months to the point where she is unable to point to any specific instance of what Radia has done to "hurt" her, and she has completely denied many of the things we have obtained proof of in this document. Whatever her motivations, she appears to be incapable of being honest about them.

Radia has at no point attempted to dissuade people from being friends with Adora, nor has she ever instructed anyone close to her to attack Adora, either publicly or privately. This has been confirmed by nearly every person we have spoken with during the compilation of this document. She has consistently attempted to de-escalate the situation and keep the rift private. Adora has not provided her the same consideration; at this point, her actions can be considered little other than malicious.

Furthermore, Adora has continued to actively feign innocence to any outside party who have attempted to determine what is going on and to attempt to mediate. She actively changes her tone and framing based on what she believes will be the most sympathetic angle to whoever she is speaking to, changing details to attempt to maximize her story's credibility, despite its ever-shifting nature. Due to this, and Radia's fear of speaking up due to concerns for not being believed or told she was overreacting, **Adora has faced little to no consequences for her actions, and absolutely no public repercussions for the torment she inflicted.** 

### **Final Phone Call**

Due to the concerns of some third parties who desperately hoped that this could be resolved amicably, Radia (against her better judgement) agreed to a phone call with Adora on July 30th.

Again, Lazerpig chose to step in as an arbiter, a neutral third-party voice, to manage what they assumed was going to be a very emotionally fraught conversation.

It had been Radia's intention to try to negotiate some form of settlement; one that would include accountability and clearing her name, while not resorting to placing the situation at the volatile whims of the public internet. She intended to propose that Adora publicly state some of the things she had done on her stream, not social media, and offer an apology; in return, Radia would do the same, issuing a public acceptance of her apology and publicly forgiving her, and asking that they be allowed to go their separate ways. She reasoned that this would be the easiest way to resolve the situation with as little fallout as possible, as staying completely private was not an option, as she had no way of verifying how many people Adora had spoken to and the rumors had long ago traveled outside of the initial area.

Radia, with the agreement of Lazerpig, did not intend to bring up the possibility of releasing a document, or even mention that there would be consequences should Adora refuse. She did not want to be perceived, by Adora or others, as attempting to blackmail or strongarm Adora into submission. She also knew such things would only antagonize Adora, and despite everything that had been done to her, she still wanted to see if constructive conversation could be had.

What neither Lazerpig nor Radia expected was to be met with a brick wall of a conversation. Adora seemed utterly disinterested in any sort of discussion; her speech was flat, monotone, and devoid of any sort of emotional reaction to anything. The main phrase that she repeated, over and over again like a canned response, was "It was a private matter. I am ready to bury the hatchet. We both hurt each other. Let's move on and go our separate ways."

For over 25 minutes, Lazerpig and Radia attempted to get Adora to engage in some sort of dialogue, to clarify what Radia had done to hurt her, to explain any of her actions. Adora denied everything, including things this document has direct proof of. Even Radia revealing that she had attempted suicide provoked no response whatsoever: Adora only answered in a flat, emotionless voice, "I hope you get help."

More disturbed than frustrated, Radia and Lazerpig elected to leave the call, as it was incredibly clear that no constructive conversation could be had with Adora, and it appeared to all parties that she did not hold any real remorse for what had happened.

### **Conclusion**

It has become unfortunately more than obvious that this now goes beyond a silly internet drama spat between VTubers. This is now a very real, and very dangerous situation; one that nearly ended in tragedy.

Going public with this is an unfortunate last resort attempt to halt Adora's grudge. All previous attempts at getting her to de-escalate and correct the record have failed; No amount of contrition, surrendered ground or spaces, or attempts at professionally parting ways has satisfied her, and she has made no real attempts to apologize, correct the record, or de-escalate. Her only "apology" was a naked attempt at avoiding consequences and sandwiched between more lies.

There is no justification for the unhinged lengths she has gone to in her attempts to oust Radia from the content community. She engaged in blatant spreading of falsehoods, twisted documentation, violated Radia's privacy, casually doxed her to other individuals, as well as directly and explicitly demanded Radia take cuts to her income and streaming presence as some form of penance, none of which appeased her in the slightest.

Adora has shown zero remorse, offering no apologies even when informed that Radia had needed to be taken to the Emergency Room, when asked for even a token apology for the extreme disruption it had caused to multiple people's lives, or even when informed of Radia's attempt on her own life. Rather than allowing disagreements and bruised feelings to be settled privately, she engaged in a months-long crusade to systematically dismantle Radia's entire support structure, despite knowing the extent to which Radia depended on it and the grievous harm it would cause her.

This all took place during the run-up to the first anniversary of the death of Radia's brother, a traumatic event that Radia personally attests that Adora helped her through by effectively inserting herself as a surrogate sibling, something she has publicly proclaimed numerous times. It is impossible that Adora did not understand the damage she would do to Radia's mental health by doing this, especially at this time.

Radia had not compiled any sort of document whatsoever at this point, nor had she attempted to express any kind of "ire" or hostile action. She consistently stated she merely wanted to be left alone. This document only began to be pulled together following the suicide attempt, as the situation could not be allowed to go on any longer.

It took nearly losing her life, and the near-inconsolable grief of those close to her at nearly losing her, to finally get Radia to be willing to voice what had happened publicly. So great was her fear of being unkind or judged as guilty, so all-consuming were her fears of further retaliation, that even now she has required the assistance of several close friends to be able to put the words to print.

Everything possible has been done to confirm and corroborate what has been written here; double checking DMs, reaching out to confirm eyewitness accounts, comparing documents. If

Radia is lying, she has done so with a totality and flawlessness that defies credibility and has successfully duped a vast variety of people. If Adora has any exonerating evidence to the contrary, she has refused and/or failed to produce it, even when approached by neutral third parties who merely wanted to hear her side of the story.

Adora's behavior throughout this ordeal has been on the borderline of narcissism. She has done everything in her power to isolate Radia from her friends and family, to force methods of control over her, her stream schedule, her finances, who she could and could not talk to, and at all times she would impose a constant stream of belittling, mockery, humiliation and abuse, dressed up as emotional concern. All this in order to keep Radia in a position where she would constantly have to doubt herself, and be forced to apologize again and again, offering herself as tribute in the desperate need to please Adora.

These are the classic signs of an abusive relationship. And it comes at a time where Radia would have been in an emotionally vulnerable position, something Adora was fully aware of.

While some of this may seem cutthroat and mean, it should be emphasised that Adora is not the victim here. While she has persistently played the victim to her audience, and may continue to do so in the future, nothing has actually happened to her; she has not faced consequences of any kind. Though with the release of this document she may now do so.

Adora's life, social status, reputation within the VTubing community, and her career as a content creator have been entirely unaffected and unchallenged. Her hiatus was due to unrelated issues that, to respect her privacy, we shall not dive into any further.

While "cancel documents" may seem petty and dramatic, with some who were aware of this situation protesting strongly for the "moral high ground – walk away" option, we will remind you again this document is the final straw in a long series of negotiations where Adora was given every opportunity, subtle and obvious, to back out. She has been offered every courtesy that Radia has not, she has been talked to, she has been allowed to state her side of the story, she has been allowed to structure a narrative to her audience to protect herself where Radia has remained silent. While the "just walk away" approach may seem the morally correct thing to do, as it is common mindset within the human condition to appeal to the abuser, had we the ability to resolve this without the public spotlight we would have taken it.

Each time Adora would reject what was offered and double down, with the end result being additional punishment aimed at Radia making this considerably worse for her.

Radia cannot turn the other cheek and walk away; Adora pursues her, enacting more punishments for each slight, and it makes things worse.

And given where it has taken Radia, the definition of "worse" could be interpreted as "Final".

We'll also remind you Radia is not the only person Adora has done this to, though we have focused entirely on the situation around Radia. Had we also included the ordeal of just the few victims we are aware of, we could have easily tripled the length of this document.

There is an account from another victim of Adora's that cannot be made public in this document due to the victim not wanting to be identified. It features disgusting levels of cruelty, financial exploitation, horrific violations of highly personal information, and emotional manipulation. What has been done to Radia is not a one-off, it is a pattern.

An overarching, horrifying theme that became apparent while collating the info for this document is that people in the space are genuinely *afraid* of Adora, and actively avoid either telling her private info (as it will immediately be made public or divulged to others) or upsetting her, as she does not forget grudges and will go to rather insane lengths to persecute those that she feels have wronged her. She is incapable of admitting fault except in cases where it would benefit her, and even when she does it is done in a way that excuses her actions as much as possible and shifts the blame elsewhere. Furthermore, her behavior seems to worsen the greater the power disparity between her and the opposing party. It is likely no accident that she targeted Radia, who she knew to be emotionally fragile and unable to speak up for herself.

Radia has been left mentally scarred; she will take time to recover and may never recover fully. Though she has become extremely good at masking her emotions to her audience, to her friends who have spoken to her 'mask off' every day it is more than obvious the effect this has had.

Radia will need time and support to be able to recover, and all actions taken after the release of this document will be focused on providing that, not whatever actions Adora may take to discredit her or what has been stated here.

This document has not been written in the hopes of destroying Adora's content career, nor is it being written because she should be harassed; both are wrong, and nobody involved in the writing of this document endorses or is calling for such actions. It has been written because all ideas to halt her spreading of lies and correct the record have been exhausted. Radia only wishes to no longer live in constant fear of yet another unexplained ending of contact, another cold shoulder from those she thought she was friendly with, and a constant sense of fear and paranoia as to what information was being spread behind her back.

Please, Adora. Please just go away.

# **Ending Statement from Radia**

This is not the sole time I have been treated poorly by Adora, in fact, our entire relationship is littered with her abuse of me...for years. Degrading me, framing me in a negative light to those near her, as she had near infinite time to spend around them, while I, a readily employed individual with a *very* busy life, could not be online or around as often. When I state I am incredibly busy...it is not an understatement. I am someone who on top of content maintains a professional, full time corporate job, volunteers within my community and work space (I mentor a young soon to be graduate each quarter to give them insight into the engineering space), manage a household, and up until relatively recently was serving as a guardian and fiscal support system for a young chronically ill adult going to university.

With my obligations limiting exposure to me, Adora was skillfully able to amplify any minor situations, questions, or small issues for years, painting them to encapsulate all of my personality to various parties. She gaslit me continually, manipulated my own family to unknowingly continue her abuse by proxy, and contributed to a state of severe exhaustion and stress within one of my few social spaces that is not directly work or volunteer work related.

Quite frankly, the realities of my personal and professional life are of zero concern to Adora. I keep my details that are public under my real name incredibly scant and even more limited when speaking in the social media space for the exact reasons we see here. Adora has a historic issue with freely sharing personal information of others with non-involved parties, early on in my friendship I noticed that behavior and was even warned she had a very "loose set of lips." This flippant disregard for personally identifiable information is not only willfully negligent but also callous in nature. Doxxing me is not a matter to "lol" about, Adora.

You provided my personal identifying information **without my explicit consent** to try and prove your own deep neuroses created through your historical actions of being an untrustworthy confidant, which has only been reinforced to me by various outside parties in the VTuber space; this air of caution extended to any of your close company by sheer proxy. The actions you engaged in were reckless in nature, with disregard to any risk, and you were fully hoping that revealing my personal identifying information would be used to harm me.

You threatened my safety, you harassed and intimidated me, and through your own willfully reckless actions, you made me the target of undue attention and further abuse. Bully is too light a word; you are a coward, one of the highest order, a duplicitous snake who takes pleasure in undermining others for your own personal gain.

The only kindness you will find from me is my belief in redemption, but for you to achieve redemption in any capacity, there must be condemnation for your actions. Far too long have many suffered in silence out of sheer fear that you would further destroy their lives, their professional careers, and their dignity. We would like to be free to live without fear... I would like

to live without fear. Your promises mean nothing; you eliminated anyone who previously served as a force to perform checks and balances on your behavior. I highly doubt your next enforcer will last long either before you cut the rope. That being said, I fully believe in providing people with chances to improve, but I have exhausted every option beyond full unbearable silence to continue the long line of content corpses that hold your sins... silence is not acceptable. There is no "burying the hatchet"; you ensured that with your own actions long, long ago.

I sincerely wish that you can ruminate on your behaviors, halt your continual crusade in painting your friends as morally corrupted targets to be taken down, and become a better version of yourself.

I hope that amidst all of this that you have friends who will support you and help oversee the regulation of your more malicious behaviors. I do not wish for you to be alone as you selfishly wished for me; I do not wish for you to lose your community, your livelihood, or your dignity. My genuine hope is you take a look at the mirror and recognize what stands there.

May you treat those that remain with kindness; I certainly will not be amongst them. Not now, not ever again. Goodbye, Adora; may this be our last encounter.

### **Accusation Document**

#### Main Issue 1:

- Saturday Night Stream
  - o Lying or massively overemphasizing a health issue to make money
  - o Keeping it a secret from us and purposefully hiding it from us
  - Complaining about financial situation the next(same) day and complained about hotel and not being able to afford it
  - o Stated that hotel suite upgrade would be only \$50 for an entire stay
  - o Never mentioned Chinese food to us despite mentioning it in chat
  - Had a hugely successful stream night predicated on a lie and didn't bring it up to us on any capacity and instead only complained about money for a hotel the day after

Reasons why we think food poisoning is not true:

- We know for a fact that she woke up in the morning 10 hours later leaving the hotel room
  - Ate breakfast in the car casually (Tim Hortons breakfast sandwich and donut holes) and ate food with gluten in it
  - o Arrived at aquarium with no known issues to then swim in bioactive water with stingrays while immunocompromised
  - o Ate frozen yogurt shortly after, something high in lactose
  - o Ate a creamy alfredo pasta with seafood shortly after
  - Only information ever given was during Montana's that she "might" be bad for her to eat a blue rare steak and not feeling well

Conclusion: If you are willing to lie about your health, we don't know how we can trust you and we don't want to send our communities to you. Because this is the sort of thing that if it got out, would look incredibly poorly on you.

Stop just because your mental health is bad doesn't mean you can deceive people in this way and that you should take a break and if you do not do so, we are going to have to consider tearing apart the group and if you don't have the ability to process this. We also need proof and information that shows us she is not lying on certain aspects.

#### Main Issue 2:

- General lack of gratitude
  - o Lack of gratitude to her community for the amount of money they give to her
  - o Having that lack of gratitude seep out to community members including out to members in DMs and as well on stream while we are present
  - Complaining to Adora with a lack of gratitude to Gobtsun despite being a dedicated clipper who has given countless videos and promotion to her for free of charge and helped grow her channel, but stating it wasn't enough
  - o Crashing out over a chatter stating they're giving money to Alicia instead of her, despite the fact Alicia has done so much for her for nothing in return to Alicia than friendship.

- Adora never brought this up, but having had Kono bring up to me in private you complaining about lack of gratitude towards Adora over not helping you enough.
- understand medical issues are expensive and are worried for the future. But that does not give you the right to treat the money that people give you out of their hearts as inadequate then complain about it. The economy is in an incredibly tough time right now, if that behavior got out on a more broad scale, people will not want to give you money anymore, because why would they?
- Lack of Gratitude/money hoarding at expense of friends
  - People coming on her stream and helping her out or doing things for her and her not recognizing that. Thinking only of herself for only making money for herself and not anyone else she's around.
- Lack of Gratitude towards over everything related to Anime North
  - Because of she was able to attend Anime North for free minus the cost of her plane ticket
  - Stoneforged case and future potential affiliate status
  - o Booth with her face on it and fantastic promotion
  - o Only ever complained to out not coming to the Offkai room and stating she was left out
  - Behaving weird in response to during and after her charity stream.
     i.e. silent treatments, never speaking about it or making any statements on it, ignoring as she talked about it
  - o Complaining about the standee frequently despite having thrown it together in the last second
  - Talking about all the things she wants us to do next year even though you contributed functionally nothing to the booth
- Complained during convention about not being able to spend any money on merchandise/artist alley/vendor hall, then proceeded to spend money regardless
- Had funds to at any point book a hotel room but instead tried to pressure to
  offer her hotel room, which being shared between due to lower income
  made.
