**Via Text Message:** This method of entry will be available for the entire Contest Period. Send a text message to 1-561-735-5403 or WhatsApp 1-561-567-5053 subject CONTEST. In response to this text message, a reply will be sent to you for confirmation of entry and instructions. Follow the directions provided in the reply to confirm your entry.
