

**ACCEPTABLE USE OF TECHNOLOGY AGREEMENT,
COPPA COMPLIANCE FORM
STUDENT / PARENT ACKNOWLEDGMENT**

STUDENTS:

I have read and will abide by the iPad Acceptable Use Agreement of the Bend-La Pine Schools. I further understand that should I commit any violation my access privileges may be revoked and school disciplinary action and/or appropriate legal actions may be taken.

PARENTS/GUARDIANS:

I have read and agree to assist my child in understanding and abiding by the iPad Acceptable Use Agreement of the Bend-La Pine Schools. In order to continue providing your student with the most effective web-based tools and applications for learning, Bend-La Pine Schools needs to abide by the *Children's Online Privacy Protection Act (COPPA)*. Our district utilizes several computer software applications and web-based services, operated not by this school, but by third parties. These web-based services include Oregon K-12 Apps for Education and similar educational programs. In order for our students to use these programs and services, certain personally identifiable information, generally the student's name and email address, must be provided to the web site operator. Under this federal law, these web sites must provide parental notification, and obtain parental consent before collecting personal information from children under the age of 13. I understand that access to district technology equipment and its entire system of electronic communication is designed for educational purposes and I give permission for my child to use Oregon K-12 Apps for Education and to the operators of any additional online educational programs and services which our schools may add during the upcoming academic year. I also recognize some materials on the Internet may be controversial and objectionable and that, while every attempt will be made to block inappropriate sites, it is impossible for the Bend-La Pine Schools to restrict access to all controversial and objectionable materials. I will not hold the Bend-La Pine Schools responsible for the accuracy or quality of any materials acquired or viewed on its system by my child. I understand that improper or inappropriate use of technology equipment and the district system by my child may result in revocation of his/her technology privileges and the imposition of school discipline and appropriate legal actions. I accept all financial and legal liabilities that may result from my child's use of the Bend-La Pine Schools equipment and technology system. I release the Bend-La Pine Schools, its officers, employees, agents, representatives, and all organizations and individuals related to the Bend-La Pine Schools' technology system from any and all liability or damages that may result from my child's use of the district's equipment and electronic communication system. I specifically agree to indemnify and hold the Bend-La Pine Schools, its officers, employees, agents, and representatives harmless for any actions, claims, costs, damages, or losses, including, but not limited to, attorney's fees incurred by the Bend-La Pine Schools relating to or arising out of my child's use of such equipment and system.

IPAD USE:

The iPad and its content remain the property of the Bend-La Pine Schools. The district's iPad Acceptable Use Agreement fully applies to the use of this equipment both on and off school premises. iPad settings have been adjusted for appropriate school use. These settings must not be altered, deleted or circumvented in any way. The district has provided digital content and resources for student use that must remain installed on the iPad and be easily accessible at all times. The student and parent/guardian agree to be responsible for the maintenance and care of the iPad and to return it when requested in the same condition in which it was received, except for normal and reasonable wear and tear. iPads may be inspected periodically to check for appropriate use and condition.

STUDENT PLEDGE FOR IPAD USE

- ☐ I will take good care of my iPad.
- ☐ I will never leave the iPad unattended.
- ☐ I will never loan out my iPad or charging brick and cord.
- ☐ I will know where my iPad is at all times.
- ☐ I will charge my iPad's battery daily.
- ☐ I will keep food and beverages away from my iPad.
- ☐ I will not disassemble any part of my iPad or attempt any repairs.
- ☐ I will protect my iPad by keeping it in a case at all times.
- ☐ I will use my iPad in ways that meet Bend-La Pine Schools expectations.
- ☐ I will not deface the serial number or iPad asset tag. Leave visible.
- ☐ I understand data loss does occur; therefore, I will keep my iPad backed up.
- ☐ I understand my iPad is the property of Bend-La Pine Schools.
- ☐ I will immediately notify school staff in cases of damage, theft or vandalism.
- ☐ I will be responsible for all damage or loss caused by neglect or abuse.
- ☐ I will return the iPad and original brick and cord.
- ☐ I agree to follow Policy EHA-AP Appropriate Uses of Technology, Equipment, Infrastructure, and services.
