

Event Risk Assessment: Ella Street Festival 2026

Overview

The following document comprises the preliminary risk assessment for the Ella Street Festival 2026. The event is currently in the initial stages of planning and hence this document should not be considered complete or definitive. As and when events are planned, owners will be assigned, the risks reviewed and updated in this document. For those already planned, the risk assessments will be reviewed and updated at least one month in advance of the festival.

Risk Matrix

The risk factors are calculated using the below risk matrix.

Risk Definitions

To ensure everyone on the Ella Street Planning Committee uses the same standards, these definitions have been made:

Severity (Impact)

- **Low:** Minor issues requiring basic on-site first aid (e.g., small cuts, light trips).
- **Medium:** Injuries requiring professional medical attention or potential property damage (e.g., deep cuts, burns, or electrical issues).
- **High:** Serious injuries requiring hospital admission or major safety breaches (e.g., vehicle collisions or fire-related emergencies).

Likelihood (Probability)

- **Low:** Very unlikely to happen; requires a rare combination of circumstances.
- **Medium:** Could happen at some point during the festival day.
- **High:** Highly likely to occur if no control measures are in place.

Required Actions based on Result

Event Risk Assessment Ella Street Festival 2026

- **Low Risk:** Acceptable. Continue with the planned control measures and monitoring by volunteers.
- **Medium Risk:** Action required. Organisers must ensure specific control measures (like cordons or briefings) are strictly followed.
- **High Risk:** Immediate attention. The Planning Committee should review the activity. Additional professional oversight or physical barriers may be needed.
- **Critical Risk:** Unacceptable. The activity must be redesigned or cancelled until the risk can be lowered to at least Medium.
