WARNING: BY SIGNING THIS FORM, YOU GIVE UP IMPORTANT LEGAL RIGHTS, INCLUDING THE
RIGHT TO SUE

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I hereby irrevocably grant to HMPTN Water LLC ("Hampton Water"), its respective subsidiaries, affiliates, successors and assigns, and to other such persons as Hampton Water may designate from time to time, the absolute and unrestricted right (but not the obligation) in perpetuity to reproduce, publish, display, distribute and/or otherwise use and reuse my name, title, biography, voice, signature, endorsement, likeness, personality, biographical information, interviews, testimonials, performance (collectively, "Likeness") and/or any material, including video, film, photographs, or other recordings supplied by, taken of, or about me (with the right to "dub" the voice of another in place of mine) in any and all media now or hereinafter known, and/or in any manner, alone or accompanied by other material, throughout the world for the purpose of advertising, marketing, memorializing and promoting Hampton Water and Hampton Water's products and services or for such other purposes as Hampton Water shall reasonably designate.

I hereby waive any rights to inspect and approve the finished materials or their use. Nothing herein will constitute any obligation on Hampton Water's part to make any use of any of the rights set forth herein. I agree that all right, title and interest in and to the finished product and/or services, including the copyrights therein, shall vest exclusively in Hampton Water. I hereby release and discharge Hampton Water from any liability by virtue of any blurring, distortion, alteration, optical illusion, or use in composite form, whether intentional or otherwise, that may exist in any media or in any publications thereof. I represent that I have legal capacity and authority to act for and on behalf of myself, and I agree to indemnify and hold harmless Hampton Water and its subsidiaries, affiliates, successors and assigns from and against any claims or liabilities assessed against them as a result of any insufficiency of my legal capacity or authority to act for and on behalf of myself in the execution of this Agreement.

I agree that all rights, title, and interests to the rights granted herein and the results and proceeds hereof, including all copyrights and other intellectual property rights therein, belong solely and exclusively to Hampton Water for all purposes throughout the universe in perpetuity. If any provision of this Release or law or ruling does not fully vest in Hampton Water any of the rights set forth in this Release, I hereby irrevocably and in perpetuity grant and assign to Hampton Water all rights, title, and interests not so vested. To the fullest extent allowable under any applicable law, I hereby irrevocably waive or assign to Hampton Water any so-called "moral rights" or "droit moral" in connection with Hampton Water's use of the rights granted hereunder. I agree that Hampton Water has the right to adapt, change, delete from, and add to the Likeness, and/or use all or any part thereof in new versions, adaptations, and other programs and audio-visual works without approval by, advance review, notice to, or compensation to me.

I represent and warrant that I have the full right and power to execute this release ("Release") and I agree further that I will not hold Hampton Water or anyone who receives permission from them, responsible for any claim or liability resulting from (i) the rights granted hereunder in accordance with the terms hereof, including, but not limited to, claims in the nature of copyright infringement, defamation, disparagement, slander, false light, invasion of privacy or right of publicity or the like; and (ii) any damage to the personal property of, or personal injury to, myself resulting from my participation in the Event and all related activities and any and all claims, demands, actions, losses and costs which might arise out of my participating in the Event, even though such claims, demands, actions, losses and costs may have been caused by the action(s), inaction, or negligence of myself or others.

I further represent that I have neither assigned nor otherwise entered into an agreement by which I purport to assign or transfer any right, title, or interest that would conflict with my grant of rights under this Agreement.

I acknowledge and agree that the organizers, sponsors, and volunteers of the event entitled Hampton Water Rosé Tour Austin, taking place on or about April 26th, 2025 (the "Event"). are not responsible for any injury, loss or damage of any kind sustained by me or any other person while participating in the Event, including injury, loss or damage which might be caused by the action, inaction, or negligence of others. I hereby, for myself, my heirs,

executors, administrators or anyone else who might claim in my behalf, covenant not to sue, and waive, release and discharge the Event organizers, Hampton Water, sponsors, and volunteers of any and all claims of liability for death, personal injury or property damage of any kind or nature whatsoever arising out of, or in the course of my participation in the Event. This Release extends to all claims of every kind or nature whatsoever, foreseen or unforeseen, known or unknown. I acknowledge that I am aware of the possible risks, dangers and hazards associated with my participation in the Event (including the risk of severe or fatal injury to myself or others), including risks associated with travel to and from Event locations(s). I agree TO ASSUME AND ACCEPT ALL RISKS arising out of, associated with or related to my participating in the Event, even though such risks may have been caused by the action(s), inaction, or negligence of others; TO BE SOLELY RESPONSIBLE FOR ANY INJURY, SOCIAL AND ECONOMIC LOSS, COST, OR DAMAGE which I might sustain while participating in the Event even though such injury, loss, or damage may have been caused by the action(s), inaction, or negligence of others.

I hereby bind myself to the terms and conditions of this Release. This Release contains the entire understanding between the parties regarding the subject matter hereof and supersedes all prior understandings. No waiver, modification or additions to this agreement shall be valid unless in writing and signed by both parties hereto. I agree that the terms of this Release are confidential and shall not be disclosed to any third party. This Release expresses the entire agreement between myself on the one hand and Hampton Water on the other hand and shall replace and supersede all prior arrangements and representations, either oral or written, as to the subject matter hereof. I acknowledge and confirm that no representation or promise not expressly contained in this Release has been made by Hampton Water or any person associated with Hampton Water and that in entering into this Release, I have not relied upon or have been induced by any promise or representation (express or implied, oral, or written) not contained herein. I agree to sign additional documentation as Hampton Water may reasonably require in order to effectuate the purposes and intent of this Release. Hampton Water may freely assign this Release to any third party. This Release shall be deemed to have been negotiated and entered into, and shall be construed in accordance with the laws of the State of New York. This Release may be amended or modified only by signed the written agreement of me and Hampton Water.

I represent that I am at least twenty-one (21) years of age or older and have the right to enter into this agreement and grant the rights set forth above.

I am submitting this Release voluntarily and of my own free will. I have no impairment, nor any history thereof, which will hinder my ability to participate in the Event in a safe manner.
