

**Statement by Lanre Rotimi, ISPE / EAG,
Intergovernmental Negotiations on the Post 2015 Development Agenda
Meeting with Major Groups and other Stakeholders 24, June 2015**

“Means of Implementation, MOI”

I am making this Statement on behalf of ISPE / EAG.

If we are to collectively achieve increasing convergence between Final Push to achieve MDG by 2015 and Post 2015 Development Agenda Vision Intention and Reality, through delivery on the commitment to “leave no one behind” and pass acid test of credibility of the SDG, there is urgent need to ensure that Post 2015 Zero Draft and FfD Zero Draft each address fundamental issues of “Research, Planning, Data, Implementation, Monitoring, Evaluation, Learning, Participation and Results as One” from “Village to Global” levels in each of the 193 Member States.

To achieve this, there is a need to ensure that relevant provisions in Post 2015 Zero Draft and FfD Zero Draft are Aligned and Harmonized and each Zero Draft has its own Means of Implementation, MOI. It is not helpful that discussion on Post 2015 Zero Draft MOI is being left until decision has been taken on FfD Zero Draft. It is erroneous to assume that Implementation of Post 2015 Zero Draft is embedded in FfD.

To achieve success on sustainable basis and deliver on the “people centered nature” of the SDG there is urgent need to recognize that Post 2015 Zero Draft and FfD Zero Draft must each have its own MOI that effectively address **how** governments will **constructively engage** with all relevant **stakeholders** at subnational, national and international levels in the implementation of the Action Agenda in each of the 17 / 21 SDG, as well as the Follow Up and Review / Monitoring and Evaluation of this Implementation; that each Zero Draft must have the same “Our Common Commitment and Shared Principles” with 3 paragraphs - the 2 paragraphs in this section of Post 2015 Zero Draft and the Opening paragraph in FfD Zero Draft 21 June starting from “We affirm our strong and political commitments to address the challenges of creating an enabling environment for sustainable development

Additionally, all ideas and recommendations in Synthesis Report and Data Revolution Report need to be **implemented** as appropriate in each of the 17 / 21 SDG Action Agenda in ways that ensure **all How questions** in Synthesis Report, Data Revolution Report, Post 2015 Zero Draft and FfD Zero Draft are **effectively and efficiently answered** in each Community, in each Local Government, each National Government and at each International level in each of the 193 UN Member States.

Finally, regarding the deployment of key principles of “One Worldwide Approach” suggested in Synthesis Report to “Action Agenda, MOI and Follow Up and Review as One” in each of the two Zero Drafts, there is urgent need to ensure that a “One Worldwide Approach” with “Local

Context" is **selected without delay** and that selection is based on the most advance "One Worldwide Approach" with **clear** "Principles, Instruments corresponding to each Principle, Practices and Database" that ensures critical principles of "Transparency, Accountability and Participation, TAP; Evaluation, Learning and Results, ELR and Means of Implementation, MOI as One" cannot and will not be left behind in the work towards achieving increasing convergence between Final Push to achieve MDG by 2015 and Post 2015 Development Agenda Vision Intention and Reality.

Please find statement from a UNECE Senior Official "The UN is a member driven organization. The member states decide what is corruption, how to fight it and how the UN can help. Im here to comply with these rules as my view is one of 7 billions. The is no UN dictatorship no UN marines who will persecute you. The UN security council is the only body who can. So UN lives and strives to consensus by the member states. If you want to change our work your and other governments can help us. No other way, that's the transparent rules the member states, including yourself, have dictated us".

It is clear that without achieving Corruption Free Society in any of the 193 Member States, seeking to achieve SDG Vision Ambition in that Country will be a mirage; that SDG affect all Countries - Developed and Developing and not just Poor Developing Countries alone; that all Members of the UN Family including World Bank Group and IMF need to ensure that Lessons Learnt from 15 years of implementing MDG is actually Learnt in the Design and Delivery of SDG (for example, had many of the recommendations in MDG Gap Reports particularly 2013 and 2014 MDG Gap Reports been fully implemented with effective monitoring and evaluation of this implementation, many of the issues causing division in the FfD Process will have been resolved), hence the need for Member States and UN Family Organizations to seriously consider points made in this Statement against the background of the informed opinion expressed by this UNECE Senior Official.
